Risky job without safety measures

Workers at different dockyards in Nesarabad upazila work risking their lives

Thousands of workers at different dockyards in Nesarabad upazila work without any safety measures and equipment, risking their lives.

As a result, accidents often occur there, some of them fatal. Recently, two people were electrocuted at two separate dockyards there.

On a visit to several dockyards, this correspondent saw electric wires spread all around the dockyard while uncovered electric wires were found tied to a pillar.

Although gloves, helmets, protection boots, safety belts and other equipment are necessary for working in dockyards where the workers have to work with electricity, gas, iron bars as well as iron cutters, not a single worker at any dockyard in Nesarabad has any

"We are working in the dockyard without any safety measures as nobody has given us the equipments," said Akram Hossain, a worker at Salehia Dockyard in the upazila.

They do not wear helmets even when they work on a ship, he added.

"To work amidst scorching heat, we need to wear protection boots to protect us from the heat of the iron," said Akram Hossain, another worker there.

"We asked the contractor to arrange safety equipments for us, but he did not pay any heed," said worker Goutom.

"We work here amidst unsafe environment as we have to depend on the earning from the dockyard," he adds.

Md Abul Kalam, an employee of Salehia Dockyard in the upazila, said they urged the contractor to arrange safety equipments for the workers, but nothing has changed.

"We only lease the dockyard land to the contractors, who make new water vessels or repair old ones," he said, adding that the contractors are responsible for the other works connected to repair

This correspondent tried to talk with several contractors, but they declined to make any comment over the issue.

Upazila Nirbahi Officer Abu Sayeed said he is unaware of the unsafe environment in the dockyards.

The other commuters, including farmers and patients, are facing the same ordeal, said villagers of both the unions, adding that the situation has been prevailing as the authorities concerned have never come forward to solve the problem. A large number of farmers carrying

agro-products face troubles every time they cross the river by boat to reach Aramnagar and Shimla bazars in Sarishabari upazila town, said farmers Sohrab Fakir, Sairuddin Miah and Shahid Mondal of Ghoramara village.

Sarishabari upazila Local Government Engineering Department (LGED) Engineer Shafiullah Khandaker said a proposal for construction of a concrete bridge over the river was sent to the higher authorities concerned about two years ago.

"I do not know when the construction work will start as design of the bridge and the cost assessment are yet quarters," he added

Elderly woman murdered

Son-in-law goes into hiding after the incident

A 70-year-old woman was brutally murdered allegedly by her son-in-law at Mirzapur village in Madarganj upazila following a family feud on Sunday.

Deceased Bhanu Bewa, wife of late Abdur Razzak of Itail village in Sadar upazila, used to live with her son-in-law Rafiqul Bepari Dipu, 45, husband of her younger daughter Hasna Begum, in Dhaka.

Informed by locals, police recovered the victim's beheaded body from an eucalyptus orchard and the head from beside a canal adjacent to the orchard on Monday night, said Asaduzzaman, sub-inspector of Madarganj Police Station.

Bhanu left Dhaka on August 18 to the SI quoted Hasna as saying.

Committee at her office's conference room yesterday where a 20-point decision was taken to ensure road safety. The decisions also include checking unsafe

overtaking and overloading of buses, removing illegal roadside markets, repairing damaged roads, widening highways, and introducing a hassle-free system to get driving licence and vehicle documents. Earlier on Monday night, three mobile courts sealed

an illegal auto-rickshaw factory in Bhabaniganj area and jailed its manager Ranju Sarker for one month. The courts also collected Tk 10,700 in fine from 11 autorickshaw drivers and jailed

protested against the drive and demanded release of the arrestees, but the mobile courts did not listen to him. Talking to The Daily Star

yesterday, the MP however said he is in favour of the drives against unauthorised vehicles.

"My problem is that it's being conducted only in Natore. Unauthorised vehicles are running freely everywhere else. Over the years, the number of such vehicle has reached so high that a sudden ban would cause huge unemployment and the affected people will

blame me," he observed. Lawmaker Fazle Hossain Badsha of Rajshahi said removing all the threewheelers would create an impact on local economy.

Good sugarcane yield delights farmers

Sugarcane growers in the district are all smiles as they got good yield of the crop due to favourable weather and absence of attacks by pests and diseases.

The prices are little higher in the beginning of the season but the sellers and the buyers are happy over the good supply.

Though sugarcane cultivation demands hard labour, local farmers became interested in cultivating it due to higher profit than other crops, including jute.

Sugarcane was cultivated on 559 hectares of land at nine upazilas out of 12 upazilas in the district this year, said district Sub-Assistant Agriculture Officer of the Department of Agriculture Extension (DAE) Shariful Islam. Of those, 260 hectares are in Sadar upazila, 100 hectares in Nagarpur, 60 hectares in Bhuapur, 32 hectares in Mirzapur, 20 hectares in Ghatail, 18 hectares in Kalihati, 16 hectares in Madhupur, 14 hectares in Gopalpur, 38 hectares in Delduar, and one hectare in Basail upazilas, he said.

tion was 33,574 tonnes, he added. Rakibul Islam, a sugarcane farmer of Dharerbari village under Baghil union in Sadar upazila, said he has cultivated sugar-

cane on one bigha of land. "I have spent Tk 25,000 for cultivation, including Tk 3,000 for buying saplings, Tk 1,000 for ploughing, Tk 5,000 for labour

cost, and Tk 3,000 for fertilisers," he said. "I hope I can sell my sugarcane for at

least Tk 50,000," he said. Farmer Shayan Miah of the same village said he cultivated sugarcane on 1.5 bighas

of land and also got good yield. Sugarcane was cultivated on around 100 hectares of land at Pitchuria, Krishnapur, Tablapara and Dharerbari villages and the yield was good as pests or diseases did not attack the fields this year, said farmer Rokon

Hossain. DAE District Deputy Director Md Abdur Razzak said bumper sugarcane was produced in the district this year and the farmers are getting good prices for their produce.

people capsizes Three passengers missing in Jamuna

At least three people, including a minor girl, went missing when a trawler carrying 100 passengers capsized after it collided with a cement-laden cargo vessel in the Jamuna river yesterday.

The missing people are Noor Box, 50, of Ataikula upazila

and eight-year-old Mehgla and Mohammad Masum of Sujanagar upazila of Pabna. The trawler left Aminpur area of Pabna's Sujanagar

upazila for Aricha in Manikganj in the morning. The engine-boat capsized in the river after it hit a cargo vessel near Alokdia Char. All the passengers, except the three, managed to swim ashore, Officer-in-Charge of Shivalaya Police Station Habib Ullah said,

adding that at least 15 people were injured in the accident. Mizanur Rahman, deputy assistant director at Manikganj Fire Station, said divers continued rescue operation till filing of this report.
