A man, accused in a murder case, came under gun attack by criminals in Masumbazar area of the town yesterday.

Injured Jamal Sheikh, 45, of Masumbazar village is accused in Jubo League leader Molla Masud murder case, said Officer-in-Charge of Pabna Sadar Police Station Md Obaidul Haque.

He is now undergoing treatment at Pabna Medical College Hospital, said the

Jamal's brother Ratan Sheikh said his mother died due to old age complication on Tuesday and she was buried yesterday morning.

When Jamal was returning home after burying her, a group of criminals opened fire and hacked him in the area around 11:30am, said Ratan.

The fellows of late Masud might have attacked Jamal over previous enmity, the OC said, adding that they are trying to arrest the attackers.

# Woman beaten by son-in-law

He also assaulted her two daughters over land dispute

A woman and her two daughters were injured when they were beaten, allegedly by her son-in-law, over land dispute in Gabhishimul village under Gouripur upazila.

The victims are Amena Khatun, 60, and her daughters Lolita Begum, 30, and Poly Akter, 17. Poly is a Higher Secondary Certificate (HSC) student at Gouripur Mohila Degree College.

Quoting the victims and locals, Gouripur Police Station Officer-in-Charge Ripon Chandra Sarker said Lolita was married off with her cousin Nuru Badsha seven years ago and the couple has a four-year old girl child.

There had been a longstanding dispute over a piece of land between the two families and Nuru had been demanding the land from his in-laws, which created a feud between the couple. Lolita was also physically assaulted on various occasions

and she had been staying at her parents' house for the last one year, the OC said. Nuru and his brothers went to the disputed land on

Tuesday noon. Amena and her daughters went to the spot and both the groups locked in an altercation. At one stage, Nuru and his men punched and beat up Amena and her daughters with sticks, injuring them, the OC said. Hearing the screams, local people rushed to the spot and

took the victims to Gouripur Upazila Health Complex, where they are undergoing treatment, said the official.

## Marriage after paying dowry

Disagreement over marriage of college girl solved at police station

The marriage between a college girl and her boyfriend was mediated by police in an arbitration on Monday in Chirirbandar where the girl's parents agreed to pay dowry. The marriage ceremony was held at

a local temple after the arbitration in Chirirbandar Police Station.

Police said banker official Joyanto Kumar Roy, son of late Pulin Chandra Roy of Surail Sahapara village in Chirirbandar upazila, had been in a relationship with a college girl, a master's student at Dinajpur Government College, for nearly eight years.

Recently, Joyanto's parents secretly fixed his marriage with another girl, daughter of Monoranjan Roy of Parbatipur upazila, on condition of giving Tk 15 lakh and gold ornament as dowry.

His family also took Tk 10 lakh and a gold chain in advance during their engagement on August 10.

After hearing about the engagement, the college girl lodged a written complaint with Chirirbandar Police Station on August 25.

Two days later, police picked up Joyanto from his rented house in Officer-in-Charge Haresul Islam of the police station said, adding that they also called both the families there. Monoranjan, who was unaware of

Joyanto's previous affair, suddenly appeared at the police station and refused to marry off his daughter with Joyanto. He also told Joyanto to return his Tk

10 and sought police help to recover the amount. Later, arbitration was arranged at

the Round House of the police station where Sub-Inspector (SI) Tajul Islam was asked to solve the dispute. During the arbitration the parents

of the college girl were asked to pay Tk 10 lakh which Joyanto took as dowry from Monoranjan and marry off their daughter with Jayanto, police said. After an hour-long bargain, the father of the girl agreed to pay Tk 6.5

lakh as dowry. They paid Tk 40 thousand to Joyanto's family in advance and arranged the couple's marriage at a local temple the same night, Monoranjan said.

birth to a baby daughter. Jalil later got bail in the case during the trial and

went into hiding.

## 45 AL men sent to jail

A court here yesterday sent 45 Awami League (AL) leaders and activists to jail after rejecting their bail prayer in connection with a case for assaulting police in Gurudaspur upazila in 2017.

Senior Judicial Magistrate Mominul Islam passed the order when the charge sheeted accused appear before the court and sought bail.

According to the case statement, two rival factions of AL locked in a clash over attending the upazila law and order meeting on May 11, 2017.

At least 10 people, including four policemen, were injured in the clash.

The following day, Sub-inspector Mohammad Saiduzzaman of Gurudaspur Police Station filed a case naming 67 people, including Gurudaspur Municipality Mayor Shahnewaz Ali Mollah and 200 others unnamed.

Forty five, out of the 65 charge sheeted accused, who secured bail from the High Court earlier, were sent to jail, Court Subinspector Shafiqul Islam said.

# Vessels collide

2,000 passengers escape from capsize

Double-decker launch MV Saharukh-1 with around 2000 passengers on board luckily escaped from possible capsize in the Bishkali river of

Jhalakathi. Mohammad Jasim, a passenger of the launch, said Shaharuk-1 plying from Barguna to Dhaka via Barisal left Barguna launch ghat around 2:30pm full of passengers on

Tuesday. Launch Master Ujir Ali said when the launch was crossing Gabkhan channel through the Bishkhali river around 8:00pm, a cargo-laden vessel hit the launch from opposite side and caused

small crack on the launch. Iqbal Hossain, a passenger, said they requested launch master and other staff not to run launch in such a vulnerable condition, but they did not care.

The six-inch crack was above the three-foot high from the water level, so they decided to continue plying and reached Barisal around 9:30 pm, said Ujir Ali.

After reaching Barisal River Port, the authorities concerned cancelled the trip of MV Saharukh-1 and shifted passengers to another launch, said Ajmol Huda, deputy director of Bangladesh Inland Water Transport Authority (BIWTA).

Abu Helal Siddiki, engineer of BIWTA, said the crack might get wider if the launch plied further. So they cancelled its trip.
