No end to horror

Road crashes claim five more lives

As deaths on the roads continue despite measures taken by the authorities to improve road safety, another five people were killed and three others injured in two separate road accidents in Netrakona and Dinajpur yesterday.

In Netrakona, four people were killed and three others injured when a Kalmakanda-bound bus coming from Dhaka collided head on with a CNGrun auto-rickshaw at Mashka Kathalbari area on Kendua-Atharabari road at around 3:00pm.

Mohammad Fakruzzaman Jewel, additional superintendent of police (ASP) in Netrakona, quoting locals, said the accident occurred when two CNG-run auto-rickshaws, coming from the opposite direction, were over taking one another before one of them collided head on with the bus.

All of the victims were passengers of the CNG-run auto-rickshaw. Four of them died on the spot, while the three injured were taken to Mymensingh Medical College Hospital (MMCH), said Imarat Hossain Gazi, officer-incharge (OC) of Kendua Police Station.

The dead were identified as Md Jamal Uddin, 35, the driver of CNGrun-rickshaw; and passengers Nazir from Kendua, and Murad Hossain, 17,

from Mohanganj upazila of Netrakona.

The injured were Golam Robbani, 22, Jasim Uddin, 40, and Shakir, 20 -all day labourers from Kendua in Netrakona.

"All three of the injured patients were in critical condition. They are being given emergency treatment, and the next course of action will be taken after necessary examinations," said Moniruzzaman Sani, the on-duty doctor at MMCH.

Police and Fire Brigade and Civil Defense personnel, on information, rushed to the spot and recovered the dead bodies, OC Imarat added.

Police also seized the bus. Its driver, however, managed to flee the scene, ASP Jewel said.

Meanwhile a mentally challenged woman was killed in an accident at Hakimpur upazila of Dinajpur, after a speeding truck hit her while she was crossing the port road in front of Hiramoti Cinema Hall, at around 12:00pm yesterday, police said.

The dead was identified as Firoza Begum, 35.

A report unveiled by Bangladesh Jatri Kalyan Samity, a passenger welfare platform, at a press conference on Friday, said that despite measures Uddin, 25, Sharif Hossain, 19, both taken by the authorities to ensure road SEE PAGE 11 COL 6

Body of drug trader recovered in Kushtia

Police recovered the bullet-hit body of a known drug trader from a village in Jibonnagar upazila of Chuadanga bordering India yesterday at noon.

The deceased was identified as Shahin Ali, 43, son of Munnaf Ali of Ashtolapur of the upazila.

Mahmudur Rahman, officer-incharge (OC) of Jibonnagar police station said locals discovered Shahin's dead body in a mango orchard in Benipur village at about 12:00pm.

On information police recovered the body, the OC said. Police sent the body found to be hit by three bullets, to Chuadanga sadar hospital for

According to Rahman, Shahin has been involved in drug trade for over 20 years. He smuggled drugs from India and traded inside Bangladesh territory. He is an accused in at least 10 drug-related cases filed with

Jibonnagar police station. Earlier, Shahin was engaged in several clashes with his rivals in the area, Rahman said citing police records. He expressed suspicion that his murder may have something to do with his rivalry with opponents.

Police is investigating the murder, the OC said.

"treatment" where he would dress his legs with a liquid which he claimed was concocted from herbs.

"Aminul charged me Tk 2,000 to Tk 2,500 every time I visited him. I spent almost Tk 40,000 to Tk 50,000 in total on these treatments," Mohafez told The Daily Star during an interview a few months ago.

When the "treatment" failed to improve his condition, one of Mohafez's brothers finally stepped in. He refused to let him go see the kabiraj again, although Mohafez insisted that the herbs were working.

He took him back to Rangpur Medical. Unfortunately, by then the dead tissues had risen up to his knees and spread to his other leg as well, prompting the hospital to form a committee that eventually decided to amputate both his legs to save his

Hriday Ranjan Roy, an associate professor at the hospital, said, "When I saw him Mohafez [in March], he had developed septicaemia [blood poisoning]. The infection began spreading upwards.'

These days, Mohafez is bedridden.

Stories of patients being given pain injections at upazila and union drug stores during heart attack, ultrasounds carried out by non-medical persons on pregnant women, operations by Kabiraj and death of babies during deliveries, are all rampant.

However, there is no infrastructure in place to prevent such incidents.

Bridge, all the passengers, except the woman, got down.

Around 11:45pm, the driver, Alam Khandaker, 45, stopped the bus in the area and raped the woman inside the vehicle, the OC said, adding that the driver's helper Nazmul, 22, stood guard outside.

A night guard of a local market heard the woman's screams and informed a patrol team from Bangabandhu Bridge East Police Station about the matter. The law enforcers rescued the woman and arrested the helper from near the

The driver, however, managed to flee, Mosharraf said.

On Friday, police admitted the woman to Tangail General Hospital where she underwent medical tests. The reports were not available till last

The same day, Sub-Inspector Nure Alam filed a case under the Women and Children Repression Act with the police station. According to the case statement, Alam raped the woman

while Nazmul abetted him. Nazmul was produced before a Tangail court where he gave a confessional statement. After recording the statement under Section 164 of the Code of Criminal Procedure (CrPC), Senior Judicial Magistrate Md Ashikuzzaman sent him to jail, the OC

said. Police seized the bus and were trying to arrest the driver, he added.

Yesterday, the woman was moved to a government shelter home in Gazipur as per a directive from a Tangail court.

Kabirul Haque, sub-inspector of the police station, said the court came up with the directive after they filed a prayer in this regard.

Quoting accused Nazmul, the SI said the woman was roaming in Tangail Bus Stand area on Thursday night and she got onto the bus being asked by the driver and the helper.

Both the accused are from Bhuapur upazila of Tangail. Talking to this correspondent last night, Kabirul also said they came to

know from Kushtia police that the woman's family lives in the district's Mirpur upazila. The family members were on their way to Gazipur to meet her, he added.

On August 25 last year, Rupa, 27, was raped and killed on a bus heading for Mymensingh by three assistants of the driver. Her body was thrown out of the vehicle in an empty forest area on Tangail-Mymensingh road.

A Tangail court sentenced the trio --Mohammad Shamim, 26, Akram, 35, and Jahangir, 20 -- to death over the incident that caused an outcry. The driver, Habib Miah, 45, was given the same punishment for abetting the three.

In April, 2016, transport workers had raped a female garment worker, aged around 23, on another moving bus on the Tangail-Mymensingh Road

in Madhupur upazila of Tangail.
