# JU law dept: Without a classroom for seven years

The Department of Law and Justice of Jahangirnagar University (JU) has been facing an acute shortage of classrooms, forcing students to frequently cancel their regular classes and learn in cramped conditions.

Although seven years have passed since the department started its journey in 2011, the university authorities could not yet designate a single classroom for the department permanently. The three-storey social science faculty building houses

six departments, the law faculty (with one department), and the Institute of Business Administration (IBA). But it is only the law department that does not have any designated classrooms. From the beginning, the law students had been using

three classrooms -- two green rooms in Zahir Raihan Auditorium, and a classroom (no-340) which belongs to the geography and environment department. Initially, the authorities concerned managed the geography department to lend a room to the law depart-

ment under the law faculty but in July, the former depart-

ment took it back, issuing a notice to the latter. "Moreover, the two green rooms can hardly accommodate 40 students but we have some 60 students in each batch. At present, the department has some 350 students in six batches including master's," said Israt Ara

Begum Atika, a third-year student of the department. "The classrooms are usually overcrowded. It becomes unbearable especially when the power goes

"Being a class representative, I always carry the extra burden to maintain class routine and arrange classrooms accordingly," she added.

"Cancellation or postponement of classes has been very common for us. Besides, it is a hassle to move from the social science building to the auditorium, some six minutes away, to arrange and attend classes every now and then," she said.

"When we were using another department's classroom, sometimes we had to vacate the room in the middle of class or exam as students of that department needed it," said fourth-year student Khan Muntasir Arman.

"The situation was very embarrassing for us. And now we do not have that classroom either," he added.

"Nor do we have a seminar library where we could sit, read, discuss class topics or study. We have to even use other departments' washrooms, which is very awkward and make us feel neglected," he added.

"If classes are not conducted regularly, how would we complete the syllabus in time?" asked Arafat Hossain Romeo, a third-year student.

Palash Roy, from session 2011-12, the first batch of the department, said, "Due to the classroom crisis, we had to cancel many classes which took us six extra months to complete our syllabus. As a result, we faced a session jam."

A teacher of the department, wishing anonymity, said, "Like students, we the teachers are suffering too. We don't have enough space to sit, rest or even take preparations for our next class."

#### RU admission application opens

Rajshahi University authorities yesterday opened online registration for undergraduate admission tests of 2018-2019 academic session.

The application process began at 12:00 noon and will continue till 12:00 midnight of September 12, according to a press release. Admission tests will be

held on October 22-23 under five units. Only students who passed HSC and equivalent examinations in 2017 and 2018 and fulfil minimum requirements are eligible.

Admission seekers can apply via university website and pay a fee through mobile banking service. A maximum of 32,000 applicants will be selected from each unit on the basis of SSC and HSC results. Selected applicants have to complete a final application process to sit for the tests, the results of which will be published by November 15. This year, RU will enrol 4,173 students.

# Summit had no scope of discussion on Rohingyas

Says Bimstec secretary general at press briefing

The Rohingya issue could not be included in the declaration of the 4th Bimstec summit, held on August 30-31 in Kathmandu, as there was no scope for formal discussion on the matter during the summit, Bimstec Secretary General Shahidul Islam said yesterday.

He made the remark at a post-summit press briefing held in the Bimstec Secretariat at Gulshan in the city.

Responding to a query made by The Daily Star, he also said, "There was no proposal or request from any member country to include or not to include the Rohingya issue in the agenda for discussion or adding [it] in the Kathmandu Declaration."

Since the issue was not included in the agenda, there was no scope to discuss it dur-

ing the summit, added the secretary general. Bimstec (Bay of Bengal Initiative for

Multi-Sectoral Technical and Economic Cooperation) member countries are Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka and Thailand.

In another query, The Daily Star asked whether India or Myanmar had requested not to discuss the Rohingya issue at the summit. In response, the secretary general categorically replied in the negative.

Both Bangladesh and Myanmar have shown their prudence by not raising the Rohingya issue as they feel that raising any contentious issue would hinder the progress of the forum, Secretary General Shahidul said, adding, "And we feel that both Bangladesh and Myanmar have shown diplomatic maturity by not raising the Rohingya issue when the organisation is not ready to deal with this sort of issue."

Senior officials of the Bimstec Secretariat were also present at the briefing.

## Court sets Oct 11 for charge framing

A Dhaka court yesterday directed jail authorities to produce BNP Chairperson Khaleda Zia before it on October 11 in

connection with the Niko graft case. Judge Md Mahmudul Kabir of the Special Judge Court-9 of Dhaka passed the order and set October 11 for framing charges in the case against all accused.

The judge directed all the accused, including Khaleda and BNP leader Moudud Ahmed, to appear before the court. The judge passed the order after Khaleda's lawyer

Sanaullah Miah submitted a petition seeking a direction on the jail authorities to produce her before the court. Since her conviction in the Zia Orphanage Trust graft case, the BNP chief has not been produced before any other court in connection with several other cases, although

repeated orders were issued for her to appear. Khaleda, who stands accused in over 34 cases, was jailed on February 8 after she was found guilty in the Zia Orphanage Trust graft case.

On December 9, 2007, the Anti-Corruption Commission filed the Niko graft case with Tejgaon Police Station accusing Khaleda and 10 others of abusing power to award a gas exploration and extraction deal to Canadian company Niko during her tenure as the prime minister.
