Food grain carriers start 72-hr strike in Rajshahi, Rangpur divisions

Some 250 contractors, who transport food grains for 163 government warehouses in 16 districts under Rajshahi and Rangpur divisions, yesterday started a 72-hour strike to protest harassment by food offi-

The contractors alleged that they were forced to call the strike as unloading of over 100 truckloads of food grains were either refused or delayed in the last two months by the food officials on ground of substandard quality.

They only transport the grains, procured

by the government, from one government

warehouse to another, they said, adding that ensuring its quality cannot be their responsibility as the grain is procured by government officials. Shah Alam, general secretary of the Food Grain Transport Contractors' Association in

Rajshahi and Rangpur divisions, said the food officials delayed or refused to unload trucks at 10 government warehouses during the period. "How will we ensure the quality of the food grains? Some officials are procuring the low-quality food grains and other offi-

regional controller (RC) of food, said, ". spoke with the contractors and assured them of taking necessary steps."

In order to probe into the allegations, they yesterday formed a three-member committee headed by the district controller of food in Bogra, he said, adding that the committee has been given one week's time

to submit its report. The contractors said, the warehouses where most of the 100 trucks were refused to be unloaded were in Shantahar of Naogaon

and Muladuli of Pabna districts. The trucks were also refused in Shingra, Bonpara and Gurudaspur in Natore; Bogra Sadar; Talora in Sirajganj; Mohimaganj and Kandia in Gaibandha; and Thakurgaon

Due to the refusal, the contractors had to incur losses as the trucks, hired for one day, were forced to overstay.

The general secretary of the association, Shah Alam, said food officials are supposed to declare the status of the grains before those are loaded onto a truck, but the officials often ignore the rules.

For each day of delay, they incur a loss of Tk 4,000, he said, adding that they were forced to start the 72-hour strike, but they would declare an indefinite strike if the authorities concerned do not take proper

measures.

2 Indians among 5 sued for money laundering

The Anti-Corruption Commission (ACC) yesterday filed two cases against five persons including two Indian citizens for their alleged involvement in laundering Tk 64.29 lakh abroad. ACC's Deputy Assistant Director

Muhammad Shihab Salam filed the cases with Kalabagan Police Station against Yogesh Kakar, and his wife Ruby Kakar, managing director and director of Regency Packaging Limited and Regency Trims Limited respectively.

The three others accused in the case are HSBC officials Ahmed Habib, Sohag Chakma and Tahmim Hasan of Overseas Payment and Investigation department.

According to the case statement, the couple sent an extra Tk 19.5 lakh to a USbased T-shirt company as commission without taking approval from Bangladesh Bank.

The three bank officials cleared the trans-

action although Yogesh and his wife could not produce supporting documents in this regard, the statement added.

Another case stated Yogesh directed the bank officials to draft an illegal credit agreement and sent Tk 44.79 lakh to one Amarson Overseas Pvt Ltd of India. The bank officials assisted in the transaction and also concealed the information.

A probe by ACC revealed Yogesh as the director of Amarson Overseas Pvt Ltd.

"Habib and Sohag gave clearance for the transaction, although Yogesh could not provide supportive documents in this regard," the FIR said.

Contacted, Talukdar Noman Anwar, head of marketing and communications of HSBC Bank said he is yet to know anything on the issue.

"However, we're respectful of the regulations of Bangladesh and will cooperate with the authorities concerned," he added.

THREE-WHEELER BAN ON HIGHWAYS Villagers block Dhaka-Ctg highway, demand bus stop

Suffering from lack of transport amid the strict enforcement of banning three-wheelers on Dhaka-Chittagong highway, residents of 10 villages in Chouddogram yesterday blockaded the highway for about an hour.

The villagers from Kalikapur union gathered on the highway in Noabazar area around 9:00am, demanding a bus stop there.

They said two bus services -- Jamuna and Madina -- ply the highway between Chouddogram and Feni. But those do not stop at Noabazar and there has been no transport since law enforcers imposed the ban on three-wheelers on the highway, protesters said.

The agitators cleared the road after about an hour following highway police's assurance of addressing the issue.

Mahbub Hossain, chairman of Kalikapur union parishad, said, "I understand the reasons behind this demand. In Noabazar, there's a branch of Sonali Bank, a government primary school, a village health care centre, the union parshad office and a number of factories. Thousands of residents of the 10 villages have been suffering due to the transport crisis."

A total of 225 prosecution witnesses and 20 defence witnesses testified during the proceedings.

On August 21, 2004, a grenade attack killed 24 leaders and activists of Awami League and its associate bodies and injured over 300 others.

Ivy Rahman, the then Mohila Awami League president, was among the deceased.


Sheikh Hasina narrowly escaped with an ear injury.

Two cases -- one for murder and another under the Explosive Substances Act -- were filed with Motijheel Police Station.

In March 2012, the tribunal framed charges against the accused in the two cases.

Of the 49 accused, eight, including three former inspector generals of police, are now on bail; 18, including BNP Senior Vice Chairman [currently acting chief] Tarique Rahman, are on the run; and 23, including Babar and Pintu, are in jail.

Deception leads to tragedy

On a January afternoon, 80-year-old Amrito Bala was at home alone. Some people arrived at her doorstep and identified themselves as census bureau officials.

They spoke to her for a while, inquired about her homestead and took her fingerprints on a paper.

They also handed her a packet, told her to "buy some sweets" and left in a

When her son, Ratan Barua, got home and opened the package he found Tk 8,500 inside it.

Not knowing what to do with the money or who to contact regarding it, they left it aside.

The incident took place at Barua Para of Raozan upazila in Chittagong. What transpired next was beyond

her comprehension. Just after a few months, in June, she saw some labourers digging large holes for piling works, a few yards away from

Her sons tried everything to stop the work. They said they contacted all the high-ups of the power development board (PDB), but to no avail.

As a last resort, they also went to the court in June but lost the battle due to the fact that their mother's fingerprints were on the documents.

For the family, disaster did not end there. Tragedy struck again.

Amrito Bala suffered a massive cardiac arrest in August.

"After passing days regretting what happened, my mother passed away on August 18," said Ratan Barua.

"This 20-decimal land was all we

had. This was our ancestral homestead." "Now they [REB] want to grab it. Even after the death of my mother, they

did not stop," the 45-year-old said. "All we have left is the home now," he added.

"I also called REB office many times. They told me to remain satisfied with the money," he alleged.

He said this has happened to them

Misery has been stalking the family since 1985 when the first electricity tower was installed on their land, though there were empty lands available, he claimed.

"It's the same now. They could have

Elderly woman dies after losing part of ancestral land actually from Rural Electrification set up the tower on an open space. But they chose ours to evict us from our

ancestral land," alleged Ratan, a tech-

On June 14, the family filed a writ

petition with the High Court. On June 28, the HC issued a stay order to stop the work for six months.

Jyotirmoy Barua, lawyer for the writ petitioner, said REB obtained permission from Amrito Bala through fraudu-

As per existing law, an acquisition has to be done through the office of Deputy Commissioner (DC) of Chittagong and REB would pay the compensation money to the DC.

Then the DC, following legal procedures, would pay compensation to the

family. He said REB has no authority to acquire any land on their own or pay compensation directly to anyone.

The lawyer also said as per "Dayabhaga" (Hindu inheritance law), a woman cannot be the owner of her husband's property. So, Amrito Bala had no legal authority to give

consent anyway, he argued. "The Appellate Division without considering these facts accepted REB's argument that they have paid TK 20,000 to Amrito Bala and vacated its earlier stay order," he said.
