A cancer patient died while he was undergoing treatment by a local quack at Chatodda of Chandina upazila on Monday. The dead, Shamim Khan, 45, son

Kalam asked him to drink all the bottles of rose water. After drinking 60 bottles of the flavoured water, Shamim began feeling sick and said he could not drink anymore.

However, Kalam forced him to drink from the remaining bottles. At one stage, Shamim became unconscious and then died on the spot.

News of his death incensed locals. A mob picked up Kalam and handed him over to police.

Shamsul Islam, officer-in-charge of Chandina Police Station confirmed

the incident. A case was filed against Abul

The gazette, signed by Md Mahbubar Rahman Sarkar, deputy secretary (administration-1) of the ministry, said the proceedings could not be held at Bakshibazar because it is a crowded area. Instead, the trial would take place at a temporary court at Room-7 of the jail's administrative building.

Asked, Deputy Commissioner (prosecution) Anisur Rahman told The Daily Star that the government has set up a temporary court for the trial. Judge Md Akhtaruzzaman of the Special Judge Court-5 of Dhaka will be holding the trial from today. In 2016, the law ministry had issued

another gazette, saying the trial proceedings in the two graft cases would be held at the makeshift court at Bakshibazar. Contacted, Khaleda's lawyer Masud

Ahmed Talukder said the decision for holding the trial inside the jail was an "illegal attempt". Any trial should be held where everybody has access. "But the jail is a restricted area

where nobody can enter easily to witness the trial," he said.

The Anti-Corruption Commission had filed the Zia Charitable Trust graft case against Khaleda and three others with Tejgaon Police Station in August, 2011. According to the case statement, the former prime minister and three others abused their power and raised funds for the trust from unknown sources.

The three others are Harris Orphanage Trust graft case on Chowdhury, political secretary to the then PM Khaleda, Ziaul Islam Munna, assistant private secretary (APS) to Harris, and Monirul Islam Khan, APS yesterday, saying the proceedings in to former Dhaka City Mayor Sadeque Hossain Khoka.

'IT'S TRIAL IN CAMERA'

BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday said the government's decision to try Khaleda Zia inside the old Dhaka central jail in the Zia Charitable Trust graft case was "contradictory to the country's constitution".

"We are considering it as a trial in camera. We are demanding withdrawal of such a decision," he said.

The BNP leader was speaking at a press conference at the party chief's Gulshan office last night, hours after the government issued a gazette notification over holding her trial inside the

Fakhrul warned of waging a tougher movement immediately if the decision was not withdrawn. "We are telling very clearly that it is a

blatant violation of the constitution. According to article 35 (3) of the constitution, the trial will have to be held in public," he said. Article 35 (3) of the constitution

stipulates that an accused in a criminal case shall have the right to a speedy and public trial by an independent and impartial court or tribunal established "The civilian rights of a former

prime minister are being violated by violating the constitution. What can be a bigger offence than this?" Fakhrul questioned.

Strongly condemning the government's move, he demanded immediate release of Khaleda for the sake of holding free, fair and inclusive general elections.

Shamsul Alam, a senior planning ministry secretary and member of the General Economic Division (GED) who placed the Delta Plan at yesterday's NEC meeting, said the barrage project would be implemented once funds are available.

Asked about its inclusion despite the PM's reservation last year, he said that before the approval, they presented the Delta Plan before the PM, and she did not reject it.

All projects under the Delta Plan would be implemented by the next government, Planning Minister AHM Mustafa Kamal later told The Daily Star.

The 80 projects would require about \$37 billion in phases, he added. "So, money would not be a problem."

The projects were picked from 133 priority projects chalked out by various ministries and divisions, a planning

ministry official said. Of them, the Ganges Barrage project would cost the highest, an estimated \$5.15 billion, according to the Delta

Plan document seen by The Daily Star.

Once built, the barrage would facilitate irrigation, help restore ecological balance and increase livelihood opportunities in the project area in Rajbari district, some 98km downstream from the Farakka barrage. It will also ensure the use of water to be available under the 1996 Ganges Water Sharing Treaty with India, according to the document.

In 2009, the government hired DDC and Associates Ltd as an international consultant for conducting the feasibility study as well as preparing the design. The firm submitted its report in 2013.

ern region and help reap a net benefit of Tk 7,340 crore every year, says a government study. After the construction of the bar-

Arrest order issued for slain Jubo League leader's wife

The widow, eight others sued over making 'derogatory comments' on religious affairs minister

Dilruba Akhter Dilu, wife of a slain Jubo League leader, and eight others have been sued for their alleged derogatory comments on Religious Affairs Minister Motiur Rahman. Mustafizur Rahman Shaheen,

joint secretary of Muktijuddha Sansad Sontan Command, Mymensingh district unit, lodged the case with Cognizance Court No-1. Additional Judicial Magistrate Rozina Khan of the court accepted the case and issued an order of arrest for Dilu this afternoon, said Abdur Rahman Al Hossain Taz, who stood for the plaintiff. Dilu is the wife of slain Jubo

League leader Sajjad Alam Sheikh Azad alias Azad Sheikh of Mymensingh town's Akua area. Azad, a member of the Jubo League City Convening Committee, was shot and hacked to death in his locality on July 31. In the case, the plaintiff alleged

that the accused addressed a rally over the killing of Azad on August 28 where they termed the minister a "Rajakar". Later, the incident went viral on social media. Following the killing, Azad's wife

Dilu lodged a case with Kotwali Police Station on August 2 accusing some 25 named and 10 unnamed persons. Mohit-ur-Rahman Shanto, Motiur Rahman's son and secretary of Awami League Mymensingh City unit, was made the prime accused in the case. However, the case was not recorded at the time.

Police finally recorded the case following a High Court order on Friday night, a month after it was filed with Mymensingh Kotwali Police Station.

Meanwhile, Dilu claimed they never made any derogatory remarks about the minister. "The case was lodged only to harass us and with a view to turning the murder case into another direction...," she said.

Using the plane on medium-haul flight has its vices. The plane would chew through its 44,000 flight-cycle designed life faster.

With one 787-8 already on the tarmac of Hazrat Shahjalal International Airport and one more due later this year, Biman seems to be on damage limitation mode.

Secretary-in-charge Mohibul Haque of the civil aviation ministry said the 787 would be used for KL flights because now they use a much bigger Boeing 777-300ER to serve the destination. He said the 777 on that route was not always full and placing the 787 there would save Biman a lot of fuel bills.

He said Biman was tired of paying the expenses of leased planes so it had opted to gradually remove the leased aircraft and replace them with their own planes. The Civil Aviation Authority of

Bangladesh (CAAB) being labelled subpar by the US Federal Aviation Administration (FAA) only made things worse for Biman. It blocked Biman from opening the Dhaka-New York flight.

Mohibul, however, was hopeful that in 2019 the FAA would place CAAB in category-1, allowing Biman to serve US cities. But still, that's just one long-haul

route for the 787. Biman would have the first commercial flight of four 787s in 2019. Shakil Meraj, general manager for

public relations at Biman, recently said the airlines plans to expand its routes and include cities like Hong Kong and Rome and increase flight frequency to London.

He, however, did not say when these would happen.

Had Biman planned better, researched the market better, bought landing rights to new destinations and got the required paperwork done, the new Dreamliner christened Akashbeena would have flown today to a destination much further than Kuala Lumpur. Now Biman has a somewhat mod-

ern fleet. Gone are the inefficient gas guzzling DC-10s and A310s. Biman has an all Boeing mid- to long-haul planes and Bombardier Dash-8 Q400s for short-haul flights. With the two leased Dash-8s, Biman serves mostly national destinations,

while the four Boeing 737-800s (two leased) and four 777-300ERs are used for regional and long-haul destinations in Asia, the Middle East and London. "Biman touched a new milestone

with the addition of Dreamliner Akashbeena to its fleet," said AM Mosaddique Ahmed, the national flag carrier's CEO, yesterday.

But Bangladeshis expatriates, a large number of whom reside in Montreal, Sydney, Los Angeles and New York, won't be served by this new plane.

Despite the shortcomings of Biman, Bangladeshis like to use Biman when possible. It often is a matter of patriotism for them but in many cases, it is the more than generous luggage allowances the carrier offers to its passengers. These people want to use Biman

and Biman needs to figure out the business end for this demand. It needs to open routes to distant cities, buy landing slots, be punctual and provide better inflight services. Biman is late to its own party and it

were grounded for four months following issues with its lithium-ion batteries. Some carriers, which had opted for the Rolls-Royce Trent-1000 engines for their Dreamliners, had to cancel flights

and ground their planes due to engine

issues and safety inspections by Rolls-Biman chose General Electric engines for all its 787s.

## '7,000 Bangladeshis'

"We gave illegal immigrants the opportunity to surrender themselves voluntarily through the 3-plus-1 programme which ended on August 30.

department boss. Meanwhile, commenting on the operation carried out at the Sepanggar and Kota Kinabalu areas from midnight to 4:00am yesterday (Malaysian time), Mustafar said 58 illegal immi-

grants were detained. "This operation will continue throughout the country, and we want our country to be free of illegal immi-

grants," he added. The major crackdown beginning on September 1 drew criticisms from the rights groups who demanded halt to it, arguing that most of the migrants were victims of exploitation

or trafficking. There are some one million Bangladeshi migrants, and nearly 50 percent of those are estimated to be undocumented, an official of Bangladesh High Commission in Kuala Lumpur told this newspaper
