Pompeo is due next to visit India, Pakistan's neighbour and bitter foe, where he is expected to pile pressure on New Delhi over its purchases of Iranian oil and Russian missile systems.

Pompeo and US Defense Secretary Jim Mattis will meet their Indian counterparts in New Delhi today, and are expected to finalise defence pacts that could bring their militaries closer amid China's rising influence, reported Reuters.

ASSAM CITIZENSHIP ROW

SC defers claims, objections receipt

India's Supreme Court (SC) yesterday again deferred the process of receiving claims and objections with regard to the final draft of Assam's National Register of Citizens (NRC) until further orders.

The final draft of Assam's NRC was released July 30. It said 2.89 crore of 3.29 crore people who applied are considered citizens of the country. Of the more than 40 lakh people not in the final draft, as many as 37.59 lakh names have been rejected and 2.48 lakh names have been put on hold.

The process for making claims and objections by those left out was set to begin on August 30 and continue till September 28. Last Tuesday too, the apex court deferred the receipt of claims and objections to Assam's final draft of the NRC from the earlier scheduled August 30.

NRC coordinator Prateek Hajela yesterday submitted a report to an SC bench of Justices Ranjan Gogoi and R F Nariman suggesting that only 10 of the 15 documents originally permitted to prove citizenship be allowed to be filed with claims and objections by the people whose names have been left out of the final NRC draft.

The SC asked the Centre and other stakeholders to respond to this suggestion of the NRC coordinator within two weeks. It then scheduled the next hearing for September 19.

When the attorney general forcefully said that the Centre has a larger interest to look after and should be given a copy of NRC coordinator's report to articulate its response, the bench told him that it is not necessary to give a copy to Centre at this stage.

US Vice President Mike Pence on Tuesday called on Myanmar's government to reverse a court ruling that imprisoned two Reuters journalists for seven years and to release them immediately.

The journalists were found guilty on Monday on official secrets charges in a landmark case seen as a test of progress toward democracy in Myanmar, which was ruled by a military junta until 2011.

Wa Lone, 32, and Kyaw Soe Oo, 28, were investigating the killing by security forces of Rohingya villagers at the time of their arrest last December, and had pleaded not guilty.

"Wa Lone & Kyaw Soe Oo shd be commended-not imprisoned—for their work exposing human rights violations & mass killings. Freedom of religion & freedom of the press are essential to a

strong democracy," Pence wrote on Twitter. Pence is the most senior US official to add his voice to an international outcry against the verdict by a Myanmar judge, who said the two had breached the colonial-era Official Secrets Act when they collected and obtained confidential documents.

"Deeply troubled by the Burmese court ruling sentencing 2 @Reuters journalists to 7 years in jail for doing their job reporting on the atrocities being committed on the Rohingya people," Pence wrote in another tweet.

US ambassador to the United Nations Nikki Haley said on Tuesday that the United States would become more vocal about the

two journalists' situation. Speaking at a news conference in New York marking the US assumption of the rotating chairmanship of the Security Council for September, Haley said

the reporters were "in prison for telling the truth."

Mark Green, administrator for the US Agency for International Development, said "these convictions are an enormous setback for democracy and the rule of law in Burma."

The verdict came amid mounting pressure on the government of Nobel laureate Aung San Suu Kyi over a security crackdown sparked by attacks by Rohingya Muslim insurgents on security forces in Rakhine State in west Myanmar in August 2017.

Boat with nearly 40 sinks in Indian river

TNN, Guwahati

A mechanized country boat carrying about 40 passengers and eight two-wheelers sank in the Brahmaputra river near Guwahati at around 1:30pm yesterday. Nearly 12 passengers swam out to safety on their own, but the rest, mostly women and school children, are still missing. A 25-member team of State Disaster Management Authority

has been pressed into rescue operations immediately.

After nearly two hours, SDRF divers have so far fished out a body of a teen-aged girl. The search operation is still on in the mighty river that is in full spate.

The boat was carrying passengers from Guwahati to north Guwahati when its engine suddenly stopped and it sank just about 200 metres away from the bank.

One of the survivors, Utpal Chamua said that he saved his life by jumping on to the rescue boat but the others did not have time and went into the river along with the boat. "We threw life jackets from the rescue boat to those who were trying to swim and one woman who was swimming with her child wrapped around her could be saved," he said.

According to sources, the boat was carrying nearly 40 passengers of which only 24 persons had boarded with tickets.

with India's bridges?

A 66-foot deck of a bridge in south Kolkata collapsed on Tuesday evening, snuffing out one life, trapping several people and crushing many vehicles. The bridge is over 40 years old. Biker Soumen Bag, who happened to be crossing the bridge, died after he fell headlong into the wedge as the deck split into two.

BRIDGE AFTER BRIDGE: This is the second major bridge collapse this year after Varanasi in which 18 people lost their lives and the fifth big one in the last two years In 2016, an underconstruction flyover had collapsed on Vivekananda Road in Kolkata killing 27 people. In the same year, 22 people died when a Britishera bridge on the Mumbai-Goa highway collapsed.

Warning bells for the Majerhat bridge were first raised in 2015 but went

unheeded. And it's not the only one. A government survey of 1.62 lakh bridges released in 2017 found 23 on national highways were over 100 years old, 147 required immediate attention and 6,000 were struc-
