A Natore court yesterday placed bus driver Shamim Hossain on one-day remand in a case for road accident here.

Earlier, police produced Shamin and his helper Abdus Samad before the Court of Senior Judicial Magistrate Sultan Mahmud and sought a five-day remand for both.

After hearing, the court allowed the police to take driver Shamim on one-day remand and granted bail for helper Samad.

On 25 August, at least 15 people were killed and 20 others injured when a passenger bus of Challenger Paribahan collided head-on with a human haulier, locally known as Leguna, on Natore-Pabna highway.

Police filed a case with Lalpur Police Station accusing seven people on August 26.

Ujirpur-Harta Road

Dilapidated for two years

Around five km of the busy Ujirpur-Harta road, connecting Barisal with several upazilas, have remained dilapidated for two years, causing sufferings to thousands of people.

The road connects the district town and different unions of Ujirpur upazila.

The 27 km Ujirpur-Harta road is in bad condition and the five km section from Dhamura College gate to Cherakhali has deteriorated over the last two years.

Due to heavy rainfall, mud, waterlogging and lack of maintenance by the authorities concerned, many cracks and potholes have developed on this part of the busy road.

The situation turned from bad to worse after heavy rainfall this year. Thousands of passengers, especially women and patients, who travel through this section go through a bad experience due to the state of the road.

Plying of loaded trucks stopped one year ago due to the bad shape of the road, said a trader at Dhamura Noton Das Gupta uses the road to

go to college from his residence in Ujirpur. He said the road has become unusable and may cause accidents. The vehicles get stuck in a gridlock

on the road, sometimes throughout the day, since they need to ply slowly and take much time due to the dilapidated road.

Abdul Hakim, a freedom fighter in Dhamura union, said villagers appealed to the Local Government Engineering Department (LGED) in Barisal one year ago to reconstruct the road, but did not get any response.

Miraj, supervisor of a local bus, said around 16 local buses and hundreds of three-wheelers ply the road every day, and traffic sometimes gets stuck due to the bad condition of the road.

The bus owners' association repaired the road temporarily with bricks and sand for continuation of bus service, he added.

Locals blamed the poor repair work that was done three years ago for the present situation.

District LGED Deputy Assistant Engineer Humayun Kabir said the government has planned to widen the road from 10 feet to 16 feet and called a tender of Tk 4.5 core for repairing the five km dilapidated road.

He said repair work will start within three months.

As rape victim is over 40! towards my home alone through a village

A housewife, raped allegedly by two neighbours at Chhatarpur village under Bishnapur union in Bijoynagar upazila on Tuesday, is undergoing treatment at Brahmanbaria Sadar Hospital.

Family members of the victim, 40, also mother of 12 children, said they went to Bijoynagar Police Station to file a case, but police said rape case cannot be filed if a woman is over 40.

"Instead of receiving the case, the OC phoned the local union parishad Chairman Jamal Uddin Bhuiyan to resolve the matter socially," said Roman Mia, nephew of the victim.

The victim told journalists that she was returning home with Tk one lakh from her parents' house at Durgapur village in Akhaura upazila on Tuesday to send her son abroad.

"After getting down from an autorickshaw on a nearby road, I was walking

path around 11:00am when neighbours Nuru Mia, 35, and Osman Mia, 40, waylaid me at Shilbari More," she said. "They snatched away the money, tied

my mouth and forcibly took me to a garden. They raped me there, leaving me senseless," she said.

A relative while passing by found her lying unconscious and arranged sending her to Brahmanbaria Sadar Hospital.

"The victim was suffering from intense bleeding and acute pain. Sample has been collected for medical test," said Smriti Rani Roy, in-charge of nurses at Gynaecology and Maternity ward of the hospital.

Bijoynagar OC Md Ali Arshad said, "I don't know about the victim's family members' coming to the police station as I was outside. I did not ask the UP chairman to resolve the matter. If anyone contacts us, we will provide legal support."

BSF returns challenged woman in Kushtia

Indian Border Security Force (BSF) returned a 40-year-old physically challenged Bangladeshi woman through a flag meeting on Tuesday, five months after she crossed the border illegally.

The flag meeting was held between BSF and Border Guard Bangladesh (BGB) at Challishpara border point in Daulatpur upazila of the district in the afternoon.

Nayek Subedar Fazlur Rahman, commander of BGB's Ramkrishnapur Camp under 47 battalion, said mentally challenged Sheuly Khatun, wife of Didarul Islam of Challishpara village in Daulatpur upazila, crossed the border illegally on April 5 and went missing.

Informed by family members, BGB wrote to adjacent Jalangi BSF camp under Murshidabad district of West Bengal on April 12.

On September 3, BSF of Jalangi camp informed the Ramkrishnapur BGB about rescue of the woman.

After necessary procedures, both border forces sat at a flag meeting. Later, the woman was handed over to her family.

on Thursday night. Prime accused Abdur Rashid, an ward level secretary of Awami League's Gafargaon union unit, was expelled from the party after the incident, said Ismail Hossain, former joint convener of the union AL.

Riad's college going sister Neelful Nahar Shanta said her brother was brutally beaten to death over theft charge at Ghagra Uthori Tower Bazar seven days ago but the prime accused are yet to be arrested.

"We are helpless as the accused are influential people," she said.

Neelful demanded immediate arrest and exemplary punishment of the killers.

Police on Tuesday arrested a man from Jamalpur municipality area in a case for killing Chan Miah, an electrician, in Melandah upazila early Monday.

Police detained prime accused Selim, 35, son of Jalim Uddin of Poirbari village, after deceased's elder brother Altafur Rahman filed a murder case with Melandah Police Station, naming two people and five to six others unnamed on Monday.

Polie produced Selim before Jamalpur Chief Judicial Magistrate Nazmul Haque, seeking a 10-day remand yesterday. The court fixed September 9 for next hearing and sent him to the jail.

According to the case statement, Chan Miah, 35, son of Alauddin, went out of his house after receiving a phone call from Selim on Sunday midnight and did not return home.

The following morning, villagers found his body at an Aman field, about a kilometre from his house, police said.

Prime accused Death trap for fish hunting birds

Lessee encircles his pond with fishing nets to prevent it from bird attack

Different species of birds, mainly the fish eating ones, have fallen into a death trap and died in Sadar upazila after the lessee of a pond encircled the entire water body with fishing nets, locally known as current nets, to save the fish from birds attack.

Villagers said at least four owls, a black cormorant, locally called pankouri, and a number of bats died in the last couple of days after they got entangled with current nets surrounding a 1.5 acre fish pond at Sundara Pirpukur village in the upazila. Local people said one Wazed Ali


of the village took lease of the pond in July this year for fish cultivation. Pankouri, one of the fish eating

birds, used to move around ponds or other water bodies in search of fish, villagers said. As a large number of fish eat-

ing birds started thronging around the pond, the lessee recently encircled the entire pond with current nets to prevent it from birds attack and boost its fish production, they said.

"Actually it is a death trap for the
