#### Plying of vessels suspended in Padma

The plying of launches and speedboats were suspended yesterday on the Shimulia-Kathalbari route due to strong currents in the Padma river.

Around 300 vehicles were stranded on both sides of the river, causing hundreds of passengers to suffer, said witnesses.

Meanwhile, only 14 of the usual 18 ferries operated on the route yesterday, carrying less than their capacity, due to poor navigability, said Khandakar Shah Khaled Newaz, assistant general manager of Bangladesh Inland Water Transport Corporation (BIWTC), adding that it took about 20-25 minutes longer than normal for the ferries to make a

He further said that launch and speedboat services have been suspended since 9:00am yesterday to avert any possible accident. "The next course of action will be taken after observing the river's situation today," he added. As launches and speedboats

people have free access. "How could it be a camera trial when the door of the court remains open? They [BNP leaders] are bringing such an allegation only to confuse people," she said, adding, "I

would like to clearly tell the nation that it's not a camera trial." Mentioning that the BNP chief was allowed to keep her maidservant Fatema inside the jail with her, Hasina questioned whether the con-

stitution or the law permitted a convicted person to take her domestic help with her in the jail. "Is there any such example anywhere in the world? I would like to have an answer from BNP leaders to this question."

She also warned that the government would withdraw the maidservant if the BNP leaders failed to come up with a reasonable answer justifying Fatema's stay in jail with Khaleda. "Because, no one has the right to

# Makeshift court in jail illegal: SCBA chief

Law minister says it's for smooth proceedings and her security

Supreme Court Bar Association President Zainul Abedin yesterday demanded cancellation of the law ministry's gazette that made way for holding trial of BNP Chairperson Khaleda Zia at old Dhaka central jail.

"The government has illegally set up a makeshift court inside the jail to hold a camera trial and punish the BNP leader illegally," he said while addressing a press conference at the SCBA auditorium.

Saying that the trial in the makeshift court is contradictory to section 352 of the Code of Criminal Procedure (CrPC), Zainul, also a BNP vicechairman, alleged that the government's motive was to keep the proceedings off limits to the public and the media. According to section 352 CrPC, a

court will be set up at such a place where people can enter.

Meanwhile, denying the allegation of camera trial raised by the SCBA president, Law Minister Anisul Hug was sentenced to five years' imprisonsaid the court had been set up to ensure ment in the Zia Orphanage graft case.

"Khaleda did not appear before the court for the last seven months citing security reasons."

The attacks came after Pyongyang sent a letter to the United Nations, demanding that Sony not move forward with the movie "The Interview" that portrayed the US-backed assassination of a character made to look like North Korean leader Kim Jong Un.

Park used a series of online personas for social media platforms, including on Facebook and Twitter, to send malicious links to individuals involved in the production of "The Interview," the complaint said. The malicious links carried North Koreancontrolled malware.

In November 2014, Park allegedly launched the same style social mediafocused attack against employees of AMC Theatres . The movie theatre chain in some cases delayed or canceled screenings of "The Interview" nationwide, Variety at the time reported. The complaint said there was no evidence AMC Theatres was

popular rose-ringed parakeet.

A common bird, the rose-ringed parakeet, scientifically known as Psittacula Kramer, can be found across the southern part of the Indian subcontinent and throughout the South Asian countries as well as some African nations.

Atikur Rahman Atik, a local of the Demazani Bazar area, said, "I have been watching the parakeets on this tree since I was young. However, the numbers seem to be decreasing day by day over the last few years."

Locals said that over the past six years, the number of birds in the area has been plummeting at an alarming rate due to many reasons, including trapping and ill-treatment.

SM Iqbal, a local bird expert currently working as associate professor of the zoology department in Tangail's Govt. MM Ali College, said the roseringed parakeet is one of the few parrot species that have successfully adapted to living in "disturbed habitats".

They feed on cereal grains, buds, fruits, vegetables, nuts, berries, and seeds, especially of the sunflower, he said, adding that the bird has become a popular house pet due to its unique ability to impersonate the human voice.

"Even though it's a common bird, its numbers have been decreasing rapidly, in the last decade or so, mostly in urban areas. Loss of habitats caused by deforestation, trapping and hunting are the primary causes for this."

Pradip Mahant, another local, said, "More than 100 pairs of the roseringed parakeet used to live in this old Mahogany tree alone, but now there is a maximum of 10 pairs left. Both the tree and the parakeets taking shelter in it stand as a memory of the Zamindar regime during the British period. Proper measures should be taken by

the government to preserve them."

Last year, the WannaCry ransomware attack affected thousands of businesses across the globe through a computer virus that encrypted files on affected systems, including Britain's National Health Service, where nonfunctional computer systems forced the cancellation of thousands of appointments. John Demers, the Assistant Attorney

General of the National Security Division, said on Thursday that this marks the first time the U.S. Justice Department has formally charged a hacker in connection with cyber crimes "sponsored" by the North Korean government.

"The department has charged, arrested and imprisoned hackers working for the governments of China, Russia and Iran. Today, we add the North Korean regime to our list, completing frankly four out of four of our principle adversaries in cyberspace." A senior Justice Department official

said a criminal investigation into Park and his accomplices was still ongoing. There has been no communication between the US and North Korean government about a possible extradition, the official said.

No North Korean government officials were referenced in the complaint by name, though it does allege the government sponsored the attacks.

The complaint was filed under seal on June 8, just days before a historic summit in Singapore between US President Donald Trump and North Korean leader Kim Jong Un.

#### 5 Bangladeshis held by border patrol agents in Texas

US border patrol agents on Tuesday arrested five Bangladeshis in Texas. Laredo border patrol agents dis-

covered the five individuals walking near the Rio Grande, one of the principal rivers in the southwest US and northern Mexico, the local kgns.tv reported on Wednesday. Since October 1 last year, 609

Bangladeshis have been detained at the US border. When agents questioned the five

individuals on Tuesday regarding their immigration status, it was revealed that they were from Bangladesh. The individuals were processed accordingly, it added.

"The Laredo Sector Border Patrol continues to have the highest number of Bangladeshi apprehensions."

The report did not mention the names of the detainees or the route they took to reach Laredo. The Washington Times on April 18

reported that illegal immigrants from Bangladesh paid up to \$27,000 to international trafficking rings to ferry them from Asia to the western hemisphere, where they make their way up through Central America and Mexico to the US border, where they are led across the Rio Grande. "It's definitely a transnational

criminal organisation that's doing that networking," Scott Good, acting deputy chief patrol agent for the Laredo, was quoted as saying by the Washington Times. The transnational syndicates facili-

tate the entire trip from start to finish, he said.
