Bangladesh's garment exporters are now regretting for establishing green factories as they are not getting the benefits of the huge investment they made to make their industrial units environment-friendly.

"We could have invested the extra money to employ a one-third more workers."

Per capita carbon emission in Bangladesh is 0.46 tonnes a year whereas in

the US, the EU and Canada the figure ranges between 10 tonnes to 25 tonnes, he said.

So, Bangladesh's factories do not even need to get green certification from other countries or companies, Hasanat opined.

"Bangladesh is naturally green and the products we make here are also naturally "I regret that I have set up green garment

factories. The buyers do not want to pay even a single cent more for sourcing from a green garment factory," he said, while speaking at a dialogue on green compliance at the Metropolitan Chamber of Commerce and Industry (MCCI) in Dhaka yesterday. READ MORE ON B3

Islamic Development Bank President Bandar Hajjar yesterday stressed the importance of the private sector to improve the basic infrastructure in its member countries and achieve the Sustainable Development Goals (SDGs).

require \$1 trillion per annum to achieve the SDGs and \$700 billion to meet the growing demand for basic infrastructures, he said.

He said the multilateral development

banks have a financing capacity of \$147 billion per annum for the IDB's members.

"How will we fill up the gap? A vibrant private sector can only fill up the vacuum," he said at a press conference at the IDB Bhaban after the opening of the bank's regional hub in Dhaka.

Garment factory owners yesterday decided to negotiate with the government for gaining benefits like cash incentives or tax waivers to cope with an increase in wages for workers.

They also suggested adjusting the salaries in line with inflation instead of forming a wage board every five years.

"We will try to get benefit from the government in the form of cash incentives or tax waivers to adjust to increas-

ing the wage of workers," said at the door. For this the salary has to Siddigur Rahman, president of the Bangladesh Garment Manufacturers and Exporters Association (BGMEA).

He was addressing an emergency

general meeting on the wage board at BGMEA Bhaban in the capital. "You keep faith on me over nego-

tiations with the government," he of the Federation of Bangladesh assured garment factory owners.

He also said the moment was not favourable for them as the national parliamentary election was knocking

be increased as per the needs and abilities of the owners, he said. Earlier the BGMEA proposed to

raise the minimum wage to Tk 6,360 from the existing Tk 5,300 keeping inflation in consideration.

Shafiul Islam Mohiuddin, president Chambers of Commerce and Industry, said the wage board issue would not get due importance for the general election.



### No VAT on computer parts at trading stage: NBR

The revenue authority has withdrawn value-added tax (VAT) on computer parts and accessories at the trading stage to help consumers enjoy low prices.

The move comes three months after the imposition of a 15 percent VAT on parts and accessories of computers at the trading stage.

In the past two fiscal years since 2016-17, the NBR had been offering exemptions on computer parts and accessories. Bangladesh Computer Samity, the apex trade body for ICT business in Bangladesh, has been demanding removal of such VAT, which, it thinks, would fuel the prices of com-

Use of laptops and computers is increasing in Bangladesh. The market for laptops is annually growing by 12 percent, driven by a growing middle and affluent class and overall income, International Data Corporation, a

Singapore-based consulting firm, found in a survey. The laptop market in Bangladesh was worth \$165 mil-

lion in 2017, according to the IDC.

### Bangladesh behind neighbours: BIBM

Bangladesh is still lagging behind in terms of financial inclusion as only 1.6 percent of its wage earners receive their pay through banking channels, a study found.

When it comes to South Asian neighbours, it is 4 percent for India and 7.1 percent for Sri Lanka, it said, adding that Pakistan was just behind Bangladesh with 1.4 percent.

The research paper titled "Achieving SDGs in Bangladesh: The Role of the Banking Sector" was presented by the Bangladesh Institute of Bank Management (BIBM) at a seminar in its auditorium in the capital yesterday.

Md Mohiuddin Siddique, professor and director of the BIBM, lead the research team and presented the keynote paper. Bangladesh is yet to catch up in other aspects as

well. Some one third of its population have bank accounts whereas it is 53 percent in India and 82.7 percent in Sri Lanka.

Bangladesh is also trailing behind others regarding the use of debit cards, in savings and other financial activities, the research found. Just 5.2 percent of the population use debit cards whereas it is 22 percent in India and 24.9 percent in Sri Lanka.

The banking sector has a lot of space to improve in terms of financial inclusion to help achieve the Sustainable Development Goals (SDG), the report said.

However, the detoriaration of the financial health of state banks is a matter of concern for financial inclusion, it said.

Bangladesh Bank has opened special types of account like Tk 10 account, school banking and agent banking which furthered financial inclusion, said SK Sur Chowdhury, the central bank's banking reforms

adviser.
