



Riva Ganguly Das tipped to be next Indian envoy

Senior Indian diplomat Riva Ganguly Das, currently serving as Director General of Indian Council for Cultural Relations (ICCR), is expected to be the next High Commissioner of India to Bangladesh, diplomatic sources in Dhaka and New Delhi said.

She will replace incumbent Indian High Commissioner in Dhaka Harsh Vardhan Shringla, who is going to be the next Indian Ambassador to the United States.

However, the changes will take place after four to five months time.

Diplomatic sources said the government of India has almost finalised the decision to bring the changes, but official announcements are yet to be issued, as the change in Dhaka will take place early next year.

Shringla, who joined as the High Commissioner of India (HCl) to Bangladesh in November 2015, is expected to leave Dhaka after the upcoming general election slated for the end of December.

Though tenures of some other key Indian High Commission officials in Bangladesh have almost been completed and their new postings have already been announced, but important officials will leave Dhaka early next year, sources said.

Land grabbing: Ragib Ali and son back in jail

A Sylhet court yesterday rejected the bail petition of industrialist Ragib Ali and his son Abdul Hye and sent them to jail for a second time in a case filed for grabbing the endowment property of Tarapur Tea Estate by forging land documents.

Mohammad Mostain Billal, additional chief metropolitan magistrate in Sylhet, sent them to jail after they appeared following the order of a special Sylhet court, said advocate Shamim Ahmed, additional public prosecutor of the former court.

Earlier on August 9, Special District and Sessions Judge Dilip Kumar Bhoumik upheld the verdict of Sylhet's Chief Metropolitan Magistrate (CMM)

after hearing the appeal of Ragib and his son. The special court also ordered the duo to surrender before the lower court concerned before September 17.

On February 2 last year, they were sentenced to 14 years' rigorous imprisonment each by the CMM court and fined Tk 10,000 each, in default of which they will have to serve another three months in jail.

In 1990s, Ragib started grabbing the land of the estate after forcing its legal Shebayette (caretaker) Pankaj Kumar Gupta to leave the country.

After grabbing 422.96 acres of the estate, Ragib built a medical college hospital, sold 337 plots, and established some other structures on the land. In 1999, a parliamentary watch-

dog on land affairs found the allegations against Ragib true and recommended legal action.

Six years later, in 2005, then land commissioner of Sylhet Sadar SM Abdul Kadir filed two cases against six people, including Ragib, with Sylhet Kotwali Police Station -- one for grabbing the endowment property after forging documents of the land ministry and the other for misappropriating Tk 1,000 crore, the aggregate value of the property and the cash deposited in the bank accounts of the tea estate.

After a long legal procedure, the then Chief Justice SK Sinha ordered resumption of the case proceedings on January 19, 2016, and on May 15 that

BGB man held with 3,000 yaba pills

Police arrested a Border Guard Bangladesh member in Chittagong's Bakalia area early yesterday, with 3,000 yaba pills in his possession.

The arrestee, Nazrul Islam, was posted at Teknaf's BGB Battalion-2.

However, Chittagong Metropolitan Police (CMP) police officials did not want to talk about it on record.

A police official, seeking anonymity, said Nazrul was arrested from Shah Amanat Bridge area of Bakalia while he was coming from Cox's Bazar. He was in plainclothes at the time.

Contacted, Deputy Commissioner (South) of CMP SM Mostain Hossain said, "Police arrested a BGB member and seized the yaba pills. BGB authorities were informed about the incident and he was later handed over to them."

Talking to The Daily Star, Colonel Gazi Mohammed Ahsan, acting commander of BGB in Chittagong Region, said, "The detainee is posted at the Cox's Bazar region, so police have handed him over to Cox's Bazar BGB."

He added that Cox's Bazar BGB would investigate and take action accordingly.

Former Jamaat MP Shahjahan denied bail

A Chittagong court yesterday turned down the bail petition of eight leaders and activists of Jamaat-e-Islami including its former lawmaker Shahjahan Chowdhury and sent them back to jail in a case filed early last month under the special powers act.

Metropolitan Session Judge Akbar Hossain Mridha gave the order, said Public Prosecutor Fakhrudin Chowdhury.

Earlier, a court placed the eight on a two-day remand in the case on August 6, three days their arrest. Detectives of Chittagong Metropolitan Police detained them from a house in the city's Khulshi area.

After the arrest, detectives said Shahjahan and his seven associates gathered at the place to plot a sabotage plan taking advantage of the then ongoing road safety protests. Police later filed a case against them with Khulshi Police Station.

According to police, Shahjahan stands accused in 20 cases filed with different police stations in the district and city. He was elected MP from Lohagara constituency twice, and is the former nayeb-e-ameer of Jamaat's Chittagong unit.

Debaters of reputed Dhaka-based English medium school Sunnydale have taken the top two positions in the "high school" section of the Asian British Parliamentary (ABP) Debate Championships in Hanoi, Vietnam. "Sunnydale 2" team won the tournament, while "Sunnydale 1" became runners-up. Debojoyoti Biswas of "Sunnydale 1" was named the best speaker (school) of the tournament, while his teammate Al Wasee M Fahmidaula was named best speaker of the final, informed Salma Parvin, moderator of Sunnydale Debate Club. Jumanah Ahmed from

Viqarunnisa Noon School (VNS) was ranked second in the best speaker category of the tournament.

Eight school teams from Bangladesh took part in the event, among 30 teams from a number of Asian nations. Of them, two teams from VNS also made it to the semifinal.

The university-level segment of the competition saw nine Bangladeshi teams take part among 90 teams. Among them, two teams from Institute of Business Administration (IBA), Dhaka University, reached the open quarterfinals, among which Sajid Khandaker and Souradip Paul from "IBA 1" reached the open finals.

The minister said there is a good sign that most motorcyclists and pillioners are using helmet now. But those who defy laws in this regard are young political activists. He directed police to take action irrespective of their political identities so that all, including children, use helmets.

Talking about poor condition of public buses in the city, he said, "In last seven years, I have talked about poor condition of buses 700 times but nothing happened."

He requested bus owners to at least paint the buses, "to save our faces to the foreigners."

Lawmakers and local representatives from Dhaka, Munshiganj, Savar, Manikganj, Narsingdi, several secretaries, top officials from BRTA, BRRTC, Rajuk, DNCC and DSCC took part in the meeting held at DTCA's office.

The DTCA was established on September 2, 2012, to prepare strategic transport plan, provide regular supervision, and coordinate planning for transportation infrastructure development within Dhaka and nearby districts.

and it was asked to submit a report within 15 working days. On July 19, the committee was given 90 working days as it could not finish collecting information about the system.

However, the premier on July 12 citing a High Court order said it was not possible to reform freedom fighters' quota.

Cabinet Secretary M Shafiqul Alam, who leads the seven-member committee, on August 13 told journalists that they had suggested abolition of almost all quotas in civil service and to prioritise merit-based recruitment.

At present, about 56 percent of government jobs are reserved for candidates from various quotas.
