anti-government then, logically, the state appears to be anti rights, she

"Culture of fear and democracy cannot exist side by side."

Sultana also commented on the findings of New York-based research firm Wealth-X that the number of ultrawealthy people grew most rapidly in Bangladesh between 2012 and 2017.

"It means, we could not fulfil the promise of equal distribution of wealth." It also shows that corruption and

looting of people's wealth is continuing in different sectors.

Marginalised people are the worst victims, said Sultana.

Former chairman of National Human Rights Commission Prof Mizanur Rahman, Deputy Head of Mission at Australian High Commission Penny Morton, and General Secretary of Bangladesh Adivasi Forum Sanjeeb Drong also addressed the event.

panel to commemorate the 70th anniversary of the Convention on the Prevention and Punishment of the Crime of Genocide, she said support for the court is indispensable for both justice and deterrence. "I urge all States to support the

court, and in this, the year we commemorate the 20thanniversary of its founding with the Rome Statute, I call upon all remaining countries to sign or ratify the Statute," said the UN human rights chief in the statement. Genocide is always shocking but it

is never committed without clear, multiple warning signs: a pattern of abuse against a group, intent to harm, a chain of command and finally a brutal and horrifying outcome, Bachelet said.

"In the case of the Rohingya, warning signs abounded: a people oppressed from birth to death, an army answerable to no one, and systematic, state-led human rights violations that went unpunished for decades, including arbitrary deprivation of nationality."

States have the primary responsibility for prosecuting perpetrators, but the court's use is wholly appropriate in cases where the state is unwilling or unable to deliver justice, she

said. The Council's Fact-Finding Mission on Myanmar issued its shocking report on the military-led campaign of murder, rape and assault against the Rohingya people of Rakhine State.

US intelligence chiefs declared in January 2017 that Russian President Vladimir Putin presided over a concerted effort via hacking and social media manipulation to boost Trump's chances in 2016 to defeat Democratic rival Hillary Clinton.

The outgoing administration of Barack Obama hit Moscow with sanctions and expelled a large number of alleged Russian spies in retaliation.

But since becoming president, Trump has repeatedly dismissed the idea that he was helped by Moscow, calling it "fake news," and has avoided criticizing Putin.

Instead, the strongest action taken since then has been the issuing of indictments by Robert Mueller, the special counsel investigating possible collusion with Russia.

In the past year Mueller's team has filed charges against 12 hackers of the Russian GRU intelligence agency, and 13 people, including a top Putin crony, linked to the St. Petersburg-based Internet Research Agency, which US intelligence says is a major source of online disinformation.

The order sets up a 90-day time frame for assessing reports of any kind of interference by foreign individuals and companies, and then deciding on the appropriate sanctions, which include freezing assets, banning business dealings with Americans and locking the actors out of the US financial system.

While such powers already exist in the White House and US Treasury, Coats said the new order would set up an automatic and formal review, while giving Trump flexibility on what actions to take.

"We felt it was important to demonstrate the president had taken command of this issue, White House National Security Advisor John Bolton said Wednesday.

It came as Congress has been weighing its own legislation to punish those interfering in elections, which the White House reportedly fears could overly tie the president's hands.

Senators Marco Rubio and Chris Van Hollen, who have proposed legislation to attack foreign election interference, said Wednesday that Trump's

action was too restrained. The executive order "recognizes the threat, but does not go far enough to address it. The United States can and

must do more," they said in a state-"Mandatory sanctions on anyone who attacks our electoral systems serve

In a statement the Democratic National Committee said Trump's order "does nothing to hold Russia accountable" for 2016.

Nigeria troops repel fresh Boko Haram base attack

Soldiers have thwarted another Boko Haram attack on an army base in northeast Nigeria, the latest in a series of offensives against military targets in the remote region. Scores of fighters attacked the base

in Damasak, in the far north of Borno state, on Wednesday evening, firing heavy artillery in an apparent bid to overrun it. Hours of fighting ensued but the

attack was repelled with the help of aerial support, military sources in the Borno state capital, Maiduguri, told AFP yesterday morning. Nigerian Army spokesman

Brigadier General Texas Chukwu confirmed troops from 145 battalion were fighting the jihadists, calling the battle "fierce". "The troops are dealing with the

terrorists," he said on Wednesday evening. Chukwu's statement was a depar-

ture from the military's repeated denials of Boko Haram attacks in recent weeks, which have seen dozens of troops killed and weapons stolen. Last month, 48 soldiers were killed

in a raid in the village of Zari, near Damasak, while last Friday, a base was sacked in the town of Gudumbali.

Gudumbali is 80 kilometres (50 miles) from Damasak. Thousands of civilians were forced to flee and Boko Haram temporarily seized the town before withdrawing the next day.

Khandakar Mosharraf Hossain told this newspaper that the UN was concerned about the country's political situation and the parliamentary elections. "That's why they invited the BNP as

The premier said a centre-based healthcare service system would be introduced at the hospital, with specific outdoor departments for each centre.

The Emergency Medical Care Centre would offer 24-hour emergency services and nearly 4,000 people would receive treatment there every day, she added.

Referring to a survey, the PM said Tk 300 crore would be saved annually after the launch of the hospital.

Hasina said the trend of patients going abroad for treatment would slow down after the opening of the new hospital.

Medical universities would be set

up in all divisions of the country in phases to provide better medical services to the people and ensure higher education for medical students, the PM told the programme. "We've set up two medical universi-

ties in Chittagong and Rajshahi, while an approval has been given to establish another in Sylhet." Besides carrying out research, the

medical universities would offer postgraduate degrees, she mentioned. The PM urged all teachers, doctors, officials, nurses and employees of the BSMMU to devote themselves to providing medical service to the people
