## Digital Security Bill passed

Concerns of journos, rights activists ignored; opposition MPs raise objection; fear widespread over free speech, independent journalism

The much-debated Digital Security Bill 2018 was passed in parliament last night with a harsh provision allowing police officials to search or arrest anyone without any warrant.

The bill got through by voice vote amid opposition from a number of Jatiya Party lawmakers, ignoring concern of journalists, owners of media houses and rights activists over some of its sections.

Journalists and rights activists have expressed worries over the new law, saying it was passed without addressing their concern.

They also said the act goes against the main spirit of the constitution and will restrict free-thinking, freedom of speech and freedom of expression. It will also impede independent journalism.

Section 43 of the new law says if a police official believes that an offence under the law has been or is being committed at a certain place, or there is a possibility of committing crimes or destroying evidence, the official can search the place or any person there. In its final report on September 17, the parliamentary standing commit-

tee on posts, telecommunications and information technology ministry recommended that police would have to take permission from the director general of the Digital Security Agency, to be formed under the new law, before arresting anyone under the section.

However, during the bill's passage yesterday, Jatiya Party lawmaker Fakhrul Imam proposed dropping the provision [of taking permission from DG] on grounds that it would hinder law enforcers from "carrying out their duties properly".

Posts, Telecommunications and Information Technology Minister Mustafa Jabbar, who placed the bill before the House, then accepted his proposal, which was passed by voice vote.

At a meeting on Sunday, Sampadak Parishad (Editors' Council), a platform of the editors of the country's dailies, expressed its surprise, disappointment and shock at the committee's final report.

In a statement, the Parishad said they were "forced to reject the report" as it suggested no fundamental changes to sections 8, 21, 25, 28, 29, 31, 32, and 43 of the draft act that poses serious threats to freedom of expression SEE PAGE 2 COL 2

## Road Transport Bill gets JS nod

5 yrs' jail for causing death by reckless driving

Parliament last night passed two separate bills including the much-anticipated Road Transport Act-2018 amid criticisms over lenient punishments for deaths caused by reckless driving.

The other bill was aimed at recognising the top Qawmi madrasa degree Dawra-e-Hadith as equivalent to postgraduate degrees in Islamic studies and Arabic. (Story on page 3)

The road transport bill moved by Minister Obaidul Quader was unanimously passed by voice vote with Speaker

Shirin Sharmin Chaudhury in the chair. The Road Transport Act-2018 has provisions of five years' imprisonment for causing death by reckless driving, a punishment deemed lenient by road safety cam-

paigners. The development comes over a month after the cabinet approved the draft law.

India crushed Pakistan by eight wickets in their longawaited Asia Cup match which failed to live up to its hype in Dubai on Wednesday.


