Power cuts aggravate Ctg dwellers' sufferings amid rising mercury

Despite record numbers in power generation in the national grid, residents of Chattogram city are suffering multiple power cuts throughout the day, amid rising heat and humidity.

According to Bangladesh Power Development Board (BPDB), the country produced 11,623 megawatt electricity on Wednesday evening, exceeding the previous production record set just two days ago of 11,534 megawatt.

However, the port city continues to witness intermittent power cuts, lasting up to an hour in some areas, leaving residents short of breath.

City dwellers experienced 36.5 degree Celsius on Wednesday, which is the highest in last one year; 35 degrees on Tuesday and 35.2 degree Celsius on Monday, said Abdul Hannan, assistant met officer, Chattogram.

As residents sweat through humidity in the high fifties (percentage) and drivers honked their horns even more impatiently than usual, many decided to stay back home, only to feel restless owing to erratic electricity supply.

"It feels like getting roasted outside home, and staying inside the house without power feels like getting boiled," said Rafiqul Dewan, a college student from Halishahar.

Khaleda's bail hearing on September 30

A Cumilla court yesterday fixed September 30 for continuing the hearing on BNP Chairperson Khaleda Zia's bail petition in connection with the arson case filed in 2015.

Judicial Magistrate Mohammad Golam Mahbub Khan set the date after hearing arguments from the prosecution and defence.

"We need time to collect documents as it is a sensational case involving death of eight persons by Khaleda-led BNP and Jamaat alliance", said Public Prosecutor Advocate Mustafizur Rahman Liton after the court fixed the date. "According to requirements we have submitted all docu-

ments. But, the prosecution is deliberately delaying the proceedings," said Advocate Kaimul Haque Rinku, a defence lawyer for Khaleda. "Khaleda was not accused in the FIR (First Information

Report). But, was later implicated in the charge sheet," he added. "The judicial officers and record section are not cooperating with us. They have been delaying to supply necessary documents to us," said Advocate Taifur Alam, another lawyer for Khaleda.

The case was filed after eight people were killed and 25-30 others were injured when a bus was torched in Chauddagram area of Cumilla on February 2, 2015, during the anti-government agitation.

Says former info commissioner

There is growing concern among people about the use of the newly-passed Digital Security Act, as people have earlier seen misuses of the ICT act, said former chief information commissioner Prof M Golam Rahman yesterday.

He was speaking at a journalism award ceremony, organised by Society for Media and Suitable Humancommunication Techniques (SoMaSHTe) with support of USAID at The Daily Star Centre in the capital. It awarded 13 Dhaka and Rajshahi-based mainstream journalists and citizen journalists for their work highlighting importance of combating extremism and promoting peace in the country.

"Digital Security Act should be

applied to give people legal protection. The law should safeguard the digital media and thus help people enjoy the advantages of the digital media," Golam Rahman said.

Addressing citizen journalists,

Monjurul Ahsan Bulbul, chief executive

officer and chief editor of Ekushey Television, said there is no barrier to journalism, but there are some challenges. "As there were challenges before, newer challenges are coming everyday in various forms in journalism," he said,

adding that engagement of brave people in journalism will help the profession. "The information that any authorities don't want published is news. Journalists should report facts and stand by the truth," said former vice

3 held for 'theft' at Kabari's home

Gold jewelleries worth around Tk 12 lakh and Tk 5 lakh in cash have allegedly been stolen from former Awami League lawmaker and renowned actress Sarah Begum Kabari's Gulshan residence.

Gulshan police have arrested her car driver Mostofa, domestic workers Shelly and Kausar Mia in this connection, Abu Bakar Siddique, officer-in-charge of Gulshan Police Station, told The Daily Star.

The main suspect Ratan Paul is still at large, although 30 days have passed since the alleged theft took place.

Contacted, Kabari told The Daily Star that she first found the valuables missing on August 20 morning. She rushed to Gulshan Police Station and filed a case. She did not disclose the matter to media for various reasons.

According to the case statement, the main accused Ratan Paul, an acquaintance of Kabari and also a resident of Chattogram, came to visit her after 15 years. She gave him shelter in April. She gave him the responsibilities to look after her home as she was abroad that time. After several months, she found the valuables missing. In the meantime, Ratan had fled.

"Police should look into the matter more seriously instead of terming the incident suicide," he said.

Many of their classmates also found it impossible to believe that the girls com-

mitted suicide. When asked, Inspector Javed Masud said, "We will be able to know clearly what happened after getting autopsy reports." The bodies were handed over to the families after autopsies yesterday noon, he said.
