At least five children were abducted in Santhia upazila yesterday afternoon, said a victim who claimed to have escaped from the kidnappers.

However, police and upazila administration could not immediately confirm who were kidnapped but said a drive was going on to trace the kidnappers' vehicle.

The victim, Meem Khatun, 12, daughter of Md Ratan of Nariagodai village and a student of class five at Nariagodai Primary School, was handed over to her father.

Quoting Meem, Jahangir Hossain, officer-in-charge of Santhia police, said a black microbus stopped in front of her school when she came outside. Passengers of the vehicle forced her into the microbus making her unconscious with a handkerchief around 11:00am, she added.

The victim further said she got back her consciousness when the microbus reached Dhulauri point and jumped from the vehicle when it slowed down. The microbus went towards Ataikula Road, said the OC, adding, Meem ran to Demra Road in panic where locals rescued her.

"According to Meem's statement, four other unconscious girls were inside the microbus. But she could not identify any of them," the OC said. The law enforcers alerted nearby

police stations and a drive was going on to trace the microbus, the OC told this newspaper when this report was being filed. Talking to The Daily Star, Md

Jahangir Alam, upazila nirbahi officer, however said there was no report of any missing children in Santhia. He added they have informed all education institutions about the matter.

"All the education institutions in the upazila have been alerted. If any student is found missing, the school authorities concerned will report to us immediately," the UNO added.

driven home in light of the fact that since Shakib's debut in August 2006, Bangladesh had played just five matches without the two stalwarts that revolutionised the country's cricket - the last instance coming in March 2014. They lost three of those matches, the last win coming in November 2013.

But after attending the exam for three hours, Toriqul was in pain and had to leave without completing it. He said he requested the authorities to allow him special provisions for taking the exams, but the authorities did not accept it.

"I applied on Tuesday for allowing me to take the exam at the University Medical Centre. The doctors at the medical centre approved my application considering my condition. I don't know why the university authorities did not accept it," said a frustrated Toriqul, also a quota movement leader.

"I cannot even sit properly for a couple of minutes without feeling pain. How can I take the four-hour exam at a stretch like others?" He said the next exam is on October 2.

Contacted, M Babul Islam, exam controller, said, "We approve such applications if a student is suffering from an infectious disease."

Meanwhile, students of the university urged the authorities to allow Toriqul to take the remaining five exams at the medical centre.

This correspondent went to the vice chancellor's office around noon for his comments, but one of the officials there said he was at a meeting. The VC also could not be reached over the phone.

In the afternoon, an office secretary answered the phone and said the VC would be available in the evening. He was still not available for comments till filing of this report around 8:00pm.

adding that all the dead and injured were from Sajapur village.

Speaking to The Daily Star, Qaiyum mourned the loss of his wife and daughter as he lay on his hospital bed. "I left Savar with my wife almost 25 years ago. We lived in Dhaka where I worked as a rickshaw puller. We were going back to our village on the truck, driven by my brother's son, to fulfill my dream of living in the village with the rest of my family permanently. That dream was snatched away from

me by this tragedy," he said. Monirul Islam, a fire fighter at Bogura Fire Services and Civil Defense, who rushed to the spot along with the other fighters and later took part in the rescue operation, said, "The mother and daughter were sitting on the iron-rod angles along with their furniture while the others were in the driver's cabin."

The truck was carrying approximately 10 tonnes of iron-rod angles, said Md Bazlur Rashid, senior station officer of Bogura Fire Services and Civil Defense.

Witnesses told police that the truck driver seemed fatigued and sleepy which may have been the reason he lost control over the steering, leading to the accident.

Sub-Inspector of Shahjahanpur Police Station Shahjahan Ali said the bodies were still in hospital and yet to be handed over to family.

Of the 234 Bangladeshis in Libya, 157 were repatriated yesterday and the rest will be repatriated soon. 10 of those repatriated were sick and were seen by a doctor at the airport who prescribed them some medicines, according to the ministry.

After completing the immigration procedures around 5:00pm, they came out of the terminal in groups of threes and fours -- all of them carrying small handbags each in stark contrast to the other passengers from elsewhere who walked with trolleys full of luggage. Dadan could not say for sure on

which date he flew, but said that he reached Dubai before Ramadan last year. From there, he was flown to Turkey and then to Tripoli, the capital of Libya. "I was not charged any money

before leaving for Libya. The brokers told me that I would have to pay them TK 5 lakh once I arrive in Libya," Dadan told The Daily Star at the airport. After arriving in Tripoli, members

of a Bangladeshi trafficking gang in Libya took the new arrivals to a room with dozens of other Bangladeshis.

"The brokers asked me to call my wife and ask her to pay Tk 5 lakh. I called my wife and she paid the money," Dadan said.

As soon as the money was paid, he said, he was handed over to a group of banned travel of Bangladeshi workers Libyans, who began to torture him. "They used to beat me and

demanded money. They even made

me call my wife to [let her know the extent of how I was tortured. "After a few days, my father died. I told them about it but they said it was

a normal matter and did not bother to release me." After a few weeks, his wife managed Tk 3 lakh and paid it to the mem-

bers of the gang in Bangladesh. Asked how his wife managed money, he said he had no idea.
