# Classrooms or godowns!

Academic activities at Gar Dharmapal Government Primary School in Jaldhaka upazila have been seriously hampered for the last two months as the school authorities have been using all the classrooms as 'godowns' to store bricks, corrugated iron sheets and rods.

The construction materials have been kept there for building a concrete academic building and due to this, students have been attending classes in the school veranda amid odd situation.

Students and guardians said the authorities concerned have been using the classrooms as godowns as they do not want to spend money for a makeshift shed to store construction materials and a guard to look after them as well.

Headmaster Mosharaf Hossain said a two storied academic building is being built under primary education development programme-3 replacing old, semi pucca and tin shed part of the school which was demolished by upazila engineering department two months ago.

The school's brick built portion with concrete roof on other side with four classrooms remain intact as before for running academic activities, he said.

"We have stored old materials of demolished infrastructure in classrooms on temporary basis to protect them from being stolen as those would be sold in auction very soon," he added.

The headmaster further added they temporarily arranged classes on school veranda and assured that classrooms would be used for study as before after the auction.

However, school authority's controversial decision triggered bitter criticism among locals.

Md Liton, a Class V student, said "While attending classes on veranda, dust carried by wind from construction site covers us which sometimes enter our eyes and cause itching."

District Primary Education Officer Osman Gani said "Classrooms in no way can be used as godowns. I've directed Jaldhaka upazila education officer to take action against the school authority and vacate the classrooms within one or two days."

## Explosives seized: 12 Habiganj BNP men sued

Police in separate drives seized bombs and explosives in Bahubal and Lakhai upazilas of Habiganj yesterday and the day before.

Masuk Ali, officer-in-charge (OC) of Bahubal Police Station, said on secret information, they raided Mirpur area on Wednesday night and seized six crude bombs and six petrol bombs from a secluded place.

Police suspect that a certain quarter had hidden these explosives there with plans to conduct sabotage.

Meanwhile, Lakhai police seized 22 crude bombs, two petrol bombs and one box of gunpowder from Bulla Bazar area early yesterday.

Informed that a gang was planning to conduct subversive activities in the area, a police team raided there and seized the bombs and explosives.

However, the criminals managed to flee the scene, sensing the presence of the law enforcers, said OC Emran Hossain of Lakhai Police Station.

Sub-Inspector Abul Bashar of the police station later filed a case against upazila unit BNP General Secretary Abdul Wadud and 11 other activists in connection with the incident.

OC Emran said initial investigation has revealed a BNP faction stored the explosives and planned to conduct acts of sabotage.

## Girls show 'red card' to child marriage

Hundreds of students of Chunarughat Pilot Girls High School yesterday showed red cards to early marriage, declaring the educational institution in Habiganj's Chunarughat upazila free from early marriage.

During the programme, organised on the school premises, about 500 students of the institution held up red cards for five minutes and took an oath to keep the school free from early marriage.

Chunarughat Assistant Commissioner (Land) Tahmina Akther, who attended the function as the chief guest, administered the oath.

The chief guest, while speaking on the occasion, said the institution has become a part of history as it is a biggest promise to say 'No' to early marriage.

Headmaster of the school Satyendra Chandra said they have been working hard for the last few years to keep the school free from early marriage.

## PABNA COLLEGE GIRL MUKTI MURDER Two more arrested, main accused still at large

Police in a drive on Wednesday arrested two more accused in connection with the case filed for killing college girl Mukti Khatun, who was set on fire in Santhia upazila, from Sirajganj's Ullapara upazila.

The arrestees are Md Jahedul Islam, 55, one of the masterminds of the brutal killing, and his son Jibon Hossain, 30.

With the recent arrest, the number of arrestees in the case rose to 26 although the prime accused in the case Awami League (AL) leader Abdus

Salam is still at large.

Officer-in-Charge (OC) of Santhia Police Station Jahangir Hossain said, after tracking mobile phone location, they raided Rajman Dahpara area in Ullapara upazila of Sirajganj and detained the two.

The arrestees were produced before a Pabna court yesterday that sent them to jail, the OC said.

Mukti Khatun, 22, daughter of freedom fighter Mozammel Haque of Nagdemra village and a second-year student of Philosophy department at Pabna Government Edward College, who suffered 60 percent

burns, died from her injuries at Dhaka Medical College Hospital on August 28.

Earlier, on August 19, a group of criminals, allegedly led by Abdus Salam, president of Ward No 1 AL, Nagdemra union unit, attacked Mozammel's house and set fire to Mukti after pouring petrol on her.

There had been a conflict between Mozammel and his neighbour Salam over capturing a local water body, police said, adding that both groups had clashed several times in the past and filed cases against each other.

## IBA Admission Test

### BBA 27<sup>th</sup> BATCH (SESSION 2018-2019)

BBA Admission Test (2018-19) of Institute of Business Administration (IBA), University of Dhaka will be held on Friday, November 9, 2018 from 10:00 am to 12:00 noon.

#### ELIGIBILITY

##### 1. For SSC/HSC Passed Applicants:

Students who have fulfilled the stipulated requirements for applying in different units of Dhaka University, and have passed their SSC or equivalent exam during 2013-2016 and HSC or equivalent exam in 2018 are only eligible to apply for 2018-2019 academic session. They must have a minimum 7.5 as total of SSC & HSC GPA (including the 4<sup>th</sup> subject). Candidates must secure at least 3.5 GPA in both the exams to be eligible to apply.

##### 2. For IGCSE/O-Level and IAL/GCE A-Level or Equivalent Exam Applicants:

Students who have passed IGCSE/O-level exam in at least 5 subjects (including mathematics) during 2013-2016 and IAL/GCE A-Level exam in at least 2 subjects (final result of at least one subject must have been published in 2018) are eligible to apply. Out of the 7 subjects in IGCSE/O-Level and IAL / GCE A-level, candidates should get minimum 4 B grades and 3 C grades. Among the best five grades of O-level and best two grades of A-level, no 'D' grade will be accepted.

3. No candidate is eligible to sit for this year's admission test, if he/she had appeared in any admission test of Dhaka University, including IBA in 2017 or before.

Candidates from O-level, A-level or from all other boards, outside the country have to obtain "Equivalence Certificate" from IBA, before applying.

#### SELECTION PROCEDURE

All **Bangladeshi** applicants must take the Admission Test. The test has two components: Written Assessment and Communication Test. The Written Assessment component evaluates applicant's aptitude in: Language, Mathematics, and Analytical ability. To pass in the Written Test, an applicant must obtain a minimum qualifying score in each of the above areas. For the Communication Test, applicants will be selected on the basis of their performance in the Written Assessment.

**Foreign nationals** with a score of at least 1900 out of 2400 in SAT Reasoning Test (with at least 600 in Critical Reading and Math and at least 550 in Writing) may be exempted from the Written Assessment. Also foreign nationals candidate having at least 1265 out of 1600 in SAT Reasoning Test (with at least 600 in Math and 575 in reading & writing) may be exempted from the Written Assessment, but must appear in the Communication Test.

#### HOW TO APPLY

The application is to be made **online starting from 3:00 pm, Friday, September 28, 2018 to 12:00 am Tuesday, October 23, 2018**. Application fees of Tk. 1000/- (including online processing fees & bank service charge) is to be paid **latest by Thursday, October 25, 2018 (before 3:00 pm)**. **Admit Card can be downloaded from Monday, October 29, 2018**.
