the much-anticipated Road Transport Act-2018 amid criticism over lenient punishments for deaths caused by reckless driving.

According to the new law, if anybody causes an accident by reckless and negligent driving, and kills or injures someone seriously, he would face a maximum five years' imprisonment or a fine of Tk 5 lakh or both.

However, if it is found that a driver has deliberately killed anyone or not averted a killing in a road accident, the incident will fall under either section 302 (murder) or 304 (culpable homicide) of the Penal Code, the law minister earlier said explaining the act.

The maximum punishment under section 302 of the Penal Code is the death penalty while it is life imprisonment under section 304.

Speaking at the rally, the association president said they would not accept the death penalty as drivers don't drive

On September 22, several top BNP leaders shared the stage with Dr Kamal and Badruddoza at a citizens' rally and extended full support to Jatiya Oikya Prokriya's three-point demand including formation of a polls-time neutral government.

Polling stations in Latvia opened yesterday for a general election that could propel a populist, pro-Kremlin coalition to power as the Baltic state celebrates the centenary of its birth as an independent state.

Though lauded for righting the economy, the governing centre-right coalition has lost ground, opinion polls suggest.

But with a quarter of voters still undecided according to pollsters, the election is still wide open. After casting his ballot, President

Raimonds Vejonis from the Green Party called on fellow Latvians to come to the polls, pointing to the Brexit vote as an example of what might happen if they didn't. "It shows us that we should not stay

at home and that we should express our opinions," he said. Latvia is a member of both the

eurozone and NATO, having joined the military alliance in 2004. Latvia's ethnic Russian minority

makes up about a quarter of the country's 1.9 million population and Harmony, which was formerly allied with Putin's United Russia party, is popular with them. The party has won the largest num-

ber of votes in the last three elections, and did not enter government only because it failed to attract coalition But this time could be different.

Along with fellow Baltic states

Estonia and Lithuania, Latvia declared independence in 1918 after the Tsarist Russian empire collapsed. But it was occupied by Nazi

Germany during World War II, and then by the Soviet Union for nearly
