President approves Digital Security Act

Cabinet did not discuss the bill as promised by 3 ministers; concern of journalists, rights bodies about some sections of the law ignored

President Abdul Hamid yesterday signed the Digital Security Bill into law amid widespread criticism that it curbs freedom of speech and expression and media freedom guaranteed by the constitution.

President's Press Secretary Joynal Abedin confirmed this to The Daily Star yesterday afternoon.

Termed draconian at home and abroad, the bill was passed in parliament on September 19, ignoring concerns of journalists and rights defenders and keeping a harsh provision that allows police officials to search or arrest anyone without a warrant.

The bill was sent to the president on Thursday with a number of local and international bodies requesting him to send it back to the House. TIB, ARTICLE 19, RTI Forum, Amnesty International, Ain o Salish Kendra and Human Rights Forum were among the organisations.

Article 80 of the constitution offered the president two options. He could give assent to the bill or return it to parliament with a message that the proposed law or any particular provisions be reconsidered. He also could suggest considering any amendments specified by him in the message.

But he must choose either of the options

within 15 days after the bill is presented to him. If he fails to do so within the timeframe, he shall be deemed to have signed the bill at the expiration of that period.

According to sources, the president signed the bill around noon yesterday when the weekly cabinet meeting was taking place at the Prime Minister's Office.

Nothing about the law was raised at the meeting though three ministers earlier had assured journalist leaders of placing their concerns before it. Responding to a query, Cabinet Secretary

Mohammad Shafiul Alam in his briefing at the secretariat said the cabinet meeting didn't discuss the Digital Security Act. A copy of the signed bill was sent to the

Bangladesh Government Press from the Parliament Secretariat for publishing of the gazette notification. After the cabinet meeting, chaired by

Prime Minister Sheikh Hasina, a senior minister wishing anonymity told this newspaper that the PM expressed her views at her October 3 press conference and so there was no need for any discussion regarding the law. At that press conference, Hasina said

Death penalty for yaba offenders

Says proposal for a new narcotics law with harsh penalties for producing, carrying, trading or storing the crazy drug

One could be sentenced to death for carrying, trading, storing or processing yaba weighing over five grams, according to a draft law approved in principle by the cabinet.

Death or life imprisonment could be meted out if any institution or individual supplies, patronises or invests or colludes in drug crimes, according to the proposals approved yesterday.

If a person carries, trades, stores, or processes yaba weighing less than five grams, he or she could be sentenced to five years in jail and fined, said the draft law placed at the cabinet meeting chaired by Prime Minister Sheikh Hasina at the Prime Minister's Office.

About 50 of the methamphetamine pills weigh five grams, according to officials of the Department of Narcotics Control.

Huda has finally moved to end his "go alone" policy that used to leave the four other election commissioners in the dark while running the EC.

The move came on October 2 when the Election Commission Secretariat in an office order said there were deviations from rules and regulations in running the activities of the EC secretariat and the four commissioners noticed that. The EC directed the authorities to run the secretariat's activities in line with the rules and regulations, the order added.

Before the issuance of the order, the CEC on the same day had invited the commissioners to tea at his office room.

Sources at the EC have confirmed The Daily Star the issuance of the order.

Distance had been growing between Huda and other commissioners over the former's "unilateral decisions" on different important activities.

Winners must not commissioners take all: Juktofront

Discusses the issue, other proposals with BNP

Juktofront, a platform of three political parties that played a crucial role in forging "greater national unity", wants a sweeping change in the current winner-take- all system in politics.

It wants to offer the opposition parties some crucial posts like the ones of deputy prime minister, deputy speaker and at least half of the heads of parliamentary bodies, empowering them with effective roles in cabinet and parliament, according to proposals drafted by the platform.

The proposals would be finalised in consultation with leaders of the BNP, an important component of the "greater national unity". And those would be turned into electoral pledges of the platform in the upcoming parliamentary election, sources at the platform said.

The platform may be named as "Jatiya Juktofront" as decided in principle by senior leaders of BNP, Juktofront and Gonoforum-led by Dr Kamal Hossain at a meeting on Sunday night.

If voted to power in next election, Juktofront leaders said, they would bring major amendments

to the constitution to implement those proposals to ensure effective "check and balance" in state power.

"We have to go ahead with these proposals to build a democratic country," Mahmudur Rahman Manna, spokesperson for Juktofront, told The Daily Star yesterday.

Manna, also convenor of Nagorik Oikya, said a functional democracy is not possible if those rational proposals are not honoured.

On Sunday afternoon, Khulna jail received the copy of a High Court order that one Obaid Ali be released from death row because the court had found him innocent.

There was one problem though: Ali had passed away that very same morning after a long battle against colon cancer.

Ali's story, however, is not one about tragic timing; rather it is about bureaucratic red-tape.

for truck strike Truckers relax work abstention after meeting with home minister

Truck-owners and drivers continued their work abstention for the second day yesterday, dealing a blow to businesses and affecting the supply chain of goods to the capital.

No trucks left Dhaka yesterday while many from different districts remained off the streets, transport leaders said.

Faruque Hassan, vice-president of Bangladesh Garment Manufacturers and Exporters Association (BGMEA), said they had been suffering because of the strike and the impact would increase unless the strike was withdrawn immediately.

"We are having problems already. We are not getting trucks for transporting our products meant for export and import," he told The Daily Star yesterday.

However, leaders of truck owners and workers last night decided to relax their indefinite work abstention and agreed to carry garments products and perishables. They took the decision following a meeting with Home

Minister Asaduzzaman Khan at his Dhanmondi residence
