# Hilsa netting rampant

### Manikganj, Munshiganj fishermen defy ban in Padma, Meghna and Jamuna

Catching of hilsa fish has continued in different areas of the Jamuna, Padma and Meghna rivers in Manikganj and Munshiganj during the ongoing government ban from October 7 to 28, meant for helping safe breeding of the popular

A good number of fishermen are catching hilsa fish in the Padma and Jamuna rivers in Manikganj as some local influential people are allegedly giving them support in exchange of huge money, reports our Manikganj correspondent Zahangir Shah.


Mostly the fishermen in the char areas in the three upazilas are catching hilsa from the river areas stretching about 60 kilometres along Daulatpur, Shivalaya and Harirampur upazilas of Manikganj.

According to locals, 500 to 600 boats are being used to net hilsa in those areas with the support of local influential political leaders and public representatives. During an investigation by this corre-

spondent, locals said an influential leader of Shibalaya upazila Awami League gave permission' to 20 fishermen to catch hilsa in exchange of Tk 4 lakh five days ago.

As per the arrangement, the hilsa catchers will be warned on mobile phones when the leader receives the news of the operation by any mobile court.

Besides, the fishermen were assured of getting relieved by giving small amounts as fine.



Under a 'contact' between 30 fishermen of Madhyanagar area and an influential Jubo League leader of Shivalaya upazila, every boat will give Tk 1,000 per day to the leader.

"During the operation, about 50 boats were destroyed and two lakh cubic metres of nets were burnt on Friday. Nearly 500 kg of

hilsa was seized in last two days," Shivalaya Upazila Fisheries Officer Rafiqul Alam said.

Shivalaya Upazila Nirbahi Officer Mehedi Hasan said 38 fishermen were punished for catching hilsa.

"We are continuously running operation to stop hilsa fishing, although there are not adequate manpower and vessels to take effective steps to stop hilsa fishing in the vast areas of the rivers in three upazilas," said District Fisheries Officer Dr Md Muniruzzaman. Mirza adds: Frequent operations by mobile courts seem futile to stop illegal catching of hilsa in the Padma and Meghna rivers flowing by the district as a large number of fishermen have continued the callous act during the ongoing ban period. "On Friday, we conducted a massive

drive in remote Bakchar area of Sadar upazila with the help of police and Ansar. There we seized one lakh metres of banned current nets and destroyed it later," said Sadar Upazila Fisheries Officer Md Nasir Uddin. "The government has allocated rice for

3,671 hilsa fishermen in the district to help them during the ban on catching hilsa. Each fisherman will get 20 kg of rice. We have also decided that all the local fishing boats will be kept under the custody of Adhara Union Parishad Chairman Kabir Master from today [Saturday]. Those will be returned to the fishermen when the ban period ends," he said.

## Accused killed in gunfight

A youth, accused in the case for killing a Jubo League activist, was killed in a gunfight between two groups of criminals at Abdul Gafur Academy in Old Kasba area of Jashore town early yesterday.

The deceased was Taijul Islam, 36, son of Hafizur Rahman of Khuldanga area of the town.

Md Apurbo Hasan, officer-in-charge of Jashore Kotowali Police Station, said informed that a gunfight ensued between two criminal groups, they raided the area around 2:00am.

Sensing the presence of the law enforcers, the criminals fled away.

Later, police recovered the body of Taijul with bullet injuries. He was accused in seven cases, including one for the murder of Jubo Leage activist Sohag.

On September 28, criminals killed Sohag with sharp weapons in the town, said the OC.

## Cops rescue girl from Dhaka

A seventh grader madrasa girl was rescued from Mugda in Dhaka on October 11 after over one month of her abduction from Chanpura village in Dashmina upazila of the district. The girl was brought to Patuakhali yesterday,

Superintendent of Police (SP) Mainul Hasan said while briefing the local journalists at his office. The victim, aged about 14 and student of a local madrasa, was

allegedly abducted on September 8 on the way to her institution. Victim's father Saiful Islam filed a general diary with

Dashmina Police Station in this regard the following day and he filed a case on October 6 after the police failed to tree the girl. During investigation, police learnt that in the meantime

a kabiraj (herbal medicine practitioner) named Harun of

the same village left the area and they started looking for him, said Mainul. Meanwhile, police launched drives in several districts including Rajbari, Faridpur and Madaripur, but in vain. Finally, they were able to locate Harun at Mugda in Dhaka and rescued the girl from his residence, the SP added. The

Harun told police that he took the girl to his Dhaka residence for taking care of his pregnant wife.

A government primary school in Charbhadrasan upazila has been holding classes under the open sky as the schoolhouse was washed away by the Padma river on August 13.

Fajal Kha Dangi Government Primary School was established in 1988 on 33 decimals of land in Fajal Kha Dangi village. A brick building was constructed in 1993, which was eroded by the Padma on August 13 this year. The school was then shifted to Shamsuddin Mollah's house in the

village on August 28. "Our school building was washed Shamuddin said. away on August 13, and our higher

The authorities told us they would build a tin-shed for us within seven days, but we have been holding classes here for nearly one-and-a-half- classes in the open when it rains or months," said Headmaster Rebeka when it is too hot. Sultana.

"The house which Shamuddin gave us is not big enough for our 97 students, so we are holding classes under the open sky," Rebeka added.

"The school authorities told me that they needed my old house for seven days. Although a month-and-ahalf has passed, they have not released my house. As a result, my family members are facing problems,"

Mim Akter, a Class V student, said authorities moved the school to they are suffering as their classes are Shamuddin's house on August 28. held under the open sky because they

have no school building. Sahadat Hossain, a student of the same class, said they cannot attend

"The final examination will be held within two months, but the students cannot attend classes due to the rain and scorching heat. They also fall sick due to the heat," said Rubina Begum, mother of a Class III student.

"We selected a new place for the school, but that was also washed away by the river. Now we are searching for another place. We shall shift the school after building a new schoolhouse," said Charbhadrasan Upazila Education Officer Ashraful Haque.

## 112 BNP-Jamaat men sued: Nine arrested

Police in separate drives detained nine people belonging to BNP and Jamaat-e-Islami from Tangail and Mymensingh yesterday and on Friday while sued another 112 in Mymensingh and Jashore.

Our Tangail correspondent reported that law enforcers arrested seven leaders and activists of BNP and Jamaat-e-Islami from Basail upazila early yesterday and on Friday night.

The arrestees are Basail upazila unit Jamaat Ameer Afzal Hossain, its Organising Secretary Kabir Khansur, former president of Kanchanpur union unit BNP Ramzan Ali, former senior vice-president of Kashil union unit BNP Nurul Islam and BNP activists Aman Miah and Hossain Jamadar.

Officer-in-Charge of Basail Police Station Anisur Rahman said they detained the BNP-Jamaat men while they were holding a clandestine meeting for conducting subversive activities in the area.

Away in Mymensingh, Bhaluka police filed a case against 91 BNP-Jamaat men

under Special Powers Act on Friday night, reports our correspondent.

Bhaluka upazila unit BNP President Fakaruddin Ahmed Bachchu was made the prime accused in the case. Mohammad Johurul Islam, sub-inspector of

Bhaluka Police Station, filed the case accusing 61 named and 30 other unnamed people for allegedly creating anarchy in the locality and planning to commit subversive activities, Officer-in-Charge of the police station Firoz Talukder said. Meanwhile, police arrested Sahebul

Alam Shawon, senior joint secretary of Jubo Dal's upazila unit, on Friday night and produced the arrestee before a court yesterday that sent him to jail. In Jashore, Jhikargachha police filed a case

against 21 leaders and activists of BNP and Jamaat, including former Jamaat lawmaker from Jashore-2 constituency Muhaddis Abu Sayeed, reports our Benapole correspondent.
