ASK concerned over border killings

Ain O Salish Kendra (ASK) in a press release yesterday expressed deep concern over the recent killings of Bangladeshi nationals by Indian Border Security Force (BSF) along different bordering areas of the two countries.

On Saturday, Bangladeshi citizen Rabbani, 25, was killed as BSF shot him on Kantivita border under Baliadangi upazila of Thakurgaon. The same month, on October 14, another Bangladeshi, Mamun Rashid, 30, was shot dead by BSF on Dana and Lobha border in Kanaighat of Sylhet, ASK said.

Such continuous killings by BSF, despite their repetitive assurance of discontinuing the use of firearms on the border, are regrettable and a violation of international rules, ASK said, hoping that the Bangladesh government will take a tough stance against the killings of Bangladeshi nationals and create diplomatic pressure on India in this regard.

Form sexual harassment cell at media outlets Fair playing foul

Women journalists suggest

Every media outlets should establish a code of conduct and sexual harassment cell, women journalists suggested at a conference yesterday.

"Women journalists experience stereotyping, unfair treatment and harassment by their male colleagues, and sometimes feel threatened and insecure about their jobs," Nasimun Ara Haque, president of Bangladesh Nari Sangbadik Kendra, said, adding that it prompts them to give up the profession.

She made the observation while speaking at the third national conference of the organisation at Press Institute of Bangladesh (PIB) on the capital's Circuit House Road.

Women journalists from across the country attended the conference, to address their professional challenges and explore opportunities for women in journalism.

The number of female journalists in both print and electronic media in the

country is less than expected, said Nasimun Ara Haque, adding that women should be appointed in the executive level and they should play a crucial role in decision-making in the newsroom.

Information Minister Hasanul Haq Inu, speaking at the programme, urged women journalists to be passionate about the profession, and to develop their own writing style.

He said women and children are most vulnerable to cyber attack, and the media has a major role to play in curbing the risk.

Veteran journalist and Bangladesh Nari Sangbadik Kendra adviser Setara Musa said back in 1960s, only a handful of women came to the profession. "It is a great accomplishment to see a houseful of female journalists today. The number will increase in coming days," she added.

Shandip Kumar Singha, additional deputy commissioner (general) of Sylhet, said the administration allotted the field as the ministry concerned permitted.

Detectives arrest five car thieves

The group of five people did not own the car they put on sale. They rented it, sedated the driver on the way, and then went on to sell it. But they ran out of luck this time -- their prospective buyers were detectives.

One of the gang members was a woman, Sharmin alias Rani, 19, of Faridpur. The others were Md Mamun, 23, of Dhaka, Md Titu, 28, of Chandpur, Shahidul Islam, 30, Pirojpur, and Ashrafur Islam, 23, of Bogra.

The detectives from Rajshahi arrested them at Elenga Filling Station in Tangail, said Superintendent of Police in Rajshahi Md Shahidullah. "Although from different districts, the five formed the gang in Dhaka for stealing private cars," he said.

The district police last month arrested a gang of eight who used to steal trucks and recovered 13 trucks from them. They also seized a private car from the gang leader Monir and learnt that he bought the car from a gang of carjackers.

"We then engaged a team of detectives to look for the gang," the SP said.

After locating the gang, the detectives asked to buy a car from them. The gang then targeted a Toyota Axio of Dhaka and rented it to go to Gazipur safari park from Savar. On the way, the driver was sedated and the car stolen. When the gang reached Tangail, they were arrested.
