## Protect civil liberties

#### Visiting US official urges Bangladesh govt

UNB, Dhaka

The United Sates has said it continues to call on the Bangladesh government to protect the civil liberties, especially the freedom of speech and freedom of

"We support freedom of expression and freedom of media everywhere, including in Bangladesh," US Principal Deputy Assistant Secretary for the Bureau of South and Central Asian Affairs Alice Wells told a press conference at a city hotel yesterday.

Sharing her country's concern over the recently-enacted Digital Security Act, Wells said obviously the digital security surrounding the social media and internet is a very serious issue around the world in terms of how to

establish reasonable safeguard. She hoped that there will be a dialogue between the government and the civil society on how to improve the legislation.

The US also urged the government to fulfill its commitment to hold "free, so. fair, credible and participatory" elections that reflect the will of the Bangladeshi people.

"With a dynamic and fast-growing economy, Bangladesh's future success will be fueled by strengthening of its democratic institutions and governing structures," she said mentioning that is why she conveyed this during her meetings in Dhaka.

Wells said they encourage the gov-

ernment of Bangladesh and the Election Commission to take all necessary steps and mentioned that it is deeply in Bangladesh's interest to have free and fair elections.

Asked about the impression that the US government is backing Dr Kamal Hossain-led initiative, Wells said they support the democratic process but not a particular party or alliance over another party.

She also laid emphasis on stronger democratic institutions.

The US principal deputy assistant secretary said they will continue their call on Myanmar to create necessary conditions for Rohingyas to return voluntarily to their former places in safety and with dignity.

"Towards that end, we continue to urge the Myanmar government to fully implement the Anan Commission recommendations, including recommendations related to access to citizenship and freedom of movement," said Wells offering their help in doing She said they also continue to call

### Fix fees for diagnostic tests within

HC orders govt body

2 months

The High Court yesterday ordered a five-member committee to fix fees of medical tests in all public and private hospitals, laboratories and diagnostic centres within next two months.

The HC bench of Justice JBM Hassan and Justice Md Khairul Alam passed the order asking the committee, formed by the health ministry, to execute its order.

The committee was formed as per "The Medical Practice Private Clinics and Laboratories (Regulation) Ordinance, 1982", and a joint secretary of the health ministry was made its convener.

"The court has set January 9 for filing a report on the progress on executing its order," advocate Bashir Ahmed, who moved a writ petition in this regard, told BSS.

One Shah Alam had filed the petition in July on behalf of Human Rights Lawyers and Securing Environment Society of Bangladesh.

Following the writ, the HC on July 24 ordered the authorities concerned to ensure open display of charts of fees for different medical services at all the private clinics, hospitals and diagnostic centres within next 15 days.

During the clash, eight vehicles were vandalised and a lorry was set on fire.

The workers said the exportoriented Swad Garments factory, where around 3,500 people worked, had been sold and it was closed on

September 21. The workers started demonstration the following day, demanding their arrears. They stopped their agitation after the factory authorities assured them of paying their dues yesterday.

As the workers did not get their dues, they started demonstration.

The workers withdrew their demonstration around 12:30pm when the Bangladesh Export Processing Zones Authority (BEPZA) on behalf of the garment factory assured them of paying their dues on November 15.

Nasrin Akter, BEPZA deputy manager (industrial relations), said the Bangladesh-Kuwait joint venture garment factory had recently been sold to a Bangladeshi company. As no agreement had yet been signed with the company over paying the workers' dues, it was not possible to pay their arrears yesterday.

Citing a notice of Miah Imdadul Haque, managing director of Swad Garments factory, the BEPZA official said the arrears would be paid on

However, this could become a serious problem for the AL if its high-ups fail to manage the potential rebel candidates and convince them to work for the party nominated runner. Things could get messy after the AL announces its nominees.

More than a dozen AL dissidents won in the last parliamentary election. One of them even beat an AL presidium member.

The party, however, did not take any disciplinary action against the rebels. "But this time the election would be a challenging one as the BNP and other parties will be running," said the AL leader.

The AL's constitution allows expulsion of leaders if they ran against party nominated candidates. But the threat of expulsion could not stop dissident candidates from contesting local government polls held in recent years.

The AL leaders said, "I think the party's nomination will be finalised in the first week of November. We will also take advantage of the provision of the RPO [Representation of the People Order] to manage dissidents."

The electoral laws allow a registered political party to nominate more than one candidate in a constituency but it has to notify the returning officer about its final pick before the last date for candidature withdrawal. The rest of the nominations then becomes invalid.

At that stage, those, whose nomination had become void, cannot run as independents since independent candidates need signatures of one percent of the constituents.

The AL leader also told The Daily Star that the leader believes AL President Sheikh Hasina would have to sit with the potential rebels to stop them from running.

Intra-party conflict also remains as a thorny issue.

In the last four years, leaders of the AL and its associate organisations got involved in conflicts that often became violent. At least 100 were killed and 8,690 injured in 634 incidents of this nature, according to Ain o Salish Kendra (ASK), a leading rights body.

Their clashes with rival parties, including the BNP, were a lot fewer during the period. At least 14 people had been killed and around 1,000 injured in 84 incidents across the country, according to ASK, which gathered data from newspaper reports and its own investigations.

Hasina at meetings with party's leaders had urged her party's grassroots level leaders several times to resolve their internal conflicts, most of which stem from bids to establish supremacy in their areas.

## Bangladeshi killed in 'BSF firing'

A Bangladeshi man was killed yesterday in what appeared to be a BSF firing near the border in Chapainawabganj's Shibganj upazila.

Indian Border Security Force, however, denied involvement in the incident.

Quoting locals, Shahadat Hossain, chairman of the upazila's Monakasha union, said Mohammad Jem, 30, a man from Parchouka village, along with others was in his crop field near Shingnagar border.

All of a sudden, BSF opened fire on them, leaving Jem seriously wounded, he said.

Jem died later around 5:00am, he

On information, Border Guard Bangladesh went to Jem's house and found his bullet-hit body there.

When the BGB communicated the BSF about the matter, the Indian side

said it did not open any fire. Lt Col Sajjad Sarwar, commanding officer of BGB Battalion-53, said it was not clear whether the man was killed in

BSF firing. "We are investigating". Shibganj police was informed

about the incident, said BGB sources.

Hamzah said the body of the ninth victim -- 33-year-old Bangladeshi man Mohamad Uzzal -- was found buried under five metres of earth near a con-

tainer yesterday. "The last container found was badly crushed and we don't rule out the possibility of finding several more bodies in the area around the con-

tainer," he said. Fair weather conditions yesterday enabled the search and rescue team to

carry out its operations. The team was digging as deep as five metres to find other victims, he added. The landslide happened at a con-

struction site at Jalan Bukit Kukus in the town of Paya Terubong, Penang. A road was being built there.

Meanwhile, civil society group Persatuan Aliran Kesedaran Negara (Aliran) yesterday called for an immediate stop to all hillslope development projects in Penang following the landslide.

"All plans that involve construction or development on hillslopes must be reviewed for workers' safety ... " Aliran

said in a statement. The NGO said it was appalled at the

loss of lives in the tragic incident. While it is unclear what exactly

happened at Bukit Kukus, the recent landslide does raise several issues.

"One is the vulnerability of construction workers who were, in this incident, migrant workers from Myanmar, Indonesia and Bangladesh," the group said.

"It highlighted the issue of their safety, especially as a stop work order in the site had been recently issued when 14 concrete beams came tumbling down.

# BNP-may-win' hope spurs race for nomination

"Many leaders believe they will easily win the polls if they are nominated by the BNP," he said, referring to the 2001 polls, in which the party won a landslide victory with many newcomers winning seats in parliament.

"This has created enthusiasm among many to seek BNP nomination."

Although the party has not formally announced whether it will join the coming polls, BNP's recent activities suggest that it will definitely join.

The party has conducted three surveys in the last few months and prepared a list of prospective MP candidates, insiders said.

In a bid to take advantage of a provision in the Representation of People Order, the BNP primarily selected three candidates from each constituency.

file for contesting the polls. Of them, one will be finalised just before the deadline for withdrawing nomination papers, party insiders added.

The laws concerned allow a registered political party to nominate

more than one candidate for each Daily Staryesterday. constituency. Before the last date of withdrawing nomination papers, the party will have to write to the returning officer picking one of the three as its nominee. The rest of the nomination papers would automatically be considered invalid.

The BNP leaders think this option would benefit their party. Even if one of the three gets dis-

qualified during scrutiny, the remaining two will stay in the race. This strategy will also help the BNP contain dissident candidates, they said. Those who will not get the final

confirmation will not be able to contest the polls as independent, because of certain restrictions.

Each of the three will be asked to one percent of the constituents.
