4 to die for killing college student

A court here yesterday sentenced four people to death and one man to rigorous imprisonment for life in a college student murder case in the district.

District and Sessions Judge Shahidul Alam Jhinuk handed down the verdict.

The death penalty awardees are Badsha Mia of Shimulia village in Shivalaya upazila, Lal Mia of Bhatirchar village in Singair upazila of Manikganj, Ajgar Chowdhury of Koshla village in Kotalipara upazila of Gopalganj and Anwar Hossain of Sangkar village in Chirirbandar upazila of Dinajpur. The lifer is Akter Hossain Jamal of

Kaliarchar-Hajirtek village under Araihajar upazila of Narayanganj. The court fined the convicts with death

penalty Tk 20,000 each and the lifer was fined Tk 50,000, in default, to serve one year more in jail.

However, Md Alam, Md Masud and Shukkur Ali of Shimulia village were acquitted as the charges brought against them could not be proved, said advocate Abdus Salam, public prosecutor (PP) of Manikganj

Death penalty awardees Badsha Mia, Lal Mia and the acquitted people were present at the court during announcement of the verdict, the PP said.

According to the case statement, Badsha Mia took his nephew Monir Hossain, a first year intermediate student of Khan Bahadur Awlad Hossain College, to Savar on September 9, 2015 in the name of giving him a job in Bangladesh Army.

Badsha demanded ransom of Tk 20 lakh from Monir's family the next day.

Badsha said he, with the help of his accomplices, killed Monir on September 10 after his family refused to pay the ransom, adding that they tied stones with the body and dumped it into the Bongshai river.

Victim's mother Maleka Begum filled a case with Manikganj Police Station on September 10.

Police arrested Badsha from Savar the same day after tracking his mobile phone. Munir's body was recovered from the river on September 13.

In hope of more compensation

Many villagers in Kalapara upazila build houses on their acquired crop lands

Instead of cultivating their farmlands, many villagers of four moujas in Dhankhali union under Kalapara upazila built hundreds of houses on their lands between May and September as the lands have been acquired for building a power plant in the union, and the compensation rate is higher for homesteads than farmlands. Patuakhali district administra-

tion acquired a total of 930.61 acres of land at four moujas in Dhankhali union to set up a 1,320 MW (660*2) Ultra-Super Critical Coal Fired Power Plant for Ashuganj Power Supply Company Limited (APSCL) to generate 1,320 MW from two units at Dhankhali union. Of the lands, 289.31 acres are in

Devpur mouja, 201.78 acres in Pachjunia, 24.55 acres in Chalitabunia and 415.01 acres in Dhankhali, said Additional Deputy Commissioner (ADC revenue) Md Mamunur Rashid.

Of the lands, 15.37 acres will be used to set up rehabilitation sites for those whose lands have been acquired, he added.

Patuakhali district administration served notices early this year to land owners to inform them about the matter. Land owners then started building new houses on their farmlands as the rate for homestead is higher than for land.

APSCL Executive Engineer Md Ashraf, refuted the allegation and said they were not involved in influencing local people to build new houses on agricultural land. Those whose lands were

acquired will get compensation as

per the rate fixed by Kalapara upazila sub-registry office under classification like agricultural, residential, non-agricultural and commercial land, he said. Rate of compensation will be fixed after a joint investigation by Patuakhali district administration

and APSCL authorities, and there is no chance for anyone to influence the decision, he said. "I have informed the Patuakhali

Deputy Commissioner and also the higher authorities of APSCL about the matter," he added. ADC (revenue) Md Mamunur

Rashid said they had heard about the matter. Those who built new houses on agricultural land to get more compensation will not get it as compensation will be fixed after joint investigation by Patuakhali district administration and APSCI authorities.

"Steps will be taken against anyone who influences the villagers to build new houses," he said.

WHATIS AND WHAT CAN BE According to three consecutive years worth of data since 2014 of the existing burn unit, the yearly death toll stood at around 12 percent of admitted patients. More lives could be saved if only the spread of infections on burn patients can be prevented, according to DMCH

sources. Acknowledging infection ment. as the cause of death for many burn patients, Samanta Lal Sen, national coordinator of burn Sheikh Hasina National Institute of Burn and Plastic

Patients having to use the floor space during treatment, like Anjuara and Abdullah, also involuntarily contribute to the spread of infections.

Among other factors, the hospital has only eight regular fourth-class staff members against the requirement of at least 300 to cater to patients admitted. Sixty-eight irregular "staff members" have been providing services in exchange for tips from patients' families.

This gap between the number of patients and hospital workers is filled by the patients' attendants. And so, the authorities' hands remain tied in regard to limiting visitors' move-

structure of 6.5 lakh square feet and modern equipment, Sheikh Hasina National Institute of Burn and Plastic Surgery institute will provide services that have not even been thought of until now, like supplying skin from a skin bank, which, Sen said, would solve the present problem of shortage of skin when skin grafts are required. It would also have 10 modular operating theatres to contain infections.

"We will be able to reattach severed limbs if a patient is rushed to the institute within six hours after an incident," Sen said, adding that a helipad was there to fly in emergency patients.

More concerns regarding the DMCH burn unit arose when an oxygen leak at an operation theatre, on Sunday, compelled the authorities to stop opera-

tions for a day because the nician to fix the problem, a hospital source said.

The unit lacked manpower, especially fourthclass support staff, since its inception in December 2003, and has been depending mostly on irregular "staff members" who learnt everything "on the job", including complicated procedure like dressing.

"The new building and equipment, costing Tk 912 crore according to the design, will not bring significant changes for burn patients unless we get skilled manpower," Partha Sankar Paul, resident surgeon of the DMCH burn unit.

However, an estimate of 2,100 staffers, including doctors, nurses, technicians, ward boys and administration staff members, have been allocated to the new institute's authority.
