Over 34 lakh cases pending in courts

Law minister tells JS STAFF CORRESPONDENT

More than 34 lakh cases are now pending with the higher and lower courts across the country, according to statistics placed by Law Minister Anisul Huq in the parliament yester-

"The total number of the cases pending with the country's higher and lower courts is 34,53,353," he said, in reply to a question from treasury bench MP M Abdul Latif.

He also said the government has taken effective measures for quick disposal of the huge number of cases.

Anisul said the present government has brought marked changes in the civil and criminal judicial systems after returning to power.

In reply to another question from Awami League MP AKM Jahangir Hossain from Patuakhali-3, the law minister said the number of cases pending with the High Court is 4,95,415, while that with the Appellate Division of the Supreme Court is 19,493.

TRANSPORT WORKERS' STRIKE Lawmaker demands

home minister's statement in House

A member of parliament from Jatiya Party yesterday demanded that the Home Minister give a statement in the parliament on countrywide anarchy and commuter's harassment during the ongoing nationwide strike of transport workers.

"A child died in an ambulance in greater Sylhet as transport workers during their strike [on Sunday] held the vehicle for around an hour and a half," JP MP Pir Fazlur Rahman said.

He also said transport workers are creating an anarchic situation in the country in the name of transport strike.

What was worse, the transport workers even smeared used engine oil on the faces of drivers and passengers on the road, trying to humiliate them.

The opposition MP also said the police and the home minister's inaction against the transport workers hurt everyone.

JSC and JDC examinations to begin on Nov 1

Over 26 lakh students to sit for exams this year

Over 26 lakh eighth graders will sit for Junior School Certificate (JSC) and Junior Dakhil Certificate (JDC) examinations on November 1 amid government's various measures to prevent question leak.

Closing down all coaching centres till the end of the exams, opening sealed packets containing question papers 25 minutes prior to the test, and banning mobile phone, smartwatch, digital pen and any digital device within 200 metres of the exam centres are some of the steps taken to ensure that the examinations are held in a free and fair manner.

He requested the guardians not to put pressure on their children over the exams.

ZIA CHARITABLE TRUST GRAFT CASE VERDICT BNP to stage demos

BNP will stage demonstrations in all metropolitan cities and district towns today, protesting a Dhaka court verdict which awarded the party's Chairperson Khaleda Zia seven years of rigorous imprisonment.

The verdict was passed illegally to keep the BNP chairperson out of politics and elections, BNP Secretary General Mirza Fakhrul Islam Alamgir told journalists at a press briefing at the party's Nayapaltan headquarters yesterday. Terming the verdict "dictated", Fakhrul alleged that

Khaleda has been convicted as per the government's "desire" to keep her away from the next general election.

"Khaleda Zia has been convicted illegally without any document and witness in a fabricated case, out of political vengeance to keep her away from politics. The dictated verdict was given so that she [Khaleda] can't take part in the

upcoming election," the BNP leader said. He alleged that the government's wish and the ministers'

remarks about the case have been reflected in the verdict. Fakhrul questioned the validity of the verdict, as it was given in absence of an ailing Khaleda Zia.

ately after the accident. Chairperson of the department Prof Mostofa Nazmul Mansur and the victim's family may Tamal said Pranto was denied admission at Medinova Diagnostic Centre. Then he was taken to Japan Bangladesh Friendship Hospital and Bangladesh Medical College Hospital, but both referred him elsewhere. "He was denied proper care at the hospitals. They showed negligence," he said.

Pranto was eventually taken to Dhaka Medical College Hospital where he was declared dead.

Quoting the on-duty doctor, Prof Tamal said Pranto "died due to excessive bleeding". "It's not a normal death. It's simply a kill-

ing. The negligence of the developer company and the hospitals are to blame for this killing."

The university administration jointly sue the developer company and the hospitals soon, said Prof Tamal.

Earlier, more than 250 teachers and students took part in a mourning procession parading the campus streets.

Meanwhile, Bangladesh Chhatra Union, Sangskritik Jote, and Chhatra Front expressed solidarity with the demands raised at the press conference, while Meherpur District Students Association formed a human chain at the university's Central Shaheed Minar.
