

School runs with only three teachers

Academic activities at Noldogi Government Primary School in Laxmipur Sadar upazila are being seriously hampered as the school has been running with only three teachers for long.

Due to the shortage of assistant teachers, about 308 students of the institution are being deprived of proper education.

Moreover, classes are being held at three classrooms and the institution has only 40 benches for its 308 students.

Alongside teachers' crisis, the primary school in Kushakhali union has been facing

other difficulties for lack of necessary infrastructures.

The school, established in 1972, was nationalised in 2014, School Managing Committee President Shafiqur Rahman said.

As the old school building became risky the authorities concerned demolished it in 2016 to pave way for a new building there.

Although a new schoolhouse is yet to be built, the contractor concerned took away a major part of the old risky building, leaving rods and beams of its lower part scattered on the school compound.

The school authorities built two tin-shed

rooms using the fund meant for mainte- acute teacher crisis and inadequate classnance of the school.

The school managing committee election was held in September 2014 and though the tenure of the previous committee expired long ago, no initiative has been taken to hold a fresh election.

Jahangir Alam, father of Class V student Rahim Ullah, said as the authorities concerned are reluctant to hold a fresh election to the school managing committee local people are losing interest in involving themselves in development activities of the institution.

Acting Headmaster Abul Kalam Azad said they have informed the authorities concerned several times in this regard but to no avail.

Substandard materials used in road work

Substandard materials are being used for making a one and a half kilometre road at a cost of Tk 80 lakh under Local Government Engineering Department (LGED) at Sreekhata village in Kaliganj upazila.

Villagers protested strongly against the substandard work and stopped the construction a week ago. They demanded use of standard materials as specified in the schedule.

Azgarul Islam, 56, a schoolteacher of Sreekhata village, alleged that the contractor used very poor quality bricks instead of first class bricks for constructing the road from Sreekhata Sonamari to Khodorpar village by 'managing' some LGED officials. "If the road is constructed with substandard materi-

als, it will be damaged immediately," said trader Nurul Islam, 50, of Sonamari village. "We are united here in the village to see construction of the road with standard materials according to the schedule, otherwise we will not allow the construction firm to restart the work," he added. Kaliganj LGED Surveyor Aynul Haque said the tender

for construction of the 1.5 km road in the village was called in November last year and contractor Abdul Hakim was given work order of Tk 80 lakh in December. Subcontractor Atoar Rahman Majhi started construction in July this year.

Hakim said Atoar got the contract using his (Hakim's) license. "I'm not responsible for this substandard work," he said.

"As the sub-contractor is a brick kiln owner, he is using

the road. The bricks used were of low quality as first class bricks were not available in the kiln at the time. "Some local people demanded illegal toll from me, but I refused to pay a single taka. So they stopped the work to take revenge," he added.

Surveyor Aynul said three letters have been served to the sub-contractor in the last two weeks, asking him to use standard materials for construction of the road.

"Departmental action will be taken if the contractor does not respond to LGED's letters within the current month," he said, refuting the allegation that LGED officials are involved with the contractor.

Mother of three gang-raped

A housewife, also mother of three, was gang-raped allegedly by some local goons in Hogladanga Hrishi Palli ares under Monirampur upazila of Jashore recently.

The 30-year-old victim, wife of a rickshaw-van puller of the village, lodged a complaint with Monirampur Police Station yesterday accusing three people, including local money lender Nazim Uddin, 41, son of Budo Sardar of the village.

The other accused are Mostafa, 42, son of late Kedar Ali Gazi, and Rezaul Islam, 36, son of late Abdul Mazid of the area.

According to the complaint, in the middle of this month the victim and her three children were staying at home while her husband was away.

At midnight, when she went out of her room to respond to the call of nature the trio forcibly dragged her to a place beside the toilet, tied her hands and legs and gang raped her.

The rapists then told her that they would rape her again if she disclosed the matter to anyone else.

The gang also threatened to kill her husband if she told him anything about the incident.

Villagers alleged that a local clique was trying to 'settle' the matter locally.

Victim's husband accompanied her to the police station yesterday afternoon after she disclosed the matter to her husband and relatives.

Local Union Parishad (UP) Chairman Bipadbhanjan Pandey said after hearing the matter yesterday he advised the victim to file a case in this regard.

"After getting complaint, I sent a police team to the area to arrest the accused," said Officer-in-Charge of Monirampur Police Station Shahidul Islam.

Too cruel, too tragic

Life seems too cruel for the ailing elderly woman, left by family over two weeks ago.

Living at the mercy of others, the hapless woman, aged around 80, is staying on the veranda of an abandoned house in old truck stand area of Aricha Ghat in Shivalaya upazila of Manikganj.

This correspondent tried to talk with her but she could not say anything clearly.

With old age complications, she is suffering from various problems including fever, diseases in mouth and blurred vision.

"I found the elderly woman on the veranda of a house of old truck stand two weeks ago. Unable to move or walk, she was lying on her own faeces and urine," said Abdur Rahman, a sweeper of the truck terminal.

Now Jabeda Begum of Nihalpur village is nursing the hapless woman. She feeds her regularly and gives her bath. She arranged pillows and kantha for her.

"The woman is getting weaker. She needs proper care and treatment," she said.

Sultana Begum of the village said, "The old woman told me that her son Mansur Ali left her here. She said her husband is Moksed Ali of Jafarganj village in Shivalaya upazila."

However, none with the names were found at the village.

Mohammad Abdul Baten, assistant director of Manikganj district office of social services department, said, "I have visited the woman and talked to her. Process is on to arrange her rehabilitation under the department. Legal action will be taken against the woman's children under Parental Supervision Act."
