The Everything But Arms (EBA) scheme has proved to be vital for the economic and social development of the country. The preferential exports from Myanmar to the EU have risen sharply from €535 million in 2015 to €1.3 billion in 2017.

The EU expressed serious concerns about the disproportionate use of Myanmar military and security forces against Rohingyas.

Over 720,000 Rohingyas fled violence in Rakhine since August last year. Last week, UN investigators said genocide against the Rohingyas was "ongoing" and that as many as 400,000 Rohingyas still remaining in Myanmar live under severe restrictions and repression.

Earlier, the US had imposed targeted sanctions against Myanmar military commanders and army units, while Australia slapped sanctions on five generals responsible for human rights violations.

HALT REPATRIATION, URGES HRW, ASEAN MPS

Human Rights Watch has demanded immediate suspension of the proposed repatriation of Rohingya starting from mid-November, arguing it would put the refugees in dire condi-

tions in Myanmar. "Myanmar's government keeps talking about returns, but it has done nothing to allay the Rohingya's fears of being returned to the same violence and oppression they fled," said HRW Refugee Rights Director Bill Frelick in a

statement yesterday. "If Bangladesh moves forward on repatriations without the UN, it will squander the international goodwill it has accrued over the past year as a host to Rohingya refugees," he said.

Bangladesh and Myanmar officials, after a meeting in Dhaka on October 31, announced a "very concrete plan"

to begin repatriations in mid-November.

The 2,000 Rohingya identified to take part in the initial returns were selected from a list of 8,032 refugees that Bangladesh presented to Myanmar in February.

In June, the UN refugee agency (UNHCR) and UN Development Programme signed a memorandum of understanding with Myanmar to facilitate the returns. They have since begun limited assessments in Rakhine, HRW said.

Yet Bangladesh and Myanmar officials did not consult with UNHCR or Rohingya refugees if they volunteer to return

"This repatriation plan is just Myanmar's latest attempt to deflect international criticism from its brutal ethnic cleansing campaign for which no one has been brought to justice," Frelick said, urging donors not to fund this "dangerous plan".

The UNHCR spokesman, Andrej Mahecic, told Voice of America: "Because we consider that conditions in Rakhine state are not yet conducive to voluntary return in the conditions of safety, dignity and sustainability, UNHCR will not, at this stage, facilitate any refugee returns to Rakhine state."

The refugee agency reported this week that it was not involved in preparation, transmission or receipt of the list (of Rohingya returnees) nor in its verification and clearing.

Meanwhile, the Association of Southeast Asian Nations Parliamentarians for Human Rights also urged Bangladesh and Myanmar

to halt the repatriation at this stage. "This is a poorly-thought plan," said Malaysian MP Charles Santiago, head of the body, reports Reuters, adding that Myanmar is not safe enough for the Rohingyas yet.

Spain prosecutors seek up to 25 yrs jail for Catalan separatists

Spanish prosecutors yesterday called for Catalan separatist leaders to be jailed for up to 25 years on charges of rebellion or misuse of public funds over last year's failed secession bid.

In a statement ahead of an upcoming Supreme Court trial, the prosecution service said it was seeking prison sentences against 12 Catalan leaders ranging from seven to 25 years, the latter jail term being sought for former Catalan vice-president Oriol Junqueras.

Prosecutors want two influential Catalan civic leaders, Jordi Sanchez and Jordi Cuixart, and former regional parliamentary speaker Carme Forcadell jailed for 17 years.

were also seeking four to 11 years jail against former regional police leaders including Catalonia's then police chief Josep Lluis Trapero, whom they also accuse of rebellion. In its statement, the prosecution service said pro-independence leaders

In a separate case, they said they

planned to use all possible means to achieve secession in October 2017, "including -- knowing that the state wouldn't accept this situation -- any violence needed to secure this criminal result." It said separatist leaders had insti-

gated "big citizen mobilisations" that represented an "intimidating force" and had also used the regional police force, with its 17,000 agents, which followed their orders.

The charge of rebellion, which implies "rising up in a violent and public manner," has caused controversy in Spain where some say the independence bid went ahead without any violence, bar that waged by Spanish police on the day of a banned independence referendum.

China challenges US to provide 'evidence' in trade secrets case

China yesterday challenged the United States to show evidence to support charges that Beijing backed a scheme by Chinese and Taiwanese companies to steal trade secrets from a US-based semiconductor firm.

US Attorney General Jeff Sessions accused the companies on Thursday of stealing an estimated \$8.75 billion worth of know-how from semiconductor giant Micron.

The Justice Department unveiled criminal charges against Chinese state-owned Fujian Jinhua Integrated Circuit Co., and United Microelectronics Corporation (UMC) of Taiwan, along with three UMC officials.

It said they conspired to steal USbased Micron's advanced designs to turn Fujian Jinhua into a major player in the global computer chip market.

"If the US side is really concerned, they should provide concrete examples that can withstand the test of evidence and facts," Chinese foreign ministry spokesman Lu Kang told a regular press briefing.

The charges were the latest in a series of cases targeting what Washington calls an ongoing Beijing programme to steal valuable US industrial and commercial secrets in order to advance the Chinese econ-

"Taken together, these cases and many others like them paint a grim picture of a country bent on stealing its way up the ladder of economic development and doing so at American expense," Sessions said.

"This behaviour is illegal. It is wrong. It is a threat to our national security. And it must stop."

US President Donald Trump has cited China's alleged theft of US technological know-how among a litany of grievances in his trade war with the Asian power. Trump and Xi spoke on the phone

about trade and other issues hours after the charges were announced, and the US leader tweeted that the pair had a "very good" conversation. Xi said he was "very happy" to talk

to Trump again and that he would like to see him at the G20 summit in Buenos Aires later this month, adding that the two countries should "push for a mutually acceptable solution to China-US economic and trade issues", according to state media. The indictment released in the US

district court in San Jose, California alleges that three former Micron employees in Taiwan -- Stephen Chen Zhengkun, He Jianting and Kenny Wang Yungming -- joined UMC in 2015 and 2016 with the express plan to hand over to the company Micron's design and manufacturing processes for specific dynamic random access memory (DRAM) semiconductors.

weapons reached Kherbari village on motorcycles, dragged the five out of their houses around 8:30pm, lined them up on the dry portion of the Brahmaputra riverbed near Bhupen Hazarika Bridge and shot them dead, according to Prashant Sagar Changmai, superintendent of police in Tinsukia district.

The assailants fled the scene taking advantage of the dark after shooting indiscriminately at people, injuring two others, he said.

The five deceased are Shyamal Biswas, 60, Ananta Biswas, 18, Abinash Biswas, 23, Subal Das, 60, and Dhananjay Namasudra, 23.

Assam Special Director General of Police Pallab Bhattacharya said, "We suspect the hand of ULFA [Independent] or some combined militant group in the incident."

However, the ULFA (Independent) issued a statement yesterday denying its involvement.

"We, the United Liberation Front of Asom [Independent], would like to make it clear that our organisation does not have any involvement in the firing incident that occurred on 1st November 2018 at Sadiya Saikhowaghat in Tinsukia district," the ULFA statement reads.

against the perpetrators. He appealed to the people to maintain peace and harmony and asked all district authorities to remain alert. Indian Home Minister Rajnath Singh also condemned the attack and

wicket haul in first-class cricket. On the other hand, another segment is more keen to bank on spinners and want to pick three spinners. Mehedi Hasan Miraz and Taijul Islam are the two sure shots, while uncapped left-arm spinner Nazmul Islam may be the third one. Apart from Nazmul and Khaled,

seam-bowling all-rounder Ariful

Haque -- picked in the Test squad to

score quick runs in the lower middle order -- is almost certain to make his Test debut and he will give the team an extra bowling option. In the batting department, Liton Das is expected to open the innings along with Imrul Kayes. Both are in good form, with Imrul striking two

centuries in the ODI series and Liton hitting his maiden ODI century in the final of the Asia Cup in September, before following it up with the country's fastest first-class double-hundred. Mominul Haque is expected to play at the specialist number three position

while young Nazmul Hossain Shanto -- who played his only Test against New Zealand last year -- is likely to bat at number four.

Zimbabwe, on the other hand, will be looking to utilise the opportunity in the longest format since last playing a Test back in December 2017, when they were beaten within the first two days of an experimental four-day Test

against South Africa.

Turkey's chief prosecutor on Wednesday confirmed for the first time that Khashoggi was strangled as soon as he entered the consulate on October 2 as part of a planned hit, and his body was then dismembered and destroyed.

Washington Post said that "biological evidence" found in the consulate's garden indicated the body was likely disposed of near where Khashoggi was killed Saudi authorities have denied

"It is now up to the international community to bring the perpetrators to justice. Of all nations, the United States should be leading the way," Cengiz said in opinion article published in the Washington Post, The Guardian and

other media outlets yesterday. "The Trump administration has taken a position that is devoid of moral foundation," she wrote, adding that "there will be no cover-up".

The murder has strained the decades-old alliance between the United States and Saudi Arabia and tarnished the image of Crown Prince Mohammed bin Salman, the ultraconservative kingdom's de facto ruler.

US Secretary of State Mike Pompeo has indicated that sanctions would soon be imposed on the individuals responsible. "It'll take us probably a handful

more weeks before we have enough evidence to actually put those sanctions in place, but I think we'll be able to get there," he said on Thursday, adding that President Donald Trump had vowed accountability for all involved in the "heinous crime".

Trump has called the affair "one of the worst cover-ups in history", but who waited outside the consulate as warned halting a Saudi arms deal the journalist entered to obtain docuwould harm US jobs.
