Pregnant woman beaten dead

A pregnant housewife was beaten to death allegedly by her husband's younger brother at Muriaruk village under Lakhai upazila of Habiganj on Sunday evening.

The victim was Mansura Akhter Sumi, 20, daughter of Shofil Mia of Dewan Bari of the same village.

"Police recovered the body last night and detained the victim's mother-in-law for interrogation. The alleged murderer, Burhan Uddin went into hiding," said Sub-inspector (SI) Razib Ahmed of Lakhai Police Station.

"Police also seized the cleaver, apparently with which the victim had been hit, and blood-stained clothes from the spot. The body, bearing multiple injury marks, has been sent to the hospital for autopsy," he said.

"During primary interrogation, Burhan's mother admitted that her son committed the murder. Preparations are on to file a case in this connection," said Emran Hosain, officer-in-charge of the police station.

"My daughter Sumi married Abdur Rashid Liton three years ago. Afterwards Liton's younger brother Burhan Uddin gave illicit proposal to Sumi, which she rejected," said Shofil Mia.

As Burhan repeated the proposal on different occasions, Sumi told it to her husband. Last week, Liton asked Burhan not to disturb his wife. On Sunday afternoon when Liton was outside, Burhan engaged in a heated exchange with Sumi over the matter. He beat her mercilessly and lastly hit her with a cleaver on the head and fled away," said Shofil.

Locals admitted Sumi to Habiganj Sadar Hospital from where she was referred to Sylhet MAG Osmani Medical College Hospital but she died on the way.

A cattle market has been sitting every Sunday on the ground of a high school in Ghatail upazila for the last three decades, hampering classes and sports activities of the institution and creating health hazards due to cow dung and foul smell.

Around 700 students of Hasan Ali Public High School at Kadamtali have been facing various problems while attending classes or using the ground for playing games due to the market.

The school was established beside Tangail-Mymensingh Road in 1972 and the

"It is tough to sit in the classroom due to the bad smell of the cattle wastes," said Sanwar Hossain Sunny, a Class X student of the school.

"Traffic jam is created on Tangail-Mymensingh Road on market day due to loading and unloading of cattle from the trucks parked beside the busy road," said Liton Miah, a driver of a bus on the route.

Headmaster of the school Mohammad Ali Jinnah said local people have been conducting the cattle market since it was started. "A petition was submitted to the deputy commissioner in 2015 for removing the cattle market, but nothing was done in this regard," he added.

Ghatail Upazila Nirbahi Officer Dilruba Ahmed said necessary steps will be taken in this regard after talking with all concerned.

Mysterious death of cattle farm owner

Police recovered the body of a man, who died mysteriously at his in-laws' house, from Ghonapara area in Gopalganj's Kashiani upazila yesterday morning.

The deceased, Kazi Arif Hossain, 40, a cattle farm owner, was son of late Mujibur Kazi of Gatepara in Sadar upazila.

The law enforcers detained the deceased's wife and father-in-law for interrogation, Sub-Inspector (SI) Kashiani Police Station Faruk Hossain said.

Deceased's younger brother Kazi Galib Hossain said Arif had been living at his in-

laws' house for the last three years. After selling all his ancestral properties at Gatepara his brother started a cattle farm

near his in-laws' house, he said. Being informed by deceased's wife over mobile phone, they went to Arif's in-laws' house and found marks of injuries on the

body, Galib added. Arif's wife Keya Begum said her husband returned home with several injury marks on

his body around 1:00am. After a while Arif started vomiting and at one stage, succumbed to his injuries the same night, Keya said.

People of this minority group have alleged that they were yet to receive any government aid.

"An NGO gave me Tk 10,000 after my father was murdered that day. That's all I got since," said Josna Tudu, 32.
