"We will absolutely not abide by such sanctions. We buy 10 billion cubic metres of natural gas. We cannot freeze our people in the cold."

Speaking in Japan earlier yesterday, Turkey's foreign minister said it would be dangerous to isolate Iran, adding that it was not easy for countries like Turkey and Japan to diversify energy

supplies. "We do not believe any result can be reached with sanctions. I think meaningful dialogue and talks are more useful than sanctions," Mevlut Cavusoglu said.

US President Donald Trump aims to hit Iran's economy and force it to abandon not only its nuclear ambitions and ballistic missile programme but also its support for militant proxies in Syria, Yemen, Lebanon and other parts of the Middle East.

# Faridpur road in bad shape

The people of 50 villages under three unions of Boalmari upazila have been suffering for one and a half years as a 400-metre section of the Satair Bazar-Alankhali road in Satair Bazar area has been in awful condition for long.

Locals said the 7-kilometre-long and 3.66 metre wide road is under Boalmri upazila Local Government Engineering Department (LGED).

Thousands of people, including students, of Satair, Ghoshpur and Moyna unions use the road every day, facing serious problems due to the damaged section. The suffering is beyond description when they need to take a critical patient to district headquarters, locals said.

Apart from the people of the three unions, some people of Magura and Jashore use the road as a shortcut to go Faridpur, they said. It has become almost unfit for vehicular movement due to lack of repair

or renovation for long, they added. Khan Jahidul Islam, a trader in Satair Bazar area said people who come to the bazar on haat days have to suffer a lot due to the dilapidated road.

Rickshaw-van puller Zafar Sheikh said accidents occur regularly when they cross that portion of the road as the rainwater stays there for a long time. Satair Bazar Managing Committee Secretary General Abu Zafar Siddiki said they told the engineer of Boalmari upazila LGED several times to repair the road, but no steps have been taken yet.

"We repaired this road two years ago but it was damaged again as there is no drainage system in Satair Bazar and the rainwater remains stagnant on the road," said Boalmari LGED Engineer Rafiqul Islam.

## PUST closed sine die

The authorities suspend 10 students for movement

Pabna University of Science and Technology (PUST) has been closed for an indefinite period yesterday following a students' agitation to press home their seven-point demand.

Besides, the university authority in an urgent Regent board meeting on Monday night decided to suspend 10 agitating students involved in the ongoing students' movement.

PUST authorities have decided to close the university for an indefinite period to bring the situation under control, University Proctor Dr Pretom Kumar Das said, adding that the students were asked to vacate the dormitories by Tuesday morning.

The agitating students became violent and misbehaved with the VC and some of the teachers when they went for a discussion with the stu-

dents on Monday, the proctor said. Earlier on Monday, agitating stu-nations.

dents staged a demonstration in front of the administrative building and besieged the university vicechancellor (VC), pro-VC, teachers and administrative officials to press home their seven-point demand, including removing semester drop system. Meanwhile, the agitating students

yesterday held a protest rally before leaving the campus and gave ultimatum to meet their seven-point demand within two working days, said Faridul Islam Babu, BCL general secretary, PUST unit. Pro-VC Dr Anwarul Islam said a

committee was formed to work out a solution in this regard but it found that there is no logical ground to fulfil the students' demands.

The committee also collected ordinances of some other universities and found that there is no provision anywhere in Bangladesh to promote the students it they do not pass their exami-

accept the amended charter. He submitted the application to the Dispatch Section of the EC Secretariat.

Interestingly, Mozammel didn't give the EC time to address his plea. He hurriedly moved to the HC the next day and filed the writ petition seeking its directives on the EC.

In its order, HC asked some high-ups of the EC, the LGRD ministry and the BNP to explain within four weeks why the deletion of the provision in the party charter, which restricted a person convicted of corruption from holding party positions, will not be declared illegal as the changes violate article 66(2) (d) of the country's constitution.

The article says, "A person shall be disqualified for election as, or for being, a member of parliament who has been, on conviction for a criminal offence involving moral turpitude, sentenced to imprisonment for a term of not less than two years, unless a period

of five years has elapsed since his release." The court also asked the commission to dispose of the plea within a month and issued a rule questioning the legality of the

changes in the BNP charter. Talking to this correspondent last week at his office, Election Commissioner Rafiqul Islam had said the commission would sit in a meeting to discuss the issue.

Election Commission Secretary Helal Uddin Ahmed recently told The Daily Star that the EC had received the directive and would take its next course of action in line with the order.

Following the HC directive, the BNP faces fresh troubles over its top leadership as the order triggered a debate on whether Khaleda Zia and her son Tarique Rahman can remain the party's chairperson and senior vice chairman respectively as they have been convicted and sentenced in corruption cases.
