## 301 women and children victims of violence in Oct Says Mahila Parishad STAFF CORRESPONDENT

At least 301 women and children faced various types of violence, including rape, murder and sexual assault in October, according to a report of Bangladesh Mahila Parishad (BMP).

The women rights organisation unveiled the report though a press statement yesterday.

Of the victims, 48 were raped, 17 gang-raped and seven were killed after rape across the country, bringing the total number of rape victims to 72 in the month, reads the report. At least 47 were killed while 27 faced unnatural deaths; 21 committed suicide; 13 were abducted and 25 were victims of physical torture, it adds.

BMP's legal aid subcouncil prepared the report, on the basis of news published in 14 national dailies.

As part of their programmes, senior BNP leaders, led by party Secretary General Mirza Fakhrul Islam Alamgir, and party activists placed a wreath at Zia's grave at Sher-e-Bangla

Nagar in the capital around 10:00am. They also offered prayers, seeking salvation of Zia's departed soul.

BNP standing committee members Khandaker Mosharraf Hossain, Moudud Ahmed, Dr Abdul Moyeen Khan, and Nazrul Islam Khan; vice-chairmen Altaf Hossain Chowdhury, Shahjahan Omar, Mohammad Shahjahan, Inam Ahmed Chowdhury and AZM Zahid Hossain; chairperson's advisers Amanullah Aman, Zainul Abedin Farroque and Habibur Rahman Habib; joint secretaries general Mahbubuddin Khokan and Khairul Kabir Khokon were present, among others.

Leaders and activists of different units and associate bodies of the party also laid wreaths at its founder's grave on

the occasion. While BNP celebrates November 7 as the National Revolution and Solidarity Day, the ruling Awami League and its front organisations consider it as the day of "killing

of freedom fighters". Amid political turmoil, soldiers and civilians jointly freed then chief of army staff Ziaur Rahman from captivity in Dhaka cantonment on November 7, 1975, paving the way for Zia to come to power.

Humayun Kabir, inspector of Barishal Metropolitan Court, said, "Police cannot prepare final reports of unnatural death cases, while the court cannot start trial process due to unavailability of forensic reports."

Superintendent of Police (SP) of Barishal Saifur Rahman said, "I contacted the medical college authority several times requesting them to form a board, but to no

He said they have at least 25 cases pending due to unavailability of the reports.

In addition, 69 cases are pending with different police stations in the metropolitan area, said BMP Commissioner Mosharraf Hossen, adding that justice seekers may misunderstand police for the delay, but "we cannot prepare charge sheets without forensic reports."

Prof Huda said, "There are two ways to solve the problem the ministry can give me the authority to sign the reports or appoint a professor to the department.

When asked, Principal of the medical college Prof Vashkar Saha said, "I repeatedly contacted the health ministry on the issue but have not got any reply."

He also said, "I have formed a committee; it will start releasing old reports within some days, but it's not a permanent solution."

He had sent Tk 3,000 and they stopped torturing him, he added.

Partha Kumar Banik, superintendent of Chattogram Central Jail, brushed aside the allegations of irregularities in the prison.

"There is no anomaly in food, medical and accommodation," he said.

"There were lots of allegation against arrested jailer Sohel but the situation is different now," he added.

# JU teachers scuffle A father's as syndicate meets

Two factions of Awami League-backed teachers in Jahangirnagar University yesterday locked in a scuffle at the vice-chancellor's office, centring a syndicate meeting.

The scuffle between supporters and opponents of VC Prof Farzana Islam broke out when syndicate member Motaher Hossain Mollah, also president of Bangladesh Krishak League, came to join the meeting. He was barred by the anti-VC faction.

He, however, entered the meeting room with help from VC-backed teachers, and fulfilled the quorum. The anti-VC teachers allegedly assaulted the syndicate member. The syndicate meeting was underway till filing of this

report around 9:00pm. Members of the anti-VC syndicate boycotted the meeting,

claiming that the VC did not cooperate with them. Syndicate member Prof Dr Laek Sazzad Andallah said, "We requested the VC to not put the issue of fresh teacher recruit-

ment on the agenda until holding of the dean, syndicate, VC panel, and JUCSU elections. But she did not pay any heed." Meanwhile, pro-BNP teachers yesterday held a protest,

opposing any fresh recruitment at the Institute of Information Technology (IIT) and demanded immediate appointment of a new director to the institute.

He said they stopped the work at the site and asked the construction firm to fill up the pit they dug within seven days. "They have already begun filling the site with sand," he said.

Mentionable, a group of 34 physicians are erecting the 24-storey building on around 13 kathas of land. They gave the contract to Osman Ali Constructions, whose workers dug up the around 30-foot deep pit, resulting in subsidence of a six-storey building beside it on Tuesday.

Earlier, seven other witnesses including Md Jahangir gave their statements before the court.

On October 25, the trial court framed homicide charges against six accused -- drivers Masum Billah and Zobair Hossain Sumon; helpers Enayet Hossain and Kazi Asad, and owners Shahadat Hossain and Jahangir Alam. Four of the accused are now in jail while two are absconding.
