PM announces 5pc increment for teachers under MPO

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday announced "Baishakhi Festival" allowance and five percent increment for teachers and employees of non-government educational institutions under monthly pay order (MPO).

She made the announcement while distributing cheques of seed money among nine organisations and trust funds at a ceremony at the Gono Bhaban in the evening.

Nearly five lakh teachers and employees of non-government educational institutions, including schools, colleges and madrasas under the MPO, will get the increment and allowance.

An additional amount of Tk 532 crore would be spent annually on meeting the expenses of the increment, while Tk 177 crore would be required annually to provide the special allowance.

The prime minister handed over the cheques of Tk 100 crore to the trust funds and organisations.

She donated Tk 10 crore as seed money to Non-government Educational Institution Teachers-Employees Welfare Trust and Nongovernment Educational Institution Teachers-Employees Retirement Benefit Board.

'Drug trader' killed in 'gunfight' with police

A suspected drug trader was killed in a "gunfight" with police in Chuadanga's Uzalpur village early yesterday.

The deceased was identified as Abul Bashar alias Pappu, 45, son of Bazlur Rahman of Akandbaria in Chuadanga sadar upazila.

According to Officer-in-Charge of Chuadanga Sadar Police Station Delwar Hossain, the law enforcers had information that a group of drug traders carrying contraband phensidyl was entering Bangladesh territory from India through Uzalpur border.

A police team was sent to the area. When they located a group of people at Uzalpur field, police asked them to

"But the group responded by opening fire on police prompting them to retaliate. The gun-battle lasted an hour," the OC said.

Police recovered Pappu's body after the "gunfight", he claimed. The law enforcers also claimed to

have recovered a shutter gun, four crude bombs and 170 bottles of phensidyl from the spot.

The OC said Pappu was an accused in six cases -- one for murder, four for drugs-related offences and one for explosions -- filed with Chuadanga Sadar Police.

His family members admitted that Pappu was once involved in drug trade. They claimed that plainclothes men

to Rajshahi today

Jatiya Oikyafront leaders have taken preparations to bring people from neighbouring districts today to their rally in Rajshahi, amid widespread arrests and the ongoing transport strike in Natore.

Police had twice denied permission for the rally before finally announcing on Wednesday night that the event could be held at Madrasa Maidan in the city on 12 conditions.

The Oikyafront could have taken better preparation for the rally if police had not delayed the permission until the last moment, its Rajshahi coordinator Mizanur Rahman Minu told a press conference yesterday.

Several BNP leaders in the region told The Daily Star that they had to stay away from home fearing arrests.

Police raided houses of many BNP leaders and threatened their family members of arrests if they joined the

rally, Minu added. Zahidul Islam Jewel, joint convenor of Bagha upazila Jubo Dal, said, "My home was raided on Thursday

night. I can't go home even at night." Police yesterday arrested 14 BNP-Jamaat men in Rajshahi and Natore, and raided many more houses of BNP leaders and activists in Naogaon

and Chapainawabganj. The rally would be addressed by Dr Kamal Hossain, Andalib Partha,

Retd Col Oli Ahmed among others. The 12 conditions slapped include not using multimedia projectors at all and not putting loudspeakers anywhere but the venue although the devices are widely used during ruling party rallies.

The participants are also not allowed to carry banners and festoons that are glued to sticks. The organisers: were asked to hold the event between 2:00pm and 5:00pm. The activists cannot gather in or around the city

They are also asked not to deliver any speech that is "anti-state", in favour of war criminals, hurt religious sentiments and can deteriorate the law and order.

Activists began preparing the stage at Madrassa Maidan around 5:00pm yesterday.

"Let us see, how far we can prepare in a night. We are not allowed to go to the venue until 2:00pm on Friday, Minu said yesterday.

He also alleged that some members of the law enforcement agencies were tearing down the banners and posters for the rally in Kasiadanga

area of the city. He also alleged that the sudden transport strike in Natore was called for not letting people from other districts attend the rally.

He blamed the law enforcement agencies for the strike saying, "If they are not responsible, why are the lawenforcement agencies silent about the transport workers who have no specific reason for calling a strike?"

He said he expected a crowd of one lakh at the rally.

Minu also said people had no confidence on the Election

Commission. "The commission is made up of some jokers, people do not believe them."

meetings with the EC on Wednesday supported its plan to announce the schedule on November 8. Yesterday, both parties welcomed the EC announcement.

Analysts fear the political situation may get complicated further following the announcement of the schedule as major issues remain unsettled with the Oikyafront threatening to intensify agitation in the coming days if the schedule was announced without resolving the crisis.

The Oikyafront may march towards the EC tomorrow in protest at the announcement of the schedule. Top leaders of the opposition combine may announce the programme at its rally in Rajshahi city today, said alliance sources.

The opposition leaders are also protesting the ongoing police drive, arrest of opposition men and the filing of "ghost cases" against their grassroots across the country.

Oikyafront top leader Dr Kamal Hossain wrote to the EC on Saturday, requesting it not to announce the schedule until the crisis over the polls is resolved.

A team of the combine also met the CEC on Tuesday with the same plea.

The Left Democratic Alliance, a combine of eight leftist parties, also sent a letter to the CEC with the same request.

"We requested the EC not to announce the election schedule until the political parties reach a consensus on resolving the current political crisis. But the EC didn't keep our request, which squandered the opportunity to resolve the crisis," said Mujahidul Islam Selim, president of the Communist Party of Bangladesh, a component of the LDA.

"Such a move by the Election Commission is not only harmful, but also dangerous," he told The Daily Star yesterday.

Talking to this newspaper, Ali Riaz, a professor of the politics and government department at the Illinois State University in the US, said the announcement of the election schedule not only makes the situation complex but also pushes it to an unwanted direction.

"I hope the Election Commission members will understand that they will need to shoulder the responsibility for creating such a situation," he added

Announcing the polls schedule, CEC Huda hoped that a competitive election would be held with the participation of all political parties.

"On behalf of the people, I urge all political parties to help continue the democratic process and the pace of development by participating in the polls."

He requested all political parties to resolve their differences politically if there was any, and said they should remain careful so that the polls atmo-
