LG Electronics Bangladesh will recognise five social organisation/workers for their willingness and struggle to work for the welfare of the people.



...... Germany said Thursday its trade surplus narrowed in September compared to a month earlier, with exports falling more than imports at a time of high tensions in global commerce.

After calendar and seasonal effects were taken into account, the surplus stood at 17.6 billion euros for September from 18.2 billion euros in August, data from federal statistics office Destatis showed.

The narrowing surplus came as exports declined 0.8 percent compared to August, while imports dipped at a slower pace of 0.4 percent. "A combination of slowing world trade and temporary factors like the new emissions norms for autos hit the German export sector over the summer months," said Carsten Brzeski, chief economist at ING Germany.

The softening surplus also came after disappointing industrial production data published this week.

was a weak regulatory framework, another factor that made the corporate governance in the banking sector vulnerable. Domination of individual inves-

tors, limited transparency, weak disclosure and poor institutional control are some other major challenges facing the banking sector. The paper pointed out poor bankruptcy laws, a lack of share-

holder participation and political interference as significant obstacles to attaining good governance. "The power of social elites also

came to the fore in other studies, which said certain families tend to dominate bank ownership and act as an impediment to fairness, accountability and transparency."

There is now a pressing need for an independent regulatory body or commission for the banking sector of Bangladesh to prevent the repeated collusion between businesses, banks and the government, it said.

"Otherwise, most governance issues such as transparency and accountability will continue to be merely a box-ticking exercise," Saadat added.

## Govt gets keys of Bangabandhu Satellite

Raowa Convention Hall in Dhaka yesterday. The company approved 25 percent cash dividend for 2017-18.

Thales Alenia Space, a Franco-Italian aerospace manufacturer, has designed and built the satellite that has been launched into the orbit on May 11 this year.

The code and switch of the satellite will be handed over it to BCSCL in the presence of Prime Minister Sheikh Hasina within a day or two, said Haque, team leader of the Bangabandhu Satellite-1 project.

"After that the satellite can start commercial operation," he added.

State-run satellite television channel BTV has already done a number of test runs and found very good quality transmission through the satellite, said Shahjahan Mahmood, chairman of BCSCL.

"Some private television channels like Ekattor TV will move to Bangabandhu-1 within a short time," said Mahmood, who was earlier the chairman of the BTRC and led the satellite launching procedures.

Ekattor TV authority said they are seriously considering moving to the country's prestige satellite.

out some issues," said Mozammel Haque Babu, chief editor of the television station.

### Toshiba cuts 7,000 jobs

Japan's engineering giant Toshiba announced plans Thursday to slash 7,000 jobs and liquidate a unit building a UK nuclear power plant, leaving its fate in doubt.

Toshiba also expects to scrap or consolidate some factories and reduce its subsidiaries by 25 percent -announcing the withdrawal from a US-based liquid natural gas business.

The liquidation of NuGen, a nuclear subsidiary in Britain, could complicate UK efforts to shift away from polluting power plants that rely on coal, a number of which are slated to close.

### Internet penetration slows in 4G era

As a result, the number of internet users might not increase, as they would not be able to get the best out of the fast data speed offered by 4G.

"In the last few months, we have seen that the import of smartphones, especially the 4G-enabled ones, has almost halted," Alam told reporters at a workshop in Dhaka on Tuesday. The industry had asked the government to withdraw the tax on handsets for at least the next two years to help it to grow.

"This would have given a push to the government's digitalisation vision too," he said, adding that the demands were not met.

The number of internet users would not escalate if the Internet of Things and artificial intelligence technologies are not adopted, said a top official of another operator.

"Once home appliances are connected to the internet, the number will become much higher," said the senior executive, who has been working in this field for more than a decade. He also said the internet users' number was not directly linked to 4G.

4G offers the fastest mobile internet and that is related to using more data. Only 3G users have shifted to the 4G technology but it has not added new users, the official said.

### 68pc Bangladeshis pay no income tax

There are nearly 35 lakh registered taxpayers and less than 20 lakh submit returns, said Md Mosharraf Hossain Bhuiyan, chairman of the National Board of Revenue. "The number of tax return submission is increasing, but we have more to do," he added. Bangladesh's per capita income is almost

double that of Nepal's and yet the tax-GDP ratio was lower than the Himalayan nation's by 14 percentage points, said AB Mirza Azizul Islam, former finance adviser to the immediate caretaker government. To increase the income tax collection,

more attention should be paid on declaration of wealth in the tax return, said Debapriya Bhattacharya, distinguished fellow of CPD. He, however, said Bangladesh needs foreign

aid to attain its development targets. "It would not be wise to think that Bangladesh would perform better without foreign finance."

He also questioned reasons behind higher spending of foreign aid for physical infrastructure and reduced spending on

Efficiency of public investment, especially in infrastructure-related projects, is imperative, said Ragnar Gudmundsson, resident representative of the International Monetary Fund. "At present, public investment in

Bangladesh suffers from significant cost overrun," he said, adding that there is a high efficiency gap in public investment management between Bangladesh and most efficient and emerging economies. He suggested a shift towards taxation on

consumption, corporate income and personal income rather higher duties on imports. Some 1,800-1,900 firms pay more than

50 percent income tax, said Nihad Kabir, president of the Metropolitan Chamber of Commerce and Industry. She stressed on the need for expansion of

tax net and better public services so that people feel motivated to pay taxes. "If you pay taxes, you should demand services," Kabir said. Good utilisation of public resources induces

people to be compliant, said Mustafizur Rahman, distinguished fellow of CPD.
