Grassroots leaders promise to work for BNP nominees

474 aspirants from Barishal, Khulna divisions interviewed by nomination board on 2nd day

BNP grassroots leaders in Barishal and Khulna divisions promised the party's nomination board to work together for whoever is nominated.

The board told the aspirants that there were many competent candidates in every constituency but as not more than one could be nominated, everyone had to abide by the party decision, said party leaders.

On the second day of interviews of BNP aspirants, a total of 474 hopefuls from 57 constituencies of Khulna and Barishal were interviewed by the nomination board comprising of the party's standing committee members, acting chairman Tarique Rahman and Secretary General Mirza Fakhrul Islam Alamgir at its chairperson's Gulshan

The Daily Star correspondent spoke to more than a dozen aspirants, all of whom promised to work for those

nominated.

An aspirant, wishing anonymity, said former lawmaker Mujibur Rahman Sarwar and BNP leader Syed Moazzem Hossain gave interviews for Barishal-5.

"During the interview, Tarique asked Sarwar why he was not talking and Sarwar replied that he would work [for the party], no matter who got the party tickets," said a senior leader.

Akand Kuddusur Rahman, a contender of Barishal-1, said, "We have full confidence in the party high ups and hope that a competent candidate will get the party ticket."

Monir Hossain, an aspirant from Patuakhali-2, said, "We have decided to participate in the election as part of the movement to restore democracy and release Khaleda Zia. We hope that the party's top leaders will give nomination to the best

Family fights over AL ticket

Land Minister Shamsur Rahman Sherif will face challenges from his family for the party's nomination in the upcoming national polls.

His daughter, Mahjebin Shirin Pia, and son-in-law, Abul Kalam Azad Mintu, are running against him for the "boat" symbol at Pabna-4, along with 14 other aspirants.

"I have been involved with Awami League politics for many years and I have enough dedication for the party. I deserve party's nomination," Mintu, also mayor of Ishwardi municipality, told The Daily Star.

However, he said he would not run as an independent candidate if he failed to get the nomination, adding, "I will work for whoever gets the boat symbol."

Contacted, Pia refused to comment on the issue.

Meanwhile Sherif, who has been the lawmaker in that area since for the past 20 years, could not be reached over phone.

Talking to the locals, this correspondent found different versions about Sherif's performance.

As Jamaat's registration as a political party has been scrapped, the party's nominees will contest the polls either as independents or under

however, commuted the capital punishment of 11 others to life imprisonment. All the eleven had been sentenced to death by a Narayanganj court in the murder case.

The judges also upheld jail terms of nine others for various terms ranging from seven to 17 years.

The accused were found guilty of murdering seven people, including Narayanganj City Corporation panel mayor Nazrul Islam and senior lawyer Chandan Sarker. They were abducted from the Dhaka-Narayanganj link road on April 27, 2014. Later, their bodies were found floating in the Shitalakkhya river.

In the full text verdict, the HC said from the facts, circumstances, and evidence on record, it is evident that both the defence-accused personnel and civil accused-personnel conjointly under criminal conspiracy and pre-planning in furtherance of their common intention abducted the victims, killed them and dropped their bodies in the river.

"From the evidence and materials is evident from the fact that the vic- inal conspiracy abducted, murtim-deceased persons were at first kidnapped in a preplanned way out of conspiracy, then were killed by twisting their mouth with polythene and by strangulation with rope, the dead bodies were tied up with plastic sacks, containing bricks, the dead bodies were taken to the estuary of the rivers Meghna and Shitalakkhya, the dead bodies were perforated with knife under navels for easy drowning into the river water and thereafter dropped in the river water," the HC said.

"Said facts clearly suggest that as per pre-planned conspiracy and in furtherance of common guilty intention to kill the victims, they were killed by twisting their mouths with polythene and by strangulation with rope by the accused-persons and thereafter, to destroy the evidence, the dead bodies were dropped in the river water...

"To what extent the accused Nur Hossain is influential and powerful

on record, it appears that the vic- tim Nazrul did not have the courage to file a case against the accused Nur Hossain although the men of the accused Nur Hossain beat up Nazrul and his men over construction of a drain. Rather, the accused Nur Hossain got a false case filed by Mobarak, an associate of him, against Nazrul," the HC said. "From the materials on record, it

mysterious role. "I think he is under pressure for selecting party candidates and sharing seats with the ruling party," a JP lawmaker, who is also a minister in the Awami League-led government, told The Daily Star on condition of ano-

Ershad's hide-and-seek comes at a time when the seat-sharing between the ruling AL and his party still remains a contentious issue.

The JP, the main opposition in the current parliament, in the last couple of days wrote to the ruling AL twice to finalise the seat-sharing. But as of now,

it remains unresolved. Ershad demanded that the AL leave 100 out of 300 parliamentary constituencies for JP candidates to contest the polls under the banner of the grand alliance led by the ruling AL, insiders

said. But the ruling party did not agree on this creating an impasse.

Ruhul Amin Hawlader, secretary general of JP, was supposed to meet Obaidul Quader, general secretary of the AL, yesterday evening.

In the afternoon yesterday, Hawlader confirmed to The Daily Star about the planned meeting. In the evening, he said the meeting has been postponed and it will be held later.

"We are facing pressure from party

them from which parliamentary constituencies our candidates will run for

the election," he said. He said the party cannot clarify it as the ruling AL has yet to make it clear how many seats they will leave for JP leaders in the upcoming parliamentary election.

"We hope we will be able to reach an amicable solution over seat-sharing through a meeting with the ruling

party high-ups soon," Hawlader said. AL General Secretary Obaidul Quader on Sunday told newsmen that the issue of seat-sharing with the components of the grand alliance would be

decision on selection of candidates. "Therefore, they are yet to start preparatory work for election to fight

In 2006, he went into hiding facing pressure from the then ruling BNP to join its alliance. On December 18 that year, he suddenly appeared at a Paltan Maidan rally organised by AL, and announced his decision to join the ALled alliance.

Following his instructions from hiding, JP leaders and workers had joined the rally before he reached there. Senior JP leaders Kazi Zafar Ahmed, Ruhul Amin Hawlader and GM Quader, among others, were present on the dais.

Joining the rally, Ershad said he and his party had been subject to constant polls. threat and pressure for speaking out against what he said was unbridled

alliance.

"I am receiving threats that I would

be sent to jail and come out as a mere corpse," the former dictator told the rally. "But I am a soldier, I am not scared of death," he added. "I've thrown off the shackles to

express solidarity with the Awami League-led grand alliance. I'm here today, free as a bird," he said on an

He claimed he had to get over several hurdles to get to the rally "at this crucial juncture".

Ershad led his party to remain in the AL-led grand alliance to contest the 9th parliamentary election in 2008, held two years behind schedule due to the state of emergency declared amid political turmoil.

After seven years, when another parliamentary election was in the offing, Ershad became the centre piece of a long-drawn drama for his flipflops over joining the January 5 polls in 2014.

Announcing that the JP will not participate in the election, he had asked his party's candidates to withdraw their nomination papers. The BNP-led alliance and some other opposition parties also boycotted the

Giving rise to questions and confusions, he was taken to the CMH from

12, 2013. However, a section of JP leaders decided to join the polls. The party chairman was elected a lawmaker in the January 5 polls as he could not withdraw his candidacy from

Rangpur-3. From the CMH, where he had been staying for unknown "illness", Ershad directly went to the Bangabhaban to attend the oath-taking ceremony of the prime minister and ministers of the

new government on January 12, 2014. On the same day, he was appointed special envoy of the prime minister with the status of a minister. Three of his party lawmakers were inducted

into the council of ministers. Talking to reporters at the Bangabhaban after the ceremony, Ershad said: "I'm quite well." From there, he returned to the President Park with a new role.

In the wake of criticism against his party for being in the opposition and in the cabinet at the same time, Ershad on several occasions in recent years said he would ask the three party men to step down as ministers paving the way for JP to emerge as the real opposi-

But earlier this month, after talks with the AL-led 14-party alliance, the JP chief said his party will participate in the upcoming election as a compo-
