# Wärtsilä opens power plant optimisation centre

Wärtsilä has recently launched a new digital expertise centre in Dhaka, capable of synthesising and combining big data, analytics and human expertise to optimise power plant operations.

A key function of the centre is to provide real time support to customers and help them avoid and address unforeseen technical events.

It has similar centres in the US, the United Arab Emirates, Indonesia, India and Brazil, all connected to its headquarters in Finland, the technology group said in a statement yesterday.

## US durable goods orders dip to 15-month low

A steep decline in aircraft sales last month pushed orders for big-ticket, US-made goods to their largest drop in 15 months, the government reported Wednesday.

The decrease was far steeper than economists had expected and came with downward revisions to prior months. Outside the volatile aviation sector sales rose modestly.

In another sign of potential weakness, a closely watched measure that is often viewed as a proxy for business investment -orders of non defense capital goods excluding aircraft -- was flat following declines in the prior two months.

The result could weigh on GDP calculations for the final quarter of 2018.

Total orders for US durable goods unexpectedly fell 4.4 percent to \$248.5 billion, marking their third decline of the last four months, according to the Commerce

Department.

The result was the biggest drop since July of last year. Forecasts had called for a decline of only 2.6 percent.

Sales of aircraft, which see broad swings from month to month, led the decline: civilian aircraft were down 21.4 percent, adding to September's 19.3 percent drop, while military aircraft fell nearly 60 per-

Autos posted a token 0.2 percent gain.

Excluding transportation, sales rose 0.1 percent, undershooting forecasts for a 0.4 percent gain but reversing some of September's 0.6 percent decline.

Primary metals and machinery both fell for the month while communications and electrical equipment both rose.

But non-defense capital goods excluding aircraft -- a segment that can track changes in oil prices and was a target of last year's Republican driven tax cuts -- was flat for the month.

## China says it can't accept new US trade accusations

China said Thursday that it "cannot accept" Washington's latest accusations of unfair trade practises as the two economic giants exchanged barbs ahead of a key meeting between their presidents later this month.

In an update to an earlier investigation into China's trade practices, Washington on Tuesday accused Beijing of failing to change its "unfair" trade practises, and said the country "appears to have taken further unreasonable actions in recent months".

China's commerce ministry blasted the new report in a regular press conference Thursday.

"The US carried out a so-called 'update' report, making new unwarranted accusations against China, which are completely groundless and disregard the facts, China cannot accept this," said ministry spokesman Gao Feng.

seeking global industrial dominance in cutting-edge sectors like robotics and renewable energy through a variety of illicit means.

Those include stealing American intellectual property by forcing or pressuring US companies present in China to surrender it or through state-sponsored corporate acquisitions, hacking and industrial espionage as well as massive state subsidies and dumping.

Trump has enacted punishing tariffs on more than \$250 billion in imports from China, which has in turn put countertariffs on more than \$100 billion in goods China buys from the United States.

"We hope the US will stop its words and deeds that damage bilateral economic and trade ties and adopt a constructive attitude to return relations to the right track," Gao told reporters. US President Donald Trump is set to discuss the trade issues with Chinese leader Xi Jinping on the sidelines of a Group of 20 summit in Argentina, which starts on November 30.

A 164-seater Boeing 737-800 aircraft, comprising eight business class and 156 economy class seats, runs the flights, the airline said in a statement yesterday. The minimum one-way fare, including all taxes and

surcharges, has been fixed at Tk 19,999 and return fare at Tk 29,999. US-Bangla Airlines is also offering a six-month equal

monthly installment facility on a two-nights-three-days' holiday package for Guangzhou, including the Dhaka-Guangzhou air fare and accommodation at a three-star hotel with complimentary breakfast, starting at Tk 36,990 per person.

The airline also operates flights to Muscat, Doha, Singapore, Kuala Lumpur, Bangkok and Kolkata alongside on all domestic routes.

"The opportunity driven entrepreneurs tend to stay in the business for longer periods with better revenue and profit margin. That is why, they were able to make changes in their products, production processes, marketing and pricing," he said. However, insufficient capital acts as a

major constraint to entrepreneurship, he added.

The report suggested adoption of sectoral policies targeting key and potential sectors, highlighting the value chain of respective industries to facilitate entrepreneurship development.

It also stressed ensuring fair competition by proper implementation of rules

and regulations including competition policy, financial reporting of companies and company laws.

It recommended assessment of fiscal and financial incentives provided to different industries.

"A life cycle approach needs to be taken into account," Moazzem said.

Life cycle approach and development of new entrepreneurs are very important, said Distinguished Fellow at the CPD Prof Mustafizur Rahman.

"We have to switch to entrepreneurial state from developmental state. The role of state is very important," he said citing various policy support and incentives provided to the RMG industry.

### ADP spending slows as ministers busy with polls

However, the Executive Committee of the National Economic Council (Ecnec) has been on a project approval spree. At least 82 projects, involving Tk 88,782 crore, have been

approved in October. Two Ecnec meetings in the first week of the current

month had approved 67 projects involving Tk 116,921 crore. Between July and September, 75 projects, involving Tk

56,819 crore, have been okayed. On the slow ADP implementation, Planning Minister

AHM Mustafa Kamal had earlier said most of the projects were taken for roads, schools and madrasas, for which the construction materials were not available on time. The private sector does not have any automated brick

field, so it does not make the required number of bricks showing the excuse of rain, he said. "They wait for the rainy season to end to start making

bricks," he said, adding that he would advise the government to set up automated brick fields to produce bricks for public sector's construction works.

Historical data shows that the pace of the ADP implementation becomes very slow at the beginning of a fiscal year.

In June, the Finance Division empowered the project directors with the right to release the first and second quarter funds by themselves instead of waiting for approval from the ministries or divisions concerned, an exercise that eats up two to three months.

Not only the finance ministry, Kamal also met with secretaries of different ministries and divisions in early August to inform them about the government's position on speeding up implementation of development projects in the election year.

Of the total ADP, Tk 14,800 crore of the government's own fund was spent in the July-October period of 2018-19 against an allocation of Tk 113,000 crore while the implementation rate was 12.01 percent last fiscal.

Some Tk 8,360 crore was spent from foreign aid, which is 13.93 percent of the allocation.

In the current fiscal year, total foreign aid allocation was Tk 60,000 crore. In the last fiscal, the foreign aid utilisation was 18.40 percent of the total outlay for the same period.

However, this time the performance of state-owned enterprises improved: they spent Tk 1,704 crore in the first four months of the fiscal year, which is 21.66 percent of their allocation. It was only 14 percent during the same period last fiscal year.

Of the large 15 ministries and divisions whose allocation was almost 80 percent of the total ADP, performance of seven ministries and divisions hovered between 3 to 8 percent only.

These are road transport and highways division, railways ministry, bridges division, primary and mass education ministry, secondary and higher education division, water resources ministry, and posts and telecom ministry.

However, three ministries and divisions were the top performers, of which power division implemented 28.21 percent, local government division 20.86 percent and power and mineral resources division 33.87 percent.
