







Khaleda's polls hope dashed

Latest development at SC means she's ineligible to contest; BNP fields back-up candidates for her 3 seats

BNP Chairperson Khaleda Zia cannot contest the upcoming parliamentary election as the Supreme Court yesterday upheld the High Court ruling barring a person sentenced to more than two years in jail from taking part in elections even if an appeal against the conviction is pending.



On her behalf, BNP men submitted the nomination papers to the offices of the returning officers (ROs) concerned in Bogura and Feni from where she had contested national polls in the past.


Scrutinising the nomination papers on December 2, the ROs can declare her disqualified for the upcoming election in the light of the apex court order.

Amid uncertainty over her polls bid, the BNP yesterday fielded back-up candidates in the three constituencies. In the afternoon, party Secretary General Mirza Fakhrul Islam Alamgir filed nomination papers for contesting the polls from Bogura-6 constituency.

Dr Kamal won't take part in polls

Dr Kamal Hossain, a key leader of the Jatiya Oikyafront, yesterday said he would not participate in the upcoming parliamentary election, ending all speculations over his joining the polls.

"I am 80. I am working for my country and party now," he told The Daily Star.

The Gonoforum president said election was not the only way to serve the nation and any party. He would take part in making different policies and decisions of his party, he added.

On October 13, the BNP and several other political parties, including the Gonoforum, formally launched the Jatiya Oikyafront for what they said was holding the 11th general election in a free, fair and inclusive manner.

25 Jamaat men awarded BNP nomination

The BNP has nominated 25 leaders of Jamaat-e-Islami, a key component of the 20-party alliance, to contest the upcoming parliamentary polls.

It has handed out nomination letters, signed by BNP Secretary General Mirza Fakhrul Islam Alamgir, to Jamaat men. The letters attached to their nomination papers were submitted to the offices of returning officers and assistant returning officers, said insiders in both parties.

"We have received 25 nomination letters from the BNP," Matiur Rahman Akand, organising secretary of Jamaat, told The Daily Star yesterday.

Of the 25 Jamaat aspirants, Shamim Sayedee, second son of convicted war criminal Delawar Hossain Sayedee, submitted nomination papers for Pirojpur-1. On October 29, the Election

Commission scrapped the registration of lamaat in line with a High Court verdict that declared Jamaat's registration illegal.

The EC's move made it clear that the party would not be able to contest the upcoming national election.

Therefore, Jamaat men were initially preparing to run as independents. If they participate in the polls as independents, they may not get a common symbol, said party sources.

Polls code flouted, no action taken

Defying the electoral code of con-· duct, many Awami League and BNP leaders yesterday submitted nomination papers in processions across the country.

The leaders, including ministers and incumbents, were seen throng-

ing the office of the returning officers with a huge number of supporters and party men. Some of them even used government privileges while submitting the documents.

1 killed, 40 hurt in violence over party tickets

A man was killed and more than 40 others · were injured in violence over nomination in several districts yesterday.

Besides, aggrieved supporters of some leaders who were not nominated by their parties staged demonstrations in different districts. Similar incidents had taken place in other areas the previous two days.

In Natore, a Jubo League leader was · hacked to death in Gopalpur of Lalpur upazila yesterday. The victim, Jaharul Islam, 38, was the organising secretary of Lalpur Jubo League.

There had been a longstanding rivalry between Jaharul and another Jubo League : leader Mostaq Hossain over establishing : recently nominated Awami League MP candidate for Natore-1, while Mostaq is a · follower of incumbent lawmaker Abul

Around 11:00am, some attackers, led by · weapons near North Bengal Sugar Mills,

Jaharul was first taken to a local health complex and then to Rajshahi Medical College Hospital where he died, said police.

Who is BB fooling?

Central bank fails in a big way as regulator yet shows no sign of embarrassment in patting itself

Two things come easy in Bangladesh -- getting big bank loans and blissfully

failing to repay. The money in the vaults seems to be the easiest prey today. In the last ten years, scam after scam in the banks has rocked our financial sector, each and every scam unique and more spectacular than the previous ones. The banks looked like sandcastles suddenly being washed away by a bevy of businessmen.

There were outcries and warnings from think-tanks to individuals about the state of affairs happening in the banks. Media were awash with the stories hardly to any effect.

When such was the state of the banking sector, a recent Bangladesh Bank report highlighting the central bank's success in the last ten years that completely ignored the lack of governance in the financial world came as a shock for two reasons - either the regulator does not recognise the weakness and malaise plaguing the banks or that it has taken it for granted that such things are commonplace and so deserve no special mention. In other words, the Bangladesh Bank has dusts off its hands.

But from the regulator, a more honest assessment of the situation is expected if the flaws are to be corrected and malaise treated. Sadly, the report seems to be more written with political exigency rather than with real urgency and professionalism.

How the central bank conducts its core business today will explain why

the report looks so frail. Hallmark is truly a hallmark in the banking scam of the last ten years.
