GRAFT CASE HC orders Khoka's son, daughter to surrender

The High Court yesterday directed Ishraque Hossain and Sarika Sadeque, son and daughter of former Dhaka City Corporation (DCC) mayor Sadeque Hossain Khoka, to surrender before the Chief Metropolitan Magistrate's Court in Dhaka in four weeks in connection with two graft cases.

The bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam passed the order after disposing of their bail petitions.

Deputy Attorney General AKM Amin Uddin Manik said the HC also refused to pass any order on their pleas, seeking direction upon police not to harass or arrest the siblings in SEE PAGE 4 COL 6

Late mayor Annisul Huq believed in the motto "If not me, then who; if not now, then when", said top business leaders of the country while commemorating him at a memorial programme yesterday.

Federation of Bangladesh Chamber of Commerce and Industry (FBCCI) organised the meeting at FBCCI auditorium to mark former Dhaka North City Corporation (DNCC) mayor Annisul Huq's first death anniversary.

Annisul, who had been undergoing treatment at a hospital in London, breathed his last on November 30. He was laid to eternal rest at Banani graveyard on December 2 last year.

Annisul had courage, dynamism, charisma, and creativity, and with these abilities he achieved feats that others could not, said the speakers. "Tejgaon truck stand would never be cleared without

mayor Annisul's initiative, and that proved that he was the only one who could do it," said Atiqul Islam, former president of Bangladesh Garment Manufacturers and Exporters Association (BGMEA).

Former president of FBCCI, AK Azad said that they never thought the government would allocate money to a private organisation, but Annisul made it possible during his time as FBCCI president. The organisation built chamber buildings in 64 districts with that budget.

During emergencies like natural calamities and national crises, women are hit the hardest, and the recovery period is also the longest for them due to existing inequalities, gender discrimination and incompatible emergency response mechanisms, speakers said yesterday.

In this context, the policymakers and other stakeholders should address gender-based violence (GBV) by following a comprehensive and multisectoral approach. This was discussed at a roundtable,

The advertisement ran like this: If you have a problem, he has a solution.

Be it marital dispute, financial crisis, curing diseases, collecting debt, subjugating a loved one or what not, claiming himself a "Jiner Badsha" (king of genies), he used to offer people hope of solving all their problems.

However, those who responded were duped and eventually robbed off their money after falling into the trap of Jubair Ahmed -- the so-called Jiner Badsha.

The 27-year-old has been conning people for a long time, but luck finally ran out for Jubair as the Criminal Investigation Department (CID) of police arrested him from a hotel in Dhaka's Farmgate area yesterday morning. Law enforcers arrested him in connection

with a fraud case filed last year, Shah Alam, deputy inspector general of CID, told a press briefing at its headquarters in Malibagh around noon.

Jubair's three accomplices -- Zafar Iqbal alias Kajal, Sagar and Samir -- were also arrested recently. Syeda Jannat, special superintendent of

CID, said the accused are members of an organised criminal gang and they used to embezzle money from people by posting advertisements in two weekly magazines. They used the name of "Darbar Sharif"
