

Healed partly

37 BNP aspirants among 80 win appeals with EC after ROs reject their nomination papers

Thirty-seven BNP candidates yesterday won appeals at the Election Commission, helping the party recover partially from the damage done by rejection of the nomination papers of its 141 parliamentary aspirants.

Their win also ensured the party's candidature in four of the six constituencies where returning officers (ROs) rejected all nomination papers of BNP leaders during scrutiny.

Hearing of the aspirants' appeals in the remaining two seats will be held today and tomorrow.

Yesterday's successful appellants include BNP senior leaders barrister Aminul Huq and Maj (retd) Akhtaruzzaman, who are now allowed to contest the polls from Rajshahi-1 and Kishoreganj-2.

But the rejection of appeals of several BNP leaders, including former ministers Mir Nasir Uddin, Iqbal Hasan Mahmud Tuku, and Ruhul Quddus Talukder Dulu, has raised concern in the BNP camp.

The ROs concerned rejected their nomination papers on the grounds of their conviction in graft cases. The EC upheld the ROs' decision.

After three days of protest, students of Vigarunnisa Noon School and College (VNSC) yesterday decided to go back to class and attend exams after being assured that their six-point demand, over the death of ninth-grader Aritry Adhikary, would be implemented.

Meanwhile, another group of students protested the arrest of class teacher Hasna Hena, who was taken to jail yesterday in a case filed by Aritry's father for "provoking the suicide". The group claimed the teacher was not involved in the incident.

In the morning, protestors, mostly from classes IX and X, took position near the main entrance of the institution in the capital's Bailey Road, to press home their demands, including the resignation of the acting principal and the school's governing body.

Sonali in a fix

Worried about recovering Tk 3,000cr from Hall-Mark Group as it finds no buyer for mortgaged assets

The Sonali Bank has floated tenders 60 times between 2013 and 2017 to sell the mortgaged assets of Hall-Mark Group but got no buyers, and the lender is now worried about recovering nearly Tk 3,000 crore from the scamster.

Bidders are not showing interest to buy the highly disputed properties of the garment maker, fearing it might invite trouble for them in future, sources in the stateowned bank said.

"The bank is in a fix, as it can neither use the properties nor sell those," said a senior official of the bank.

"The machinery is gradually losing productivity as they have remained unused for long," the official added, asking not to be

named. On top of that, the Sonali Bank has to

count more money now to guard the mort-

gaged assets at its own cost. It also had to bear the cost of running about five dozen advertisements in different newspapers.

Finding no other alternative, the lender is now considering turning the Hall-Mark factory complex built on over 61.17 acres of mortgaged land into an economic zone, although it has not made a final decision yet.

As per Sonali Bank's assessment, Hall-Mark's assets and infrastructures are worth Tk 1,170 crore. Of this, the Group has mortgaged assets are worth Tk 389 crore.

After the loan scam surfaced following a Bangladesh Bank investigation in 2012, the Sonali Bank filed a petition with the civil court, seeking ownership of the rest of the Group's assets, worth Tk 781 crore, so it can recover the loan. The court is yet to deliver a verdict.

The lender also filed 16 lawsuits with money loan courts and two with civil courts,

Mystery remains

Autopsy performed on Banglamotor toddler; father remanded STAFF CORRESPONDENT

There was no sharp

weapon or electric shock injury marks on the body of the two-year-old boy recovered from his Banglamotor home on Wednesday, according to the autopsy report.

A three-member medical board yesterday conducted the autopsy on Noor Safayet's body at the Dhaka Medical College morgue. Sohel Mahmud, head of

the forensic medicine department at the DMC, said there was a small injury mark on the child's forehead but no sign of bleeding.

"We found his lung and liver to be a bit swollen and we have sent his brain, liver, blood, and lung for histopathology," he added.

The injury mark on his forehead could have been due to a fall "but we need the histopathology report SEE PAGE 2 COL 6

He wanted to be 'Boss'

How a movie inspired a landlord to set up a network of gangs

In 2015, AKM Rana was doing rather well as a landlord. The then 35 years old did not have to do much yet money was flowing in from the two buildings and several shops he leased out.

But then he watched a movie -Boss: Born to Rule - in which the lead creates a network of gangs, develops a

AKM Rana crime empire, and assumes control of the underworld. He formed a gang that year comprised mostly of ruling party men. They picked up people posing as law enforcers and robbed them. Rana used to claim that he was an assis-

tant commissioner of detective branch of police. But leading a gang was never Rana's ultimate goal. He wanted an empire to rule.

Rana connected his gang with eight more gangs operating in the capital and brought them under a single umbrella. He even employed sources across the capital to tip the gang off about people carrying valuables and large amount of cash.

Together the gangs, each 16 to 20 men strong, mugged people in broad daylight posing as law enforcers, said Bashir Ahmed, superintendent of Police Bureau of Investigation (PBI). They would use motorbikes and microbuses to take their victims to isolated places, he said.
