# Demonstrate that corruption is a punishable offence

TIB calls on govt, ACC

Transparency International Bangladesh (TIB) yesterday urged the government and Anti-Corruption Commission (ACC) to be more watchful and demonstrate that corruption is indeed a punishable offence.

Without effective response from the government and ACC, the fight against corruption will fail, said TIB Executive Director Dr Iftekharuzzaman. Raising questions over the sincerity of bringing corrupt people to justice, especially those in positions of power, and empowering ACC in this connection, he said, "We don't see that happening."

Iftekharuzzaman made the remarks while addressing the inaugural ceremony of an anti-corruption cartoon and photography exhibition at Drik Gallery in Dhaka. The exhibi-

tion will continue till December 13. TIB also handed over prizes among winners of the 13th Anti-Corruption Cartoon Competition 2018 and 4th Anti-Corruption Photo Competition

To mark International Anticorruption Day, TIB also formed a human chain in front of Dhaka University's Teacher-Student Centre (TSC) in the morning.

Speaking at the programme, Iftekharuzzaman said, "There are various important places, which are conducive to corruption. During the road safety movement, it was seen that a workers' leader is in charge of an important ministry. Although many promises were made to resolve this issue, these were never delivered."

He also said the possibility of enforcing the anti-corruption acts has been reduced because of some contradictory laws like ICT Act and Public Service Act.

At the inaugural ceremony of the exhibition, he said, "The Digital Security Act has become a weapon not only against freedom of expression but also against the anti-corruption movement.

"The Digital Security Act has unfortunately created a context in which people feel insecure to raise voice and are forced to exercise self-censorship. We call upon the government to really reconsider this law and amend it as soon as possible."

Addressing the inaugural ceremony, Danish Ambassador Winnie Estrup Petersen said corruption disproportionately affects the poor, particularly women and minority groups.

The cartoons and photographs in the exhibition are a treasure of information on the nature and impact of corruption that will provide a strong collective voice for change, she said. "It is my strong conviction that this important event will create greater awareness and motivation among the young generation to say 'no' to corruption."

## Increase number of reserved seats in parliament

Bangladesh Mahila Parishad demands

Bangladesh Mahila Parishad (BMP) yesterday alleged that all political parties that came to power since independence did not take any adequate initiative for the social and political development of women.

The women's rights activists also placed their 21-point demand which included direct election of women and increasing the number of reserved seats to 100 from 50.

They made the demands from a rally on "Political empowerment of women and holding a free and fair election" held at the Central Shaheed Minar in the capital.

"The Awami League-led government did not keep its own promise made in the election manifesto and Sheikh Hasina also broke her promise made in several speeches by not taking initiatives to hold direct election for women," said Ayesha Khanam,

president of BMP.

She alleged that the 17th amendment of the constitution, which allows reserved seats for women in the parliament for another 25 years without the provision of election, will hamper progress.

"The government may succeed in economic development but without ensuring political rights of women, it will not be sustainable," she added

She alleged that female parliament members, in reserved seats, cannot play a bold role as they have no constituencies and the parliament is dominated by male politicians.

"I know that women have no legal barrier to participate in the national elections from the 300 general seats but it is quite difficult for women candidates to get nominations from their respective parties as getting nomination depends on money and muscle SEE PAGE 4 COL 1

Baki Billah passed the order considering her age and that there was no specific allegation against her, court sources said.

Hasna Hena, 51, was arrested by the Detective Branch (DB) of police on December 5. She was sent to jail the next day by a Dhaka

## Hearing on AG's petition deferred

A Dhaka court yesterday deferred the hearing on the prosecution petition seeking permission to produce an FBI agent and two members of Canadian police in court to testify in the Niko corruption case, till January 3 next year.

The court also asked all the 11 accused, including BNP Chairperson Khaleda Zia, to appear before it on the day.

Judge Sheikh Hafizur Rahman of the Special Judge's Court-9 of Dhaka passed the order after Khaleda's lawyer Abdur Rezak Khan submitted a time petition saying that they would file written objection against the prosecution's pleas.

## Formulate comprehensive human rights action plan

Activists urge government

Human rights defenders yesterday demanded that the government develop a comprehensive national action plan incorporating all recommendations received from international bodies for

protection of human rights in the country. They also stressed on implementation of international and national human rights obligations, to improve the country's human rights situation.

They were speaking at a programme at The Daily Star centre, marking the International Human Rights Day being observed today. It was organised by Human Rights Forum Bangladesh (HRFB), a platform of 20 human rights organisations.

Zakir Hossain, a steering committee member of HRFB, placed an 18-point demand to political parties, urging them to adopt a "zero tolerance" policy in case of extrajudicial killing, enforced disappearance

and death in custody. He also urged political parties not to use law enforcers for political gains, and to keep children away from political

activities. Sheepa Hafiza, coordinator of HRFB and executive director of Ain o Salish Kendra

As it was the death anniversary of his father Ataur minister and a veteran national leader, Barrister Ziaur said he and his son went to the graveyard along

He said an Ansar memhe wanted to offer prayers at his father's grave, the Ansar member replied he

A police personnel appeared and inquired if he had a gate pass, said Ziaur. He said he gave the policeman his identity and also mentioned the particular graveyard he intended to visit. The policeman was unmoved and suggested that Ziaur proceed to their office and obtain a "pass", otherwise he was unable to allow them entry.
