Contacted, BNP standing committee member Amir Khasru Mahmud Chowdhury, who is contesting the polls from Chattogram-11 constituency, told The Daily Star, "How will my activists hang posters when they cannot even accompany me during campaign?"

"On December 12, they [the ruling party men] attacked us when we were conducting campaign in Madarbari area. Police, however, arrested one of my activists instead of taking action against the attackers," he claimed.

"On the same date, police picked up my chief election coordinator Md Sikander soon after an UK embassy delegation left my house after a meeting," he alleged.

Mentionable, Dr Shahadat Hossain, president of the city unit BNP, who is contesting the polls from Chattogram-9, was arrested on November 7 in Dhaka. He has been in jail since.

Maruful Hoque Chowdhury, personal secretary of Shahadat, alleged, "The ruling party men are removing our posters and banners indiscriminately. We will file a complaint to the Chief Election added. Commissioner soon."

Chattogram Metropolitan Police Commissioner Mahbubor Rahman said they are yet to receive any formal complaint in this regard. "I don't think any police member would do such things. If someone else had done it, we would take actions upon proof."

Contacted, Divisional Commissioner Abdul Mannan, returning officer of six constituencies in the city, said it is not believable that law enforcers are removing posters and banners of BNP candidates. Those who are raising such allegations could not show any evidence, he

However in the same meeting, another engineer with same qualification was made a permanent employee, the lawyer added.

Yeasir filed a writ petition in July challenging the termination. On July 31, HC stayed the termination and issued a rule asking the trust to explain why its decision should not be declared illegal.

Despite the stay order, the trust stopped paying his salary since May this year, the lawyer also said.

Yeasir filed a contempt petition against the trust's managing director and secretary for defying the court's order.

On November 25, the bench issued a rule asking the trust to explain in 10 days why contempt of court proceedings should not be brought against them.

As they did not respond, the HC bench issued summons against the duo, the lawyer added.

4 arrested over attempted rape, extortion

Hearing her scream, locals rushed in and saved her but the seven fled. Later, the family filed a case with Savar Model Police Station.

OC Abdul Awal of the police station said, "Our primary investigation found the allegations to be true. We are trying to arrest rest of the gang members."

He said there were previous allegations against the gang of harassing and extorting people through impersonation.

Dire consequences

"We'll consider later under which authority you're [the government] currently ruling the country, but what you're doing now is contrary to the constitution," Dr Kamal said.

"I have never seen such misrule. If anyone calls this 'good

governance', I'd say they're lying," he added. Speaking as chief guest at the programme, Dr Kamal urged the Election Commission (EC) to ensure people's voting rights and to use its rightful authority to resist the government if it bars the commission's duties.

He also urged the current government and the ruling party men to stop enjoying state benefits, alleging that their entitlement has crossed all limits.

About judiciary, Dr Kamal said the phrase "independence of judiciary" sounds ideal, but it will not be materialised if the stakeholders of the judicial system - judges, lawyers and

the government - do not believe it in their hearts. The Bar Association's President Zainul Abedin, Begum Rokeya University Vice-Chancellor Nazmul Ahsan Kalimullah and BHRF Chairman Mohammad Shahjahan, among others, also spoke at the discussion.

Debate for Democracy Chairman Hassan Ahamed Chowdhury Kiron stressed the need for training in demand-driven skills for those migrating abroad.

Brothers killed in

landslide OUR CORRESPONDENT, Sylhet

Two siblings were killed in a landslide in Maijgaon village of Fenchiganj upazila in Sylhet district yesterday.

The deceased are Shahin Miah, 8, and his younger brother Fahim Miah, 4, sons of Malaysia expatriate Liaquat Ali, said police quoting locals.

The bodies were found around 10:00am under the mud of a nearby hill, said OC Abul Bashar Md Badruzzaman of Fenchuganj Police Station. The children went missing

after they went out to play in the morning, the OC added.

The bodies were sent to a local hospital for autopsy.

Frequent hill cutting raised the risk of landslides in many areas of the upazila, said Ayesha Haque, upazila nirbahi officer of Fenchuganj, adding that locals have been asked to stay out of the risky areas.

A probe committee has been formed to investigate the matter and take necessary action, she added.
