#### BNP website blocked over 'distasteful' content

The BNP's official website -- www.bnpbangladesh.com -- was blocked last week as it contained "distasteful" content, said the Bangladesh

Telecommunication Regulatory Commission (BTRC) yesterday evening in an e-mail to the Election Commission.

Following a written complaint from the Bangladesh Nationalist Party, the main opposition party, to the EC, the commission on Monday asked the telecom regulator to take necessary action regarding the complaint.

In reply, the BTRC yesterday said the website was blocked as it contained a lot of contents that went against the law and order of the country. They also requested the EC to reconsider their order to unblock the site again.

"Two intelligence agencies also requested the telecom watchdog to block the site and that's why we went for it," reads the BTRC email.

## Shakib leads Tigers to leveller

Skipper Shakib Al Hasan's all-round performance, which included his maiden T20I five-wicket haul, helped Bangladesh bounce back to level the three-match series as the Tigers registered a comfortable 36-run win over the West Indies at the Sher-e-Bangla National Stadium in Mirpur yesterday.

Shakib, who waged a lone battle during the first T20I which the hosts lost by eight wickets in Sylhet, this time ensured that his contributions would not go in vain after scoring an unbeaten 26-ball 42 in a Bangladesh record fifth-

wicket stand with Mahmudullah Riyad which culminated in the Tigers posting their second highest T20I total of 211 for five.

Shakib also ended with career-best bowling figures of five for 21 from four overs before the West Indies were



eventually bowled out for 175 in 19.2 overs.

The left-hander's efforts were ably backed by a collective approach from his teammates, with Liton Das's blistering 34-ball 60 setting up a perfect platform.

The West Indies, despite losing wickets at regular intervals, kept the run rate near ten till the halfway mark in their innings but the cushion provided by the huge total on the board helped the Tigers maintain pressure on the batting side and eventually seal victory.

### Govt declares public holiday on Dec 30

BSS, Dhaka

The government has declared December 30 as a public holiday to enable the voters to cast their votes without hassles from workrelated commitments.

A gazette notification has already been issued to this end, said an official handout. On Monday, the Election

Commission sent a letter to the public administration ministry requesting them to announce December 30 as public holiday.

The voting in the 11th parliamentary polls will be held on the day. The public holiday

meant for enabling the officers and employees of the government, semigovernment, private and autonomous bodies and the teachers, officers and employees of all public and private educational institutions throughout the country to exercise their rights of franchise.
