Pro-liberation platforms Sammilita Shamajik Andolon and Shamprodayikota-Jongibad Birodhi Mancha arranged the discussion on "Eleventh National Parliamentary Election: Present Situation and Doable".  
Speaking at the discussion, cultural personality Ramendu Majumdar urged countrymen not to vote for those who collaborated with the Pakistani army during the Liberation War.  
He said the Election Commission's role in addressing the recent violence was not effective.  
Oikya Nap President Pankaj Bhattacharya said the election will be considered credible if voters can vote freely and return home safely on election day.  
Voters should not cast their votes for candidates with communal background and history of anti-minority activities, said economist Prof MM Akash.  
Meanwhile, at a views exchange meeting arranged by Sector Commanders Forum

(SCF) - Muktiyuddho '71 on "Tarunyer Sanglap" at Dhaka University, speakers urged people to shun anti-Liberation War forces at the polls for continuation of the country's development.  
Speaking at the programme, SCF President Maj Gen (ret'd) KM Shafiqullah said, "We have achieved independence through the Liberation War. I demand [from the youths and people] electing pro-liberation forces to power."  
At the programme, former National Human Rights Commission chairman Prof Mizanur Rahman raised question regarding Oikyafront's election manifesto.  
In the manifesto they have pledged to bring reforms to the state, but for doing so they sought help from those who "progressively harmed the country after 1975", he said.  
SCF Secretary General Harun Habib and DU Pro-Vice Chancellor Prof Mohammad Samad, among others, spoke at the programme.

that the local commissioner promised him compensation.  
The country witnessed death of 11 children in political clashes in 2013, prior the 10th parliamentary polls. Apart from deaths and injuries, many minors were detained during different political programmes, according to BSAF data.  
Although political violence was not frequent in 2015, a total of 25 children were killed and 76 were injured in arson, crude bomb explosions and city corporation election-related clashes, the rights organisation claims.  
AS Mahmood, director of BSAF, said employing children in political activities is a violation of the Children Act. "The Election Commission may ask law enforcement agencies to take actions against political parties who are using children in electioneering," he suggested.  
Election Commissioner Rafiqul Islam said the matter could be brought to attention of election enquiry committees, who can take measures in line with the Children Act.  
"Some children willingly join political rallies. But I hope all parties will keep in mind the importance of upholding human rights and child rights during electioneering," he said.

have already increased the strength of DNC and its manpower. Besides, steps are also being taken to increase their logistical support, he added.  
"Earlier, we had no statistics on addicts. Now we got the information and we have no other option but to ensure treatment facilities for them," said Jamal Uddin Ahmed, director general of DNC.  
Besides the government rehabilitation centre, there are around 275 such private centres across the country, said the DG.  
DG Jamal further said they have already updated the 50-bed government rehabilitation centre to a 100-bed one, where 24 beds are reserved for women.

At the workshop, Farid Uddin Ahmed Chowdhury, secretary to the ministry's security services division, was present as special guest.  
The number of narcotics users is increasing every day, he said, stressing the need for taking necessary steps in this regard.
