### CANDIDATES' INFO ROs yet to distribute leaflets

STAFF CORRESPONDENT

Returning officers in many constituencies are yet to start distributing leaflets containing a set of mandatory information about the candidates.

To help people make an informed choice, the leaflets are supposed to mention eight pieces of information, including on the candidates' and their dependents' wealth, annual income, source of income, education, occupation and cases, if any, filed against them.

The election campaign started on December 10 would continue until December 28 midnight.

A writ petition was filed yesterday with the High Court seeking a directive on the Election Commission to publish and distribute leaflets among the voters, containing all information mentioned by the candidates in their affidavits, to help people choose their representative.

Law and Life Foundation, a rights organisation, filed the petition seeking the court's order on the EC to comply with the guidelines provided in chapter VII of the eleventh national parliament election manual.

According to the manual, the EC

The HC may hear the petition on Monday.

Of them, only Tofael Islam in Moulvibazar said he had been distributing the leaflets among voters.

Trump had pledged to withdraw from Syria if elected, but the abrupt

announcement on Wednesday to withdraw the roughly 2,000 U.S. troops from Syria caught US lawmakers and others by surprise. The White House declined to offer a timeline for the departure.

Some of Trump's fellow Republicans strongly criticised the move, saying they were not briefed ahead of time and that the move strengthened the hand of Russia and Iran, which both support Syrian President Bashar al Assad.

US officials, speaking on condition of anonymity, have told Reuters that US commanders on the ground are also concerned about the impact of a quick withdrawal and were surprised by the decision.

Trump's move also drew criticism from some US allies, including Britain and France, which said Islamic State militants had not been defeated and that its troops would

remain in Syria. The void left by the US withdrawal could undermine diplomatic efforts to end Syria's eight-year civil war and undercut the United States' leverage in the region as well as leave it few

options if Islamic State surges again. "ISIS hits us they are doomed!" Trump tweeted, using an acronym for Islamic State.

Islamic State, which declared its so-called caliphate in 2014 after seizing large areas of Syria and Iraq, was down to its last 1 percent of the territory it once held in Syria and has no territory in Iraq, a senior US official last week. But US officials have

warned that retaking territory is not the same as defeating the militants.

In a campaign to defeat the group in Syria, former President Barack Obama ordered air strikes from September 2014 and then troops into

the country the following year. Some US lawmakers, including some Democrats, backed Wednesday's announced withdrawal

but said Congress needed to play a larger role in overseeing such military operations.

Russian President Vladimir Putin yesterday welcomed Trump's decision and said he largely agreed that

Islamic State had been defeated.

At a news conference on December 12, Rosario Manalo, chair of the Independent Commission of Enquiry, stated that the commission had found "no evidence" to support allegations of human rights abuses in the four months since it officially opened its investigation.

Her statement shows that the commission was disregarding evidence and testimony collected by United Nations fact-finders, the US State Department, and international human rights organisations since violence broke out in Rakhine in 2016, said the New York-based global rights body on Wednesday. The UN Security Council, which

has been negotiating its first resolution on the Rohingya crisis, should view the chair's comments as further evidence that Myanmar's commission is not a viable path to justice for victims of abuses, said HRW.

On September 18, the UN Independent International Fact-Finding Mission on Myanmar issued a 444-page report detailing crimes against humanity, war crimes, and genocide by Myanmar's security forces in Rakhine and serious human rights abuses in Shan and Kachin states.

The UN Office of the High Commissioner for Human Rights issued a "flash report" in February last year documenting extrajudicial killings, sexual violence, arbitrary detention, torture, and other abuses by Myanmar security forces in Rakhine after an attack on security posts in August 2016.

The HRW has documented the widespread use of sexual violence against the Rohingya, a massacre in the village of Tula Toli, and the widespread destruction of Rohingya villages.

Amnesty International has documented serious human rights abuses by the military in Rakhine and identified some of the military units and officers responsible for atrocities.

The US Holocaust Memorial Museum and Fortify Rights issued a joint report in November last year documenting abuses by security forces including murder, rape and

Analytica and other third-party applications to collect personal data without users' permission. Today's lawsuit is about making Facebook live up to its promise to protect its users' privacy."

The suit filed in Superior Court in Washington seeks an injunction "to ensure Facebook puts in place protocols and safeguards to monitor users' data and to make it easier for users to control their privacy settings," and demands "restitution" for consumers.

Facebook said: "We're reviewing the complaint and look forward to continuing our discussions with attorneys general in DC and elsewhere."

The social network has admitted that up to 87 million users may have had their data hijacked by Cambridge Analytica, which shut down weeks after the news emerged on its handling of private user information.

A whistleblower at the consultancy, which worked on Trump's presidential campaign, said it used Facebook data to develop profiles of users who were targeted with personalised messages that could have played on their fears.

The scandal has triggered a series of investigations and broad review by Facebook on how it shares user data with third parties.

#### SHARING WITH 150 PARTNERS The New York Times reported that

some 150 companies -- including powerful partners like Amazon, Microsoft, Netflix and Spotify -- could access detailed information about Facebook users, including data about their friends. According to documents seen by the

Times, Facebook allowed Microsoft's Bing search engine to see names of Facebook users' friends without consent and gave Netflix and Spotify the ability to read private messages. The report said Amazon was able to

obtain user names and contact information through their friends, and Yahoo could view streams of friends' posts.

While some of the deals date back as far as 2010, the Times said they remained active as late as 2017 -- and

some were still in effect this year. "It appears that Facebook has not

been honest with Congress or the public about how it treats its users' data," Congressman Frank Pallone, a Democrat, said in a tweet.

Facebook's head of developer platforms and programs, Konstantinos Papamiltiadis, said in a blog post that the Times report referred to partnerships that enabled "social experiences -- like seeing recommendations from their Facebook friends -- on other

popular apps and websites." None of those partnerships or features "gave companies access to information without people's permission," he said, adding that the deals did not violate a 2012 privacy settlement with the US Federal Trade Commission.

Papamiltiadis said, however, that "we've been public about these features and partnerships over the years because we wanted people to actually use them.

But he said most of the features are now gone.

#### PRIVATE MESSAGES Netflix said that the feature was used to

make the streaming service "more social" by allowing users to make recommendations to friends, but that it stopped using it in 2015. "At no time did we access people's

private messages on Facebook or ask for the ability to do so," Netflix said in a statement. Spotify offered a similar response,

indicating the music service "cannot read users' private Facebook inbox messages across any of our current integrations." The Canadian bank RBC, also cited

in The New York Times, said the deal with Facebook "was limited to the development of a service that enabled clients to facilitate payment transactions to their Facebook friends," and that it was discontinued in 2015. Senator Brian Schatz said the latest

revelations highlight a need for tougher controls on how tech companies handle user data. "It has never been more clear,"

Schatz tweeted. "We need a federal privacy law. They are never going to volunteer to do the right thing."

major cyber threat by private-sector

cyber security researchers and government investigators because of the scale of the intrusions. The hackers were charged with spying on some of the world's largest companies by hacking into technology

firms to which they outsource email,

storage and other computing tasks.

The timing of the action may further escalate tensions between Washington and Beijing after the arrest of Meng Wanzhou, the chief financial officer of Chinese telecommunications giant Huawei Technologies, in Canada at the request of the United States.

The action also comes just weeks after the United States and China agreed to talks aimed at resolving an ongoing trade dispute that threatens global economic growth.

The British government said in a statement the hacking was conducted by a group known as APT 10, which was acting on behalf of China's Ministry of State Security.

"This campaign shows that elements of the Chinese government are not upholding the commitments China made directly to the UK in a 2015 bilateral agreement," the British statement said.
