There is no place for rapists in an independent Bangladesh. AL, by ensuring punishment for the rapists, should prove that the party is indeed upholding the spirit of Liberation War, he said.

In her speech, Rupashi Chakma, president of Hill Women Federation, alleged that an influential quarter backed by the ruling party is involved in land grabbing in the Chittagong Hill Tracts and many indigenous girls and women repeatedly fall victim to sexual violence due to lack of proper punishment.

Meanwhile, another platform called "Stand against Rape" formed a human chain at Raju Bhashkorjo near TSC of DU, protesting the gang-rape in Noakhali.

Sukanta Mondal, one of the organisers of the platform, urged Prime Minister Sheikh Hasina to take immediate action against the culprits.

Tangail road crash sparks protest

One killed, another injured as bus hits motorbike

A trader was killed and his co-rider injured when a bus hit their motorcycle in Tangail on Friday, reports our Tangail correspondent.

Badal Miah, 40, from Nagar Jalpa village died on the spot when the accident occurred on Dhaka-Tangail highway in Taratia area of Sadar upazila, said police.

Firefighters rushed to the spot and took injured Rihan Khan, 38, general secretary of Bhatkura Traders Association, to Tangail General Hospital, said Abdur Razzak, station officer of Fire Service and Civil Defence, Tangail.

After the accident, angry locals kept the busy highway blocked for about an hour, causing a long tail-back on both sides of the road, said locals.

The protesters withdrew the blockade after a police team rushed to the spot and assured them of

taking necessary actions against those responsible for the accident, said Saidur Rahman, officer-in-charge of Tangail Model Police Station.

The bus was seized but its driver and his helpers managed to flee, he added.

Our Savar correspondent adds, two people were killed and three others injured when a speeding truck hit a rickshaw and pedestrians in Baipal-Abdullahpur road in Itakhola area in Ashulia on the same day.

Rickshaw-puller Md Masud, 30, from Naogaon Damurhat; and Moushumi Akter, 22, from Bagerhat, died instantly, said police.

The injured were taken to a local hospital.

Police seized the truck but could not arrest its driver and helper, said Javed Masud, officer-in-charge (investigation) of Ashulia Police Station.

"We will also move the petition, which is pending with the apex court and pray for Khaleda's bail in the case," Advocate Zainul added.

Apu, former assistant personal secretary to BNP acting chairperson Tarique Rahman, was admitted to the hospital on December 24.

He is the fourth accused in the case filed with Motijheel Police Station, Rab said.

On December 25, Rab detained three people in the capital's Motijheel and Gulshan for allegedly distributing money to influence the national election and instigate violence.

They are Joynal Abedin, general manager of Amena Enterprise, its manager Alamgir Hossain and Ali Haider, managing director of United Corporation.

The elite force also seized Tk 8 crore and several cheques, worth around Tk 10 crore, from their possession.

Speaking at a press conference in front of United Corporation in Motijheel on December 25, Rab Director General Benazir Ahmed said the three arrestees had so far distributed around Tk 150 crore in various constituencies to instigate violence and influence the December 30 parliamentary polls. The Rab chief further said, "The money came from Dubai through hundi."

Benazir also said one of the three detainees had links with Hawa Bhaban. Hawa Bhaban was considered an alternative powerhouse of the previous BNP-led alliance government (2001-2006).
