Mahidul and Nikson, however, claimed that police found nothing on them related to yaba. Instead, the cops demanded Tk 50,000 for their release.

Meanwhile, a group of JnU students blocked Roy Saheb Bazar intersection protesting their fellow students' arrest from 8am to 9am yesterday, while another section of students staged demonstration in front of the university till 10am, causing severe traffic congestion on Gulistan-Sadarghat route.

Debate for harmony begins Saturday

With a view to promoting harmony and tolerance, a five-month-long university-level debate festival will begin on Saturday at Narsingdi Government College.

Daffodil International University Debating Club (DIUDC) hosts the event and involves 60 higher educational institutions including madrasas of six districts of Dhaka division -- Dhaka, Narayanganj, Munshiganj, Manikganj, Narsingdi, and Gazipur.

The festival is part of Manusher Jonno Foundation (MJF)'s "SAMPREETI" project, which aims to increase resilience against violent extremist agendas among students. The details of the event were shared through a press conference on DIU campus in Dhaka yesterday.

Speaking at the conference, former chief information commissioner Prof Golam Rahman said, "The focus of debating should be patience, tolerance and non-violence... We have to acknowledge the existence of pluralism in society. And this is the main function of debate."

Prof Golam Mostafa Faruk, dean of the faculty of arts and humanities, DIU, said, "Due to the absence of tolerance, election to student unions has stopped. But it was the cradle of creating national leaders. Against this backdrop, debate organisations are the lighthouse."

Shahzadi Begum, deputy program manager of MJF, said, "There are conflicts and differences in society... But we have to be tolerant, too. SAMPREETI is an initiative to spread this theme."

Later on March 15 of 2016, Zohair bin Huda, joint director of Bangladesh Bank, filed the case with Motijheel Police Station in this regard.

"If we can eliminate adolescent pregnancy, fertility would be reduced by 24.8 percent," said Sarwar Bari, line director of Field Services Delivery Unit, Ministry of Health and Family Planning.

Laws fall short against child marriage when there are deep-rooted causes -- like social norms, security issues and popular beliefs surrounding gender roles -- encouraging parents to marry off their daughters young.

These are prime issues that need to be addressed to bring sustainable change to the overall scenario, speakers said. Male members, especially fathers, should be engaged in all programmes because they are the decision-makers in families, they said.

Representatives from UN organisations, national and international NGOs, rights bodies and from the government spoke at the event chaired by Arnob Chakrabarty, of RedOrange Media and Communications. Sarwar Bari and Annie Vestjens, first secretary (SRHR and gender), Embassy of the Kingdom of the Netherlands were present as special guests.

There are many pilot projects being run by the government and NGOs in particular areas for a limited timeframe. But if all partners combine their efforts, the activities can be scaled up for a wide coverage in the best interest of the targeted group -- girls and women, they said.

"If we really want to achieve something... we have to move forward in a coordinated way," said Vestjens as the discussion ended.

Contacted, Traffic Sergeant Azadul Islam denied the allegation of negligence in duty.

"Rain or shine, we have to perform our duty eight hours at a stretch on the streets," he said, adding, "Most drivers do not care for traffic rules or listen to traffic constables as they have no power to penalise them."

A traffic sergeant can penalise drivers but sergeants are usually on patrol and cannot stay at an intersection for too long.

Contacted, Traffic Inspector (north) Subhash Chandra Dey said there was a dearth of bus stops in many areas and the drivers often stop randomly to pick up passengers.

Awareness among drivers, passengers, and pedestrians is a must to address the problem, he said.

IN MEMORIAM

Today is ninth death anniversary of Ishtiaque Ahmed Khan, an eminent philatelist, historian, author and a multi-dimensional research scholar. He was the only Fellow of the Royal Asiatic Society from Bangladesh and a member of the Royal Philatelic Society, London. On 25 February, 2010 Bangladesh Post Office issued a special postmark to commemorate his lifetime contribution to philately.

Ishtiaque was a Gregorian. He had contributed to Banglapedia and was author of "The Meter

Franking Cancellations of Bangladesh" and translated and edited "The Principles of Scientific Management".

He was also awarded the Vermeil medal by the APS Stampshow, held in 2013, in Milwaukee, Wisconsin, USA for his book "One Taka Inland Envelope of Bangladesh: A Comprehensive Study".

At the time of his demise, he was an M. Phil scholar, Management Department at the University of Dhaka. He was also a member of Dhaka Stock Exchange Ltd.

Although not among us anymore, his memories remain as vivid today as it was on the day he died.
