MAN LYNCHED IN CTG JP leader arrested after 177 sued in murder case

A Jatiya Party (JP) leader was arrested yesterday evening in a case filed in connection with the killing of Mohiuddin Sohel, who was lynched by an angry mob at Pahartali Railway Bazar of Chattogram, over allegations of extortion on Monday.

Mohiuddin was the former General Secretary of Bangladesh Chhatra League's (BCL) Chattogram Commerce College unit, and was involved with the politics of local Awami League, said family members and police.

Assistant Commissioner (AC) Ashkur Rahaman of Double Mooring Zone of Chattogram Metropolitan Police told The Daily Star, "Osman Khan, 50, was arrested from his residence at Pahartali area of the city in connection with the murder."

Osman is the Joint Secretary of Jatiya Party's port city unit, and also a businessman of Pahartali Railway Bazar, said traders and police.

Earlier, Mohiuddin's brother Sakirul

Islam Shishir filed the murder case naming 27 persons including Osman and Saber Ahmed -- a ward councillor of Chattogram City Corporation -- as well as 150 unnamed persons with Double Mooring police Station on Tuesday night.

Inspector (investigation) Jahir Hossain of Double Mooring Police Station said they were investigating into the incident.

"We are looking for CCTV footage in the area, but haven't found anything till now. However, we are working on it," he said.

Mohiuddin's family members in a press conference on Tuesday claimed that Mohiuddin was murdered in a pre-planned way with help of local traders and others.

They also claimed that Mohiuddin was targeted as he raised his voice against irregularities and other crimes in the market area.

On Sunday, Mohiuddin was beaten and stabbed to death by a group of angry mob, most of them traders, for allegedly extorting local traders at Pahartali Railway Bazar.

'Stand up for your rights' Activists demand exemplary punishment for Noakhali gang-rape accused

A group of women's rights activists yesterday demanded exemplary punishment for all the accused in the Noakhali gang-rape case.

They also demanded strict punishment for those involved in abusing women and children and urged the country's women to get united and stand up for their rights.

The demand came from a protest rally under the banner, "Bam Ganatantrik Nari Sangathan Samuho", a platform of women's rights activists, comprising of six left-leaning organisations. It was held in front of Jatiya Press Club in Dhaka.

They said police have so far arrested 10 persons along with the prime accused in the Subarnachar rape case. All of them have been remanded and two of the accused already gave confessional statements.

"We hope that the arrests are not an eye-wash and the offenders will be given exemplary punishment," said Runa Noor, a member of Communist Party of Bangladesh's (CPB) women cell.

Shampa Basu, general secretary of Samajtantrik Mahila Forum, claimed that 10 children were raped and killed in the last 10 days since the December 30 election and police are yet to arrest all the culprits.

She said according to newspaper reports, 928 women

Poor management leads to traffic chaos Negligence in duty by traffic police to blame, allege port city commuters

Negligence in duty by traffic police is to blame for haphazard movement of vehicles on streets and gridlocks at intersections in Chattogram city, according to commuters.

Traffic chaos has become a common phenomenon in a number of areas, including Lalkhan Bazar, Kazir Dewri, Jamal Khan, GEC intersection, Sholosohor Gate-2, Agrabad, Badamtoli, Bahaddarhat, Muradpur, Prabartak, and Anderkilla.

Traffic policemen are often seen doing nothing when a bus stops blocking an intersection or any vehicle ignores signals and crosses the intersection, alleged commuters.

On a Sunday morning, a traffic policeman at Chawkbazar intersection along Nawab Siraj ud-Daulah Road was found least bothered when pedestrians were crossing roads amid light and heavy vehicles plying haphazardly.

At times, traffic was crossing the intersection from all directions at once.

Trishna Bhattacharya, a schoolteacher, said she often faces difficulty in crossing the street with her five-year-old daughter. "Look at all the vehicles standing in the middle of the road. I'm afraid they might start moving as soon as I start to cross."

"Most of the time, we see on-duty traffic police not doing anything to bring the situation under control," she alleged.

Jahangir Alam, who regularly commutes through Tigerpass, Lalkhan Bazar and Dawanhat intersections to go to office in Agrabad from his home in Chawkbazar, said, "Minibuses often race each other to pick up passengers. But police remain indifferent and hardly take any action."

BANGLADESH BANK HEIST CID directed to submit probe report by Feb 10

A Dhaka court yesterday directed Criminal Investigation Department (CID) to submit by February 10 probe report on a case filed over the cyber heist of \$101 million from Bangladesh Bank's account in 2016 -- one of the biggest cyber crimes in the world.

Metropolitan Magistrate Sabbir Yasir Ahsan Chowdhury passed the order after Md Raihan Uddin Khan, an additional superintendent of CID and also the investigation officer of the case, failed to submit any probe report yesterday.

With this, CID took over 56 dates for completing the investigation into the matter.

Drug dealing jailer denied bail

The High Court yesterday denied bail to Chattogram Central Jail's suspended jailer Sohel Rana Biswas, who was arrested last October with nearly Tk 3 crore in FDRs and cash and bottles of contraband Phensedyl.

The bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam also issued a rule asking the government to explain in four weeks as to why bail should not be granted to Sohel in the money laundering case filed against him.

The HC bench issued the rule after hearing a bail petition filed by Sohel.

On October 27, Sohel was arrested on the Bijoy Express train while he was on way to his hometown in Mymensingh from Chattogram.

Searching Sohel's belongings, police recovered fixed deposit receipts (FDRs) worth around Tk 2.50 crore, Tk 44.43 lakh in cash and 12 bottles of Phensedyl.

Police later filed two separate cases with Bhaierab Railway Police Station against Sohel under the Money Laundering Act and Narcotics Control Act, he said, adding that in January, Sohel filed a petition with the HC, seeking bail in the money laundering case.

Advocate Adnan Rafique represented Sohel in the hearing yesterday.

Everyone is requested to pray for the salvation of the departed soul.




Women rights activists bring out a procession in Jatiya Press Club area yesterday, demanding exemplary punishment for the culprits involved with the Noakhali gang-rape.
