NOAKHALI GANG-RAPE

2 accused give confessional statements

Two persons including the key accused gave confessional statements to a court over the incident of gangrape in Noakhali's Subarnachar yesterday.

Judge Nobonita Guha recorded the statements of Sohel, the prime accused, and Jasim Uddin, another suspect.

Earlier on Monday, two other accused gave their confessions before the court.

The 35-year-old woman was gangraped in the early hours of December 31, allegedly by 10 to 12 ruling party activists, as she voted for "sheaf of paddy", electoral symbol of the BNP.

According to the victim, the men entered her home by cutting the fence around her house. They then tied her husband and four children with ropes, after which they took the woman

outside the house and raped her. The victim also said the rapists threatened to kill her husband and

children and torch their house if she told anyone about the rape.

After the incident, the victim's husband filed a case against nine people.

The husband said the victim went to cast her vote around 11:00am on

The deportees arrived at Hazrat Shahjalal International Airport around 2:00am on Tuesday on a Saudi Arabian Airlines flight. They were detained following their admission that they were Rohingyas, immigration police said.

Nay San Lwin, a Germany-based Rohingya activist with links to Rohingyas in Saudi Arabia, said more than 1,000 Rohingyas have been kept in detention camps in the kingdom for years for violating

immigration rules, including overstaying their visas. He said the Rohingya activists are

approaching European governments to halt the deportation of Rohingyas from Saudi Arabia. He urged the Bangladesh govern-

ment not to detain them, but to instead send them to the refugee camps in Cox's Bazar on humanitarian grounds as they were victims of persecution in Myanmar's Rakhine

The Rohingyas, who have been denied citizenship in Myanmar since 1982, fled different waves of violence there and came to Bangladesh. The latest atrocities caused some 750,000 Rohingya to flee to Bangladesh, making it a global cri-

The DC said Mostafa called Azizul over phone, called him to his home and planned the rape instantly. Mostafa went to the girls and lured them to his house. His wife and child were away.

The accused are drug addicts and Mostafa was also accused in a robbery case filed with Jatrabari Police Station, he said.

Dhaka court that her father, Nahid, killed a two-year-old baby by throwing her off the second floor of a building in Gendaria on Saturday. In her statement, the girl, 12, said

she went to her father's room, hearing the victim's screams. Minutes later, the man killed the baby, said DC Farid. "The circumstantial evidence sug-

gested that Nahid took the baby in his house to rape her," the police officer said, adding that they recovered the baby's clothes and a doll from the scene. Earlier, locals had staged a demon-

stration in Gendaria, demanding capital punishment for Nahid over the incident.

According to the parliament's rules of procedure, the duration and proceedings of the first session will be finalised at a meeting of the business advisory committee of parliament with the speaker in the chair on the same day.

The new lawmakers took oath on January 3 and the 47-member cabinet was formed on January 7 with Sheikh Hasina as the prime minister.

Hasina has been elected Leader of the House for the 11th parliament while Jatiya Party Chairman HM Ershad will be the leader of the opposition.

The ruling Awami League won the two-thirds majority again in the December 30 parliamentary election. It won 257 seats while the Jaitya Party bagged 22 seats.

Around 266 MPs will sit on the treasury benches consisting of MPs belonging to the AL, Workers Party, Jatiya Samajtantrik Dal, Jatiya Party (Manju) and Tarikat Federation.

The treasury bench will get even bigger this time as it will be joined by more than 44 out of the 50 would-be MPs from reserved seats for women.

Alongside 22 JP lawmakers, three independent MPs will sit on the opposition benches. Seven lawmakers elected from the

BNP-led Jatiya Oikyafront are yet to take their oaths. Meanwhile, the Jatiya Party, which

played a dual role in the 10th parliament having represented both the government and the opposition, has decided to sit only in the opposition bench. The 10th House sat for 410 days in

23 sessions and passed 193 bills with little or no opposition from the then opposition Jatiya Party. Formed through the largely one-

sided election on January 5, 2014, the 10th parliament sat in its maiden session on January 29 that year and is valid till January 28, 2019.
