connection with the Maj Gen Abul Manzur murder case. Judge Prodip Kumar Roy of First Additional Sessions Judge's court of Dhaka passed the order following a petition filed by CID Special Superintendent Abdul Kahar Akond. With the latest petition, CID has sought

time extension in the case for

the 20th time. Maj Gen Abul Manzur, commander of sector-8 during the Liberation War, was killed in Chattogram Cantonment on June 1, 1981, two days after the assassination of the then

president Ziaur Rahman. A case was filed by Abul Manzur's elder brother Abul Mansur Ahmed on February 28, 1995.

According to the chargesheet, Jatiya Party Chairman HM Ershad, the then chief of army staff, has been named as the prime accused.

Boy found dead in abandoned house

Police think he may have been strangled after rape; prime suspect on the run

A schoolboy was found dead in Shiddhirganj area of Narayanganj yesterday, with law enforcers suspecting that the seven-year-old was strangled after rape.

Police recovered the body of 7-year old Tanjil Ahmed from an abandoned house, a day after he had reportedly gone missing.

A kindergarten student of Rasulbag Model School, Tanjil used to live with his parents in a rented house in Rasulbag area of Shiddhirganj, said police.

His father is a day labourer and mother garment worker. The couple used to leave their son with one Raju, 30, a caretaker of their landlord, Shiddhirganj Police Station Officerin-Charge Shahin Parvez quoted the victim's father Anwar Hossain as saying.

His parents did the same while going to their workplaces on Wednesday morning, said the OC.


On return, the couple did not find their son or Raju, said the police officer.

Police rushed to the spot yesterday after Tanjil's father went to the police station to file a general diary (GD). The law enforcers found the body in an abandoned

house, near the victim's residence. Raju could not be found in the area, the OC said, adding that they suspect he might be responsible for the death, and are trying to arrest him. The body was sent for autopsy. Reasons behind the death

will be known after the post mortem, he said.

Filing of a case was underway until filing of this report.

Over half of Rajshahi brick

kilns illegal ACC finds STAFF CORRESPONDENT

At least 1,144 out of the 2,000 brick kilns in Rajshahi division are running without environmental approval, anti-graft

officials found yesterday. A three-member team of Anti-Corruption Commission (ACC) led by

local deputy director Md Anwarul Haq conducted a drive at Rajshahi divisional office of the Department of Environment (DoE) in Bogura, and found 11 out of total 20 environment officials absent from work

The anti-graft officials conducted the drive after local businessman including brick kiln owners complained of bribery and harassment by DoE officials while obtaining environmental clearances.

"Corruption related to environmental clearance undermines environmental governance and it would be prevented firmly," said Mohammad Munir Chowdhury, ACC director general and lead coordinator of the enforcement drive.

the "irregularities and graft" in the judiciary.

"The media can find out if there is any," he said while talking to journalists after the High Court rejected a writ filed challenging the oath-taking of the newly elected lawmakers.

He also said most judges of the High Court and lower court are honest, sincere and loyal to the law. "However, there is an opposite situation also."

On February 4 last year, Attorney General Mahbubey Alam had said that the "judiciary has seen degradation" over the years with large number of staffers becoming involved in corruption.

EVICTING HAWKERS FROM FOOTPATHS

No probe report, a year after attack on N'ganj Mayor Ivy

One year has passed since the attack on Narayanganj city Mayor Selina Hayat Ivy over evicting illegal hawkers from footpaths, but the committee formed to investigate it yet to submit its report.

Moreover, there is no certainty when it might be completed as a member of the committee has been transferred.

A three-member probe body, which was formed on January 17, 2018, a day after the attack, was supposed to submit a report within seven working days. The deadline has been deferred four times.

The committee's chief, Narayanganj Additional Deputy Commissioner (Revenue) Jasim Uddin Haider said it is uncertain when they would be able to submit the probe report. Other committee members were: then

additional superintendent of police of the district Mostafizur Rahman, and Rab-11 assistant director (ASP) Babul Akhter. "When we were at the final stage of the

investigation, Mustafizur Rahman was promoted to SP and transferred to another district. It has slowed down our investigation process," said Jasim Uddin.

"Nothing can be said about submission of the probe report until the committee is reconstituted," he told The Daily Star.

Replying to a question, he said the deputy commissioner (DC) of the district has the jurisdiction to reform the probe committee.

However, this correspondent could not

reach DC Rabbi Miah despite repeated attempts. He did not even respond to an SMS sent by the reporter.

On December 25, 2017, the city corporation launched a drive to clear the footpaths.

Soon afterwards, the hawkers started a continuous movement to persuade the city corporation to reconsider the decision. But, Ivy said she would not bow down to the demand as "footpaths belong to people".

But Lawmaker Shamim Osman took a stance against the mayor's decision. Things took a violent turn on January 16 during Ivy's procession to free the footpaths. Osman's supporters attacked Ivy and her followers, leading to a clash on Bangabandhu Road in the city's Chashara area.

The entire area turned into a battlefield. During the skirmish, Ivy and around 50 others were injured.

After the clash, the footpaths remained free from hawkers due to vigorous drives by law enforcers for the next couple of months. But later, hawkers started sitting on footpaths due to relaxation of action.

Contacted, Superintendent of Police in Narayanganj Harun-ur-Rashid said, "The Chashara intersection has already been freed from hawkers. Other footpaths will also be cleared in phases. People will walk on the pavements. These cannot be occupied by hawkers. We will maintain zero tolerance policy on this matter."

When contacted, Mayor Ivy refused to comment over the issue.

Seven killed, 44 injured

On information, Fire Service and Civil Defence personnel rushed to the spot, rescued the injured and sent them to local hospitals. Of them, conditions of seven people are critical, he added.

Meanwhile in Noakhali, two unidentified persons were killed and 15 others injured as a bus plunged into a ditch on Choumuhoni-Feni road in Begumganj upazila on Wednesday night, UNB reports.

The accident took place around 10:00pm when one of the tyres of a Fenibound bus of Sugandha Paribahan got punctured and the vehicle plunged into a roadside ditch, leaving two dead on the spot and 15 others injured, said Firoz Alam Molla, officer-in-charge of

Begumganj Police Station. The injured were taken to a local hospital. No further details were known immediately.
