

# Shops in the middle of the road?

## CDA's plans to rent out space under ramp of Aktaruzaman flyover draws flak

Chittagong Development Authority's (CDA) decision to rent out space under Aktaruzzaman flyover's ramp -- on dividers of a major road of the port city -- in an apparent bid to manage maintenance cost of the flyover, has drawn flak.

Town planners have termed the decision suicidal, saying it will heighten risk of accident for pedestrians, and will exacerbate traffic tailbacks, while Chattogram City Corporation (CCC) has termed the decision "illegal".

CDA published a circular in local dailies on December 24, inviting prospective businesses to apply by January 24 for renting space under Aktaruzzaman flyover's ramp, in Muradpur, Gate no. 2 and Lalkhan Bazar areas.

CDA wants to build 13 shops and three super shops on the aforementioned spots, according to the circular.

CDA sources, preferring anonymity, said the initiative is aimed at generating funds for the maintenance cost of the flyover,

which is about Tk 12 lakh a month. They also said each shop will be 132 square feet in size, while the super shops are planned at 7,000 square feet each.

The spaces under the ramp of the flyover are currently being used as free parking spots.

Road safety expert Professor Dr Shamsul Haque told The Daily Star that the decision will create safety hazards.

"These shops will invite pedestrians, who will be encouraged to cross the busy thoroughfare haphazardly. They will be prone to accident when they cross the road to reach the shops as well as when they step out of the shops," he said.

Vehicles will be forced to slow down by the pedestrians, he added, saying the decision will be counterproductive at a time when government is trying to stop jaywalking and haphazard crossing on busy roads.

Contacted over phone, CDA Chairman Abdus Salam claimed it would not impact anything.

"We constructed the flyover through proper

# Ensure sustainable dev of char residents

## National Char Alliance urges govt

National Char Alliance (NCA) yesterday urged the government to form a "Char Foundation" in order to ensure sustainable development of the people living on char (shoals) in the country.

NCA also demanded formulation of a specific development project and "National Char Policy" to ensure their rights.

The platform, advocating rights of char people in national-level policy, placed these demands at a press conference on "Expectations of char people from the newly-formed government" at the capital's Jatiya Press Club.

NCA in collaboration with Shamunnay and Swiss Agency for Development and Cooperation organised the conference.

Reading out a statement, Jahid Rahman, member secretary of NCA, alleged that people of the shoals are deprived of their fundamental rights.

"They are not getting opportunities when it comes to education, healthy food, modern sanitation, medical facilities and minimum social security. The government should form a 'char foundation' to address the issues," he said.

In his speech, NCA Chairman Khondokar Ibrahim Khaled claimed that the government is yet to ensure minimum amenities for char residents, though these marginalised

# Free textbooks on sale!

## One arrested with 283 books for school and madrasa students

Free textbooks for primary and high school students, provided by National Curriculum and Text Book (NCTB) authority, are being sold in port city markets.

Dodging the eyes of the authorities concerned, some unscrupulous businessmen are selling the books, according to police and market sources.

The issue came to light after members of Detective Branch (DB) of Chattogram Metropolitan Police (CMP) arrested a book seller from the city's Andarkillah book market area with 283 free textbooks on Sunday night.

The arrestee was identified as Snehashish Talukdar, 28. He is a staff member of Prakash Bichitra, a book shop at Wali Mansion of Andarkillah book market area, said Inspector Elish Khan of DB.

"Tipped off, a team of DB police raided the book shop and detained Snehashish, seizing books meant for

free distribution among students," said Inspector Elish.

"During primary interrogation, the arrestee told the police that he and cohorts used to collect the free books from primary schools and madrasas and later sold them to students of private schools," the inspector told The Daily Star.

The owner of the book shop Debashish Talukdar is on the run following the incident, Elish said.

According to the district education office sources, educational institutions need to provide the list of their students to both primary education office and district education office for free books. As per the list, the authorities provide books to the institutions.

Police and district education office sources said a section of educational institutions have been collecting extra textbooks from district education office showing more students on the list than the actual number. These books end up in the market with the

help of unscrupulous school staff.

Chattogram District Education Officer Mohammad Jasim Uddin told The Daily Star, "We provided the textbooks as per lists provided by educational institutions...We verify a list when there's any allegation."

"We have already held a meeting where I asked the officials to verify the information," said Jasim Uddin.

Md Amirul Kaiser, additional deputy commissioner (ADC) (Education and ICT) of Chattogram District Administration told the newspaper, "District administration coordinates the free textbook festival and they will raise the issue in their next coordination meeting."

Kazir Saber Ahmed, general secretary, Chattogram chapter of Bangladesh Publishers' and Book Sellers' Association, told this correspondent, "Selling of free textbooks is strictly prohibited by our organisation. If anyone violates the law, he will have to take the responsibility."

## Cabinet committee reconstituted

The cabinet committee formed to review the Ninth Wage Board Award -- for journalists and employees working in newspapers and news agencies -- has been reconstituted, keeping its terms of reference unchanged.

A proposal for the reconstitution of the cabinet committee was approved at the maiden cabinet meeting of the newly formed government, held with Prime Minister Sheikh Hasina in the chair at her office.

Cabinet Secretary Mohammad Shafiul Alam briefed reporters at the conference room of the Cabinet Division at the Secretariat after the meeting.

He said Road Transport and Bridges Minister Obaidul Quader will lead the seven-member committee as its convenor. The other members of the committee are Home Minister Asaduzzaman Khan, Agriculture Minister Dr Abdur Razzaque, Information Minister Dr Hasan Mahmud, Industries Minister Nurul Majid Mahmud Humayun, State Minister for Cultural Affairs KM Khalid and State Minister for Labour and Employment Begum Monnuzan Sufian.

According to the terms of reference, the committee will submit its report by January 28, 2019.

# Bird-poaching rampant in wetlands

Indiscriminate hunting, trapping and selling of local and migratory birds at different upazilas in Sylhet is posing a serious threat to nature and biodiversity.

Rampant poaching by professional and amateur hunters gets quite unruly during winter, starting from mid-October to mid-March, all over the division.

During this time, the wetlands in higher altitudes dry up, and local birds from the hills fly down to flat wetlands, bottom hillocks and open fields, making them easy targets for poachers.

Moreover, migratory birds from different parts of the world come to Bangladesh, especially to wetlands known as "haor" and "beel".

Larger wetlands like Hakaluki Haor and Baikka Beel in Moulvibazar and Tanguar Haor in Sunamganj host the largest number of migratory birds; while smaller haor and beel spread around the division also host a smaller portion.

Local breeds of wild birds like bittern, egret and Asian openbill stork are also seen in these wetlands.

Environmentalists claim that due to the demand of birds, lack of social

awareness about poaching, and rare legal action, poachers consider this an open season for hunting and selling.

In Sylhet, bird poaching is rampant in Tahirpur and Dharmapasha upazilas in Sunamganj; Jaintiapur, Gowainghat, Kanaighat, Beanibazar and Fenchuganj upazilas in Sylhet; Barlekha, Kulaura, Shreemangal, Rajnagar and Komolganj upazilas in

Moulvibazar; and Sayestaganj, Bahubal, Madhabpur, Nabiganj and Baniachang upazilas in Habiganj.

Abdul Karim Kim, general secretary of Bangladesh Paribesh Andolon's (Bapa) Sylhet chapter, said, "Poachers are mainly hunting different kinds of local and migratory birds like wild ducks, Indian Pond Heron (kani bok),

# Six Rohingyas detained in Sylhet

## Police says the family entered Bangladesh from India through Zakiganj border

Sylhet Metropolitan Police (SMP) detained a family of six Rohingyas, including three children, from Kadamtali Bus Terminal area in Sylhet city on Sunday night.

They were sent to the Kutupalong refugee camp in Cox's Bazar under police escort yesterday afternoon.

Zedan Al Musa, additional deputy commissioner (media) of SMP, said the detained Rohingyas entered

Bangladesh from India through Zakiganj border.

They hailed from Saheb Bazar of Arakan state of Myanmar, he quoted the detainees as saying.

The SMP official said, "They told us that they fled their home village months ago and entered India, while some of their relatives entered Bangladesh. After passing time at Guwahati of Assam, they crossed the border to Bangladesh through Zakiganj".

"We could not get the informa-

tion on how they crossed the border, but they might have managed it through a broker. After they reached Sylhet, locals identified them as Rohingyas and informed police. It took us a while to cross-check their identity," he said.

"We have contacted their relative Sheikh Ahmed at Kutupalong camp in Cox's Bazar, and sent them to the camp under police protection. They will be questioned by police there," Zedan Al Musa said.

might have been killed with an object like hammer, police said.

The CCTV cameras were found broken but police are trying to recover footage to identify the killer(s), Bilkis said, adding it has not been found yet whether any money was stolen from the ATM machine.

"We rushed to the ATM booth hearing screams, and saw the body in a pool of blood. The body was covered with a blanket up to neck," Billal Hossain, security guard of a nearby building, said.

The victim's co-worker Waliullah, who went to the booth to start his shift at 6am, first noticed the body, Mohammad Ali, from Elite Security Services, said.

"We talked to each other at around 1:30am, sitting inside the booth. Everything seemed fine then," he said.

"He [Shamim] never spoke of any threat or problem with anyone," he said.
