attack on Khasis

Ethnic Khasi people filed a case with Barlekha Police Station in the district against 10 named people yesterday for torching three houses and cutting down 400 betel leaf plants early Sunday, allegedly to grab Khasi land in Nalikhai punjee.

"I was sleeping when my husband called me after seeing the fire. We ran out of the house without taking anything. The utensils in the house were destroyed. We are poor people and betel leaf is our only source of earning, but the plants have been cut down," said Pravita Dio, a resident whose house was burnt.

"I filed a case with the police station in this regard against 10 named people, including Shakil Ahmed, assistant manager of Chutolekha tea garden. Shakil ordered the burning of our houses and cutting of betel plants," she added.

"Seeing our houses on fire, Eju Chisham, 50, and I ran away from the houses with our families. Then we took shelter in the punjee headman's house. It was not possible to douse the fire on the high hills because of lack of water. As a result, the rooms kept burning in front of our eyes. The tin-shed houses were completely burnt down," said Achin Patro, 25.

Headman of Nalikhai punjee Tolby Lamin said there was massive damage to all the items in the three houses and around 400 trees were cut down.

"We are deeply distressed following an attack by a gang of criminals who targeted the punjee's betel leaf plantations. Indigenous people believe the attack was instigated by Chutolekha tea garden authorities following an earlier altercation between residents over grabbing our land. This was a planned attacked to grab our land," he added.

Central member of Bangladesh Paribesh Andolon (Bapa) Father Joseph Gomes OMI said it is the responsibility of the state to ensure security of the Khasi community. The state should take urgent action against the perpetrators. He said environmentalists, civil society and punjee peo-

ple demand immediate arrest and exemplary punishment of the people involved in such a heinous act. Mohammad Mukaram Hossain, manager of Chutolekha tea garden, refuted the allegations. "Khasi people grabbed

our land," he said. "I visited the punjee after hearing the news. Three houses were burnt and 400 betel leaf plants were cut. The victims filed a case against 10 people," said Barlekha Police Station Officer-

in-Charge (investigation) Mohammad Jasim Uddin. Sanjeeb Drong, general secretary of Bangladesh Indigenous Peoples Forum, told this correspondent that Khasi people have not been getting justice in the matter for a long time, adding that the land belongs to them as per ILO Convention-107.

Land rights of plain land indigenous people cannot be protected under the current land laws of the country, so the government should form a separate land commission immediately, he said.

Case filed for arson 32 schools run with few students

Although Mayda Government Primary School under Amragachhia union in Mirzaganj upazila was established in 1940, the institution is facing serious student

During a visit to the school on January 12 this correspondent found only three students were present in the school, but the school head teacher Farida Yesmin claimed a total of 30 students are currently studying there while the number was 24 in 2018, 35 in 2017 and 33 each in 2016 and 2015 from Class I to Class V. Due to troublesome communication

most of the students in the area prefer to take admission in other nearby schools, she claimed, adding that there are currently three teachers working there against five posts. Department of Primary Education (DPE)

recently issued a show cause notice to the school asking the school authorities why the number of students is so low.

If the number of students is not increased the school will be unified with another nearby school, says the show cause notice. Department of Primary Education set up

Pochakoralia Government Primary School at Pochakoralia village in Patuakhali Sadar upazila under a project titled 'Establishment of 1500 Primary School in Un-Schooled Areas' spending Tk 14 lakh in 2011-12 fiscal year.

The institution started its activity in 2014 with only 14 students while the number was 28 in 2015, 40 in 2016, 36 in 2017 and 49 in 2018.

While visiting the school on January 10 this correspondent saw only 22 students attending their respective classes though its headmaster Abdul Kuddus claimed that a total of 62 students took admission this year.

As the area is very small and the family members, mostly ultra poor, work in the capital for livelihood there are hardly any children to study in schools, he added.

Meanwhile, Purbo Telikhali Government

Primary School, established in 1994 and schools in all the upazilas of the district. nationalised in 2013, in the upazila also received the same notice.

Headmaster Rina Parvin said her institution is surrounded by at least five Nurani or Hafejee Madrasas and most of the children in the area take admission there, adding that they have sent a reply of the show cause notice to the authority concerned.

Like Mayda, Pochakoralia and Purbo Telekhali Government Primary Schools a total of 32 primary schools, including 22 in Patuakhali and 10 in Barguna, were served the same show cause notice while a total of 650 schools across the country got the same.

According to Patuakhali Primary Education Office there are 1,225 primary

Natural gas from tubewell, govt inquiry demanded

Natural gas is coming out from a tube-well set up at a village in Bhandaria upazila.

On December 6, locals found the existence of natural gas when a tube-well was being installed at the house of Delowar Hossain at Shinghakhali village of the upazila.

"After a pipe went 35 feet to 40 feet below the surface, a fire started burning as the water of the tube-well came in touch with a burning cigarette. We put out the fire with a thick, wet cloth," Delowar said.

gas begins to burn," he said. But after installing the tube-well they are not using the water from it.

Delowar circulated the matter locally and informed the local administration. But no step has been taken by the government authorities even one and a half months after the incident.

"We are afraid as the gas may cause accident in our area," Delowar said.

"We urge the government to investigate the matter and see if there is natural gas in our village. If gas is found, the government can use it in our area as well as other places," he said.

Around two years ago, "When we draw water from the Rahman, a teacher by profession, tube-well, natural gas bubbles out. found the existence of gas after When fire comes in touch with it, the installing a tube-well in his house. But he did not disclose the matter. Rather, he kept it hidden by block-

ing the tube-well.

"I thought if the matter comes to light, I may face trouble," said Khalilur, adding that he is not willing to install the tube-well as gas comes out and they cannot use the water coming from it.

"Failing to set up a tube-well, people of our village use water from unsafe sources like ponds and canals," said another local Abdus Salam Sikder, adding that, their suffering increases in the winter as the water level decreases at these water sources.

Pirojpur Deputy Commissioner Delowar's neighbour Khalilur Abu Ali M Sazzad Hossain said he is aware of the matter.

'Colourful corn to resist cancer'

Eminent scientist Dr Abed Chaudhury has developed a colourful corn which may work like cancer resistant drugs.

The corn was developed by genetic modification. It can also meet the nutritional needs.

The scientist said this to this correspondent at his house in Hazipur area of Kulaura upazila yesterday.

On Sunday afternoon, Chaudhury exchanged views with farmers and talked about the new colourful corn at a meeting organised by Kulaura Upazila Parishad.

Chaudhury said that nutrien content of colourful corn is very high compared to rice and wheat. It can be called new nutrition.

"It has a lot of keratin as its colour is yellow. I developed the colourful corn by cloning," he said, adding that the colourful corn is like cancer resistant drugs. It's especially for the children who like it very much. If the

children eat corn, their nutritional needs will be fulfilled easily. This colorful corn can be cultivated four times

a year, he said. Dr Chaudhury also distributed corn seeds to encourage farmers in Kulaura upazila as everyone


can do maize cultivation on their fallow land. He said, "I made it suitable to cultivate in our country environment".

He further said, "I had been abroad for a long time. I served in different countries of the world. Now I want to give that service to my country."
