BB to crack down on habitual defaulters

Wants amendment to laws, will hold meet with bank MDs and experts on Feb 6

The central bank has moved to reform the existing acts to clamp down on habitual defaulters, whose tendency to go to courts to stall paying back loans has sent the sector's non-performing loans to an alarming

As of September last year, the ratio of NPLs stood at 11.45 percent of the total outstanding loans. In terms of amount, it is Tk 99,370 crore.

The Bangladesh Bank is set to hold a meet-

ing on February 6 with banks' managing directors. Law Commission Chairman ABM Khairul Haque and Bangladesh International Arbitration Centre CEO Muhammad A (Rumee) Ali will explore all legal routes with a view to handing out exemplary punishment to habitual defaulters.

When banks step in to realise the defaulted loans the habitual defaulters go to courts, thwarting the move, said a BB paper. The trick used by the habitual defaulters has created an impediment to recovering the default loans.



Ahmed Bhuiyan, a deputy attorney general. "There is an urgent requirement to reform the money loan court act to reduce NPLs," he added.

Subsequently, the BB has asked the banks' MDs to place their opinions on how to speed up recovery of default loans and ensure exemplary punishment for habitual defaulters at the meeting on February 6.

"We will give probable solutions upon hearing the proposals placed by banks," Haque told The Daily Star.

mortgaged assets when defaulters fail to make payment in line with verdicts, according to Bhuiyan. In most of the cases, the banks fail to find buyers for the mortgaged assets, fearing it may invite trouble for them in future, he said.

GP logs record profit

Grameenphone logged a record Tk 3,520 crore profit last year, its highest to date, driven by significant growth in voice and data revenue.

The profit is 28.47 percent higher than what the largest mobile phone operator in the country posted a year ago.

This led GP to recommend Tk 28 in dividend per share for the full 2018. The shareholders as of the record date of February 17, 2019 will be entitled to the final dividend, subject to the shareholders' approval at the 22nd annual general meeting scheduled for April 23.

The operator said revenue grew 3.4 percent to Tk 13,280 crore in 2018. Data revenue grew 21 percent to Tk 2,550 crore and voice call revenue was up 6.6 percent.

EPZ labour law gets final nod from cabinet

The cabinet yesterday gave the final approval to amendments to the Bangladesh EPZ Labour Act, which relaxed the labour law for the export processing zones to ensure better rights for workers employed in factories housed inside the special industrial parks.

The draft law was approved in principle by the cabinet on December 3 last year.

After the cabinet meeting, Cabinet Secretary Md Shafiul Alam told reporters that the draft law got the final nod yesterday without any change.

The EPZ workers will now enjoy the freedom of association to realise their demands, according to the new amendments to the Bangladesh EPZ Labour Act. Earlier, 30 percent

Association (WWA) in a factory in the EPZ. The requirement threshold has been lowered to 20 percent because of the pressure from international communities such as the EU, Canada, the International Labour Organisation and the US.

workers' consent was required to form a Workers' Welfare

The names of the WWAs have not been changed; the existing WWAs will act like unions.

The amendment will allow the officials of the Department of Inspection for Factories and Establishments to inspect the factories housed inside the EPZs apart from the officials of Bangladesh Export Processing Zones Authority (Bepza).

Previously, only Bepza officials could inspect the factories. The amendment also allowed the workers to constitute federation of WWAs. The mandatory required consent of the workers for calling strikes and lockouts has also been lowered.

Int'l luxury cruise ship sailing thru' Sundarbans

An international luxury cruise ship is now exploring the Sundarbans -- a development that can give a boost to tourism as it goes about showcasing the country's natural beauty.

Silver Discoverer, one of the 10 ships of global cruise operator Silversea Cruises, entered the largest mangrove forest and will explore the deep forest until tomorrow.

The vessel with 61 foreign tourists, mainly from the US, will then leave for Maheshkhali and St Martin's Island.

It will proceed to Ngapali, a beach town in Myanmar's Rakhine State, and end the cruise at Yangon, said officials of the Department of Shipping (DoS) and its local ground handling operator Journey Plus.

The ship is scheduled to do two more voyages between Yangon and Chennai, touching the Sundarbans, next month, said Taufiq Rahman, chief executive of Journey Plus.

Some 72 tourists, mainly from the UK, have signed up for the cruise starting on February 12.
