Risky boat ride to attend school

Villagers, especially school goers, have been suffering a lot due to lack of a bridge on a canal at Motherbunia in Rangabali upazila for years.

Students have to go to school at nearby Rasulbaria village by boat and they have to pull a rope for the purpose.

There is no primary school at Motherbunia, a remote village, where over 1,000 people live, said locals.

There are more than 50 school going children at the village. Guardians have to send their children to Rasulbaria Government Primary School by boat amid risk of accident.

Moreover, villagers have to go to the upazila headquarters and the district town crossing a 200-foot-long canal that flows between the two villages.

Serajul Islam, a resident of Motherbunia village, said country boat has been their only means to cross the canal for long.

A rope is tied to trees on both sides and students and villagers cross the canal on a boat by pulling it. Local people arranged it voluntarily, he said.

"Most of us can't run the boat and due to this, our guardians arranged the system," said Mitu Akhter, a fifth grader.

Another villager Hasem Sikder said

despite repeated pleas the authorities concerned are yet to take any steps to build a bridge on the canal.

Abu Zafar, headmaster of the primary school, said a bridge should be constructed on the canal considering the trouble of school goers as they have to come to the school by a boat amid risk of accident.

Upazila Education Officer Md Golam Sagir said he will raise the issue at the upazila development committee meeting to resolve the problem.

Md Delwar Hossain, chairman of the upazila parishad, said he will take steps to build a bridge on the canal as soon as possible.

Boy held for selling fake SSC question papers

Rapid Action Battalion (Rab) detained a teenager from Dhaturpohela village under Akhaura upazila of the district yesterday for his alleged involvement in selling fake question papers of the ongoing SSC examinations.

The detainee, Sohag Mia, 15, son of Monir Mia of Shibnagar village of the upazila, is a Class IX student of Devgram Pilot High School in Akhaura municipality, Chandpur Debnath, senior assistant director of Rab-14 at Bhairab Camp, told newsmen at Brahmanbaria Press Club at 3:00pm.

"Sohag admitted that he had purchased question papers when he was a JSC examinee last year and afterwards himself became involved with the cheat gang," he said.

"He was selling fake SSC question papers to candidates at Dhaturpohela when Rab members nabbed him by using technology. A case against him has been filed with Akhaura Police Station under ICT Act," said the Rab official.

Drug addict kills father, injures mother Accused sent to jail

A man was killed and his wife sustained injuries in an attack allegedly by their drug addict son at Anakhanda village in Shariatpur's Naria upazila on Sunday.

The deceased was Rahim Bepari, 50, of the village. Injured Piyari Begum was admitted to Shariatpur General Hospital.

Abdul Salam Bepari, a member of Bhojeshwar Union Parishad (UP), said Nayem Bepari, 20, used to quarrel with his parents to get money for buying drugs.

Hearing screams, neighbour Salam rushed to the house of the victims on Sunday afternoon and found them in a pool of blood. At that time, Nayem stood there with a sharp weapon, said the UP member.

On information, police rushed to the spot and arrested Nayem. The victims were sent to the hospital where on-duty doctor declared Rahim dead.

Rahim's elder son filed a case, accusing Nayem, said Monzurul Haque Akand, officer-in-charge (OC) of Naria Police Station.

The arrestee was produced before a court that sent him to jail yesterday, said the OC.

Youth to die for killing former wife

A court here yesterday sentenced a youth to death for killing his former wife in 2016.

The convict is Suman Ali, 25, son of Amir Hossain of Choitanyapur-Miapara village in Shibganj upazila.

According to the prosecution, Suman often tortured his wife Farzana Akhter Sima over family issues since their marriage in 2012. The couple have two-year-old son Siam.

In December 2015, Suman divorced his wife at a local arbitration meeting.

After the incident, Suman tried to bring his son back with him several times but failed. He often harassed Sima for this.

2 crushed under train

Two youths were crushed to death under the wheels of a running train at Narundi Railway Station in the district on Sunday.

The deceased were Shimul Hossain, 22, son of Moazzem Hossain of Tulsipur village, and Abdur Rahman, 20, son of Hamidur Rahman of Narundi village in Sadar upazila.

The two left Dhaka for Jamalpur Railway Station, said Taposh Chandra Pandit, officer-in-charge of Jamalpur Railway Police Station.

The train slowed down a bit while passing Narundi station around 10:00pm.

At that time, the duo got down from the running train, but unfortunately went under the wheels of the train. Shimul died on the spot.

Critically injured Rahman died on way to Jamalpur General Hospital, said the OC, adding that there was no scheduled stoppage of the train at Narundi station.

An unnatural death case was filed with the police station in this connection, said the police official.

Worker electrocuted

A worker was electrocuted and three others were injured at Mukhoria village in Achintapur union of Gouripur upazila yesterday.

The deceased was Mahbub Mia, 27, of Kunihat village in Kendua upazila of Netrakona.

Mahbub and three other workers came in contact with live electric wire when they were working for a contractor of Palli Bidyut Samity at Mukhoria village, Gouripur Police Station OC Abdullah Al Mamun quoted locals as saying.

Hearing screams, locals rescued them and took to Gouripur Upazila Health Complex where doctors declared Mahbub dead.

Female cattle farmers struggle for solvency

A good number of women in char (landmass emerging from riverbed) areas of Teesta and Dharla rivers are now engaged in cattle rearing to bring solvency to their families.

Aklima Begum, 44, wife of Nehar Uddin of Char Kalmati on the Teesta river in Sadar upazila, said she gets up early in the morning and goes out with four cows and three goats for grazing them in the char area after preparing food for her six-member family and returns home at dusk every day.

"My two minor daughters also accompany me for rearing cattle in the char. It is our regular routine," said another woman Nurjahan Begum, 47, of the same char.

"I also collect grass for a milk cow in the house," she said, adding that rearing cattle in the char requires a lot of work.

"We have to walk eight to ten km in char areas for rearing our cattle every day," Nurjahan said, adding that she gets two litres of milk from the cow daily.

Farmer Haider Ali, 48, of Teesta river char Dabbari in Hatibandha upazila, said, "I go

to the crop field where I work daylong while my wife Sanjida Begum keeps busy rearing cattle in the char area."

"We get Tk 1.20 lakh to Tk 1.50 lakh from selling around 10 cattle every year and this is our major income which helps us mitigate poverty," he said.


Another farmer Nazrul Islam, 55, of the same char area, said they also earn by selling cow milk.

Teesta river basin Rajpur Union Parishad Chairman in Lalmonirhat Sadar Mofazzal Hossain Mofa said char women are struggling to bring solvency to their families by rearing cattle. They are engaged in rearing cattle in the char area from dawn to dusk.

With the additional income, they are now sending their children to the local schools, said the chairman.

District Livestock Officer Saidur Rahman said over 30 families in char areas have four to ten cattle each and char women are now earning better from rearing cattle.

"Our veterinarians often visit char areas and give the women necessary advice on rearing cattle," he said.

MOTHER'S REFUSAL TO ILLICIT PROPOSAL Three-year-old killed, uncle arrested

A three-year-old girl of the town was killed allegedly by her paternal uncle as the victim's mother rejected the latter's illicit proposal.

Additional Superintendent of Police Md Alamgir Hossain came up with the clue to the murder at a press conference in the town yesterday.

Halima, daughter of Amir Ali of Bhadughar area, was found murdered in the town on Saturday.

Halal Mia, 26, had been giving illicit proposal to Halima's mother for over a month. As the woman rejected, Halal along with his accomplice Rubel Mia, helper of a mason, planned to kill Halima.

On Saturday, Halal and Rubel lured the kid with potato chips and took her to a narrow lane in the area. Later, Halal strangled Halima.

The next day, police detained Halal and Rubel and during interrogation, they confessed to their involvement in the murder, said the police official.
