#### JU authorities using CCTV to identify 'molester'

Jahangirnagar University (JU) authorities are using closed-circuit television (CCTV) footage to find a man who allegedly physically molested a female student on campus on January 22.

The incident took place inside the university's new arts and humanities building. The victim, a female student of the university was on the staircase with another female classmate when a man came from behind. He hugged her and tried to touch her inappropriately, said the

victim. She has submitted a written complaint to the university authorities in this regard.

"The incident happened within 10 to 12 seconds. We also ran after him and screamed for help to catch him, but failed," she said, "How can someone dare to assault a female student in broad daylight on campus? If the culprit isn't punished, these incidents will never stop."

The written complaint has been handed over to anti-sexual harassment cel for further enquiry, said JU acting Proctor ASM Firoz Ul Hasan. "We have been trying our best to identify the man from CCTV footage and some still photos, he said.

"We have already filed a general diary with Ashulia Police Station and informed law enforcement agencies to help identify the culprit," he added.

#### 2 journos jailed for entering exam centre without permission

A mobile court yesterday sentenced two journalists to one-month imprisonment each for entering an exam centre at Bhanga Government KM College in Faridpur without permission from the centre secretary.

They are Saifullah Shamim, Bhanga upazila correspondent of the daily Bhorer Dak and daily Alokito Bangladesh; and Rabiul Islam, upazila correspondent of the Daily Janata, reports our Faridpur correspondent.

The mobile court was conducted by UNO Muktadirul Ahmad.

"The deputy commissioner of Faridpur visited the centre around 11am and saw that the journalists were taking photos and speaking to the examinees inside an exam hall. She asked for their permission papers but they did not have any. So the mobile court handed down the punishment to them," he said. Another mobile court in Madaripur fined

two teachers Tk 20,000 each for running coaching centres defying a government ban after Rapid Action Battalion (Rab-8) detained them in the morning, reports our correspondent. They are Jalal Uddin, assistant teacher of Kalkini Pilot Girls' High School, and

### Stop dumping of industrial waste in waterbodies

Savar residents urge authorities

Speakers at a discussion yesterday said that dumping of waste materials in rivers, canals and other waterbodies, in Savar -- by different industries including the newly relocated tanneries -- are causing severe pollution and posing health risks to residents.

The living conditions in Savar have deteriorated due to industrial pollution and indiscriminate waste dumping, they added, and urged authorities to take immediate steps to stop water and air pollution in the area.

Over 100 participants, mostly living in the Savar, participated in the discussion jointly organised by Association for Land Reform and Development (ALRD), Bangladesh **Environmental Lawyers Association** (Bela), rights organisation Nijera Kori, Transparency International Bangladesh (TIB) and several local organisations from Savar including Nodi O Poribesh Unnyan Parishad (NoPUP) at Village Education Resource Centre.

Authorities are overlooking the pollution problem in Savar, speakers said, adding that indiscriminate

dumping of tannery waste is spreading toxic gas in adjacent areas.

On the other hand, the waste dumping zone set up at Aminbazar area beside Dhaka-Aricha highway -- where wastes from the City Corporation is dumped -- is also hampering the environment, they

Syeda Rizwana Hasan, chief executive of Bela said around 50 industries in Savar were polluting three rivers, fifteen canals and other waterbodies.

"Bela would go to court if the authorities do not solve the environmental problems of Savar," she also said. Md Bosir Ullah, a resident of

Savar's Shadhapur area, said, "Once we used to catch fish in Beel Baghil, one of the largest waterbodies in Savar. Now it is almost grabbed, and polluted water is spreading various diseases."

"We used to cultivate crops using water from this waterbody, but now we cannot use it as the water has become severely polluted," he added.

#### Abducted girl rescued, 1 held in Gournadi OUR CORRESPONDENT, Barishal

Seven days into her abduction, a 12-year-old schoolgirl, was rescued by police on Monday night from Chandrahar bazar area in Gournadi upazila.

Police also arrested the abductor's accomplice Kaium Bepari, owner of a plumbing materials shop in the area, during a raid at his house in Chandrahar village of the upazila.

Police first arrested Kaium and rescued the girl from a location revealed by him during primary interrogation, said Mahabubur Rahman, investigation officer at Gournadi Police Station. On February 2, the girl's

father filed an abduction case against Kaium and Hero Chaprasi, the prime accused who is also an employee at Kaium's shop, with the police station.

The girl was sent to Barishal Sher-e-Bangla Medical College Hospital for tests and police were conducting raids to arrest prime accused Hero, said Golam Sorwar, officer-incharge of the police station.

## 5 get life term for raping 2 sisters

A court in Narayanganj yesterday handed down life imprisonment to five persons for raping two sisters in 2010.

Narayanganj Women and Children Repression Prevention

Tribunal Judge Mohammad Sheheen Uddin also directed the convicts to pay Tk 1 lakh each as compensation to the victims, reports our Narayanganj correspondent. The sisters were raped by miscreants in Santinagar area of

Sonargoan upazila on May 28, 2010. One of the victims filed a case accusing six persons the next day. Of the accused, one was acquitted. The main accused,

Sha Alam, 35, is in jail and four others are absconding. The acquitted is Nurul Islam. Meanwhile in Noakhali, police yesterday arrested another female accused in a case filed over brutally torturing

a 14-year-old girl. With this, five accused, including three women, were arrested, said police. The teenager from Char Nongolia village under Hatia upazila went missing around four months ago. On Sunday night, police recovered her in a critical condition from

Chattogram, reports our Noakhali correspondent. She is now undergoing treatment at Dhaka Medical College Hospital.

Her mother alleged that she went missing after one of their neighbours, Rina Akhter, also an arrestee, took her

daughter away, promising a job. Quoting the victim, the mother alleged that criminals tortured her and threw hot water and acid on her as she refused to follow their orders and work as a sex worker.

Later, they left her near Kalurghat bridge in Chattogram. Her brother filed the case with Sudharam Police Station, said OC Anwar Hossain of the police station.

### Selfie with accused! 4 killed in

A sub-inspector of Chattogram district police has come under fire after an accused of a case took a selfie with him and posted it on Facebook.

The police official is also the case's investigation officer. The incident took place on Sunday at Hathazari upazila when SI Tofayel Ahmed of Hathazari Model Police Station went to meet the accused, Habibur Rahman, who is now out on bail, for investigation purposes.

"He [Habibur] took the photo unbeknownst to me," SI Tofayel told The Daily Star yesterday. "I learnt about it when he posted it on Facebook."

The SI, however, admitted that he knew Habibur for a long time.

According to police, one Towhidul Alam filed the case accusing Habibur and five others on charges of attempted murder, theft and other charges with the police station on December 28, 2018.

On Sunday, SI Tofayel went to Enayetpur Bazar in Monia Pukur Par area as part of the investigation. The SI said, "Habibur is out on bail in the case. He is also

a cousin of Towhidul. The complainant [Towhidul] and Habibur had a longstanding feud over a shop in the bazaar.' "A brawl took place between the two a few days back and Towhidul filed the case," he added. "I went to the area to talk

to Habibur regarding the case. While talking inside a shop, he took the selfie and posted it without my consent." Habibur could not be reached for comments.

Additional Superintendent of Police (North) Mosiuddowla Reza said they are looking into the matter and action will be taken against the SI, if he is found guilty.

## 30 structures knocked eviction drive down on second day

Chattogram district administration demolished at least 30 structures along Karnaphuli River and another 40 structures were removed by grabbers on their own, on the second day of the eviction drive that was launched on Monday.

The bulldozed structures, at Mazirghat of Sadarghat area, included various types of warehouses where rice, salt, and sugar used to be stored.

Tahmilur Rahman, assistant commissioner (Land) of Patenga who is supervising the demolition, told The Daily Star that on the second day they pulled down

30 structures. "The grabbers also removed their illegal structures on their own before the eviction drive. In total, 70 structures have been removed on the second day [yesterday] in Mazirghat area,"

Tahmilur added.
